GENERAL SPECIFICATIONS



Specification of the work to be done and the materials to be used for completion of the contract annexed here to

DROUGHT RESIDENCE

Lot 2 of DP334063

Manawapou Rd

Hawera

This specification is to be read in conjunction with the accompanying drawings and any other drawing which may be issued during the Contract. The Contractor shall provide the Contract which is to be completed by all parties before the commencement of any work on the site. Any additions, omissions or variations to the Contract shall be notified in writing and signed by both parties. The owners are to ensure that all boundary marker pegs are in place and exposed for inspection.

Contract Documents

Plan drawings, specification, contract, quotation and schedule of material and works.

PRELIMINARY AND GENERAL (ALL TRADES)

1. Consent The main Contractor shall arrange to obtain all building, plumbing, sewerage consents and electrical permits and arrange all appropriate inspections excluding Code of Compliance inspection.
2. Protection of work All parts of the work liable to injury and all adjoining property, existing work, footways, trees etc. , are to be protected to the best of the Contractor's ability until completion of the Contract.
3. P.C. Sums (Nett sums) The P.C. Sums quoted in this specification are nett and the Contractor or sub-contractor concerned must add any fixing charges and profit he requires to all such items.
4. By-Laws The whole of the work in the Contract is to be carried out in strict accordance with the Local Authorities' regulations.
5. Insurance The Contractor shall at all times keep the whole of the works fully covered by insurance; mainly contracts all risk and public liability.
6. Temporary Services The Contractor shall arrange for all temporary services of which the cost will be of the contractors care and remove same on completion of the Contract. If temporary services are not practical or available to connect to and permanent connections have to be made, then this connection fee is at the employer's expense, if not covered in the Contract.
7. Maintenance The Contractors shall maintain the property for a period of 31 days after completion, and any damage done, arising during that time through faulty workmanship, shall be made good at the Contractor's expense.
8. Completions On completion all trade debris is to be removed from the site, and the building left clean and ready for occupancy, with all services and mechanical parts in good working order.

CARPENTER

1. Construction All materials are to be as specified laid true to their various lines and levels and constructed in a proper tradesman like manner, to make the whole of the works a sound construction in accordance with the Building Code. All timber work abutting or resting on masonry units, concrete or brickwork is to be protected with a bitumen - fabric damp proof course. Foundation piles as per plan. Bearers to be in long

lengths, halved over piles where joined. Sub floor bracing as required by the Building Code. Floor joists, to be on edge, set out to suit flooring sheets, nailed with 2/100mm nail at every crossing and trimmed as required for stairwell openings, slabs etc. Double the floor joists at each end of the building. Roof framing is to be contracted with Engineer designed "Gangnail" roof trusses fixed plumb, fastened to the plates with 2 x 100mm nails & Z nails and braced at each end of the building.

2. Purlins (Tile Roof) to be spaced as per plan to accommodate the roof coverings and ridging and fastened to the rafters with two 100mm nails at every crossing. Eaves runner to be nailed to the outside of the wall frames. Eaves bearers to be nailed securely to each rafter overhand.
3. Exterior finish - 100mm brick veneer cladding with brick ties to wall framing as per NZS 3604 1999.

Behind all wall linings and as detailed on the drawings, except if fitted onto tanalised timber, fit a breather type building paper, lapped 100mm. Wall areas are to be covered with exterior lining as shown on the drawings. Soffits and porch ceilings to be lined with flat hardies sheets. Build in the various exterior joinery frames. Fit head flashing. Provide access to under foundation.
4. Interior Finish A continuous reinforced concrete masonry ring foundation dimensioned as per plan. 100mm float finished reinforced concrete floor slab laid over continuous vapour barrier. Interior wall linings generally to be 9.5mm sheets fixed as per manufacturer's specifications. Wall linings of which the contractor is to take the utmost care of quality control but the responsibility of manufacturer's defects will not be rectified at the contractor's expense.
5. Timber Framing generally as per general specifications and requirements of NZ Building Code 1992 and NZS 3604 1999
In general, framing shall be 90 x 45 kiln dried, H1.2 treated, laser frame studs with trussed roof framing.
6. Plates to be in long straight lengths. Bottom plates and wall plates to be butt jointed over continuous support, top plates to be butt jointed and fastened with 4 NH nail plates.
7. Studs are to be set out to accommodate 2.4m high wall lining sheets, and are to be held to the plates with two 100mm nails at each end, bowed studs are to be straightened with saw cuts, wedges and 100 x 25mm or 75 x 25mm strapping.
8. Lintels Where built up trimmer studs are used, use one 90 x 45mm stud which is to be run up past the trimmer to the top plate and the 100 x 25mm or 90 x 45mm remaining is to run up to the underside of the lintel.
9. Nogging (dwangs) Shall be wall thickness 40mm spaced in rows at 1350mm centres maximum, set out to accommodate the wall lining sheets and be nailed with two 90mm nails at each end.
10. Ceiling battens to be set out to accommodate the ceiling lining sheets and comices around the perimeter of each room. 70x35 timber ceiling battens at 450mm maximum centres.
11. Wall Bracing As per bracing schedule.
12. Wall frames are to be assembled, squared, braced and erected. The bottom plates are to be straightened and fastened down, the corners are to be plumbed both ways using a plumb bob and line and the top plates are to be held straight with temporary bracing until the ceiling and roof framing and bracing has been completed.
13. All joints nail holes and other imperfections are to be stopped flush and left ready for the paperhanger.
14. Shower Linings as per itemised in Schedule of Material and Works and fitted to manufacturer's specifications.

15. Ceiling Linings - 10mm Gib-board ceiling lining on 70x35 timber ceiling battens, at 450mm maximum centres, stopped to paint finish.
Stopping to Level 4 finish as per Winstones Publication "Levels of Gib Board Finish".
16. Interior doors are to be fitted with one and a half pairs of loose pin butts.
17. Skirtings to be fitted to the floor, scribed to internal corners and mitred at external angles.
18. Coat cupboard and wardrobes as per itemised in Schedule of Material and Works.
19. Linen, hot water cupboards as per itemised in Schedule of Material and Works.
20. Generally form a ceiling access in a convenient and inconspicuous place. Co-operate with the Electrician in the building in of a meter box and the building of a switchboard recess and trimmed around as required. Supply and fix the sundry internal finishing mouldings and trim as required. All internal finishing timbers shall be free from all hammer marks, splits, etc. All nails in exposed work (interior and exterior) are to be punched.

PLUMBER AND DRAINLAYER

1. Generally The whole of the plumbing and drainlaying shall be done in strict accordance with The Building Code and drains shall be laid by registered workmen only.
2. Exterior Work Supply and fix all necessary flashings, lead caps, in conjunction with the builder to make a thoroughly watertight job. Supply and fix spouting to all eaves, laid with even falls to downpipes.
3. Water Service Lay on cold water from the main to a hot water cylinder, set up as shown on the drawings. Provide and set up the cylinder, complete with casing, lagging and thermostatically controlled electric element. Lay on hot and cold water services to the various fittings as shown on the drawings and to two hose taps positioned as on accompanying drawing. Hot water service to run in copper main and cold water to run in PVC or copper.
4. Fittings Provide and set up the fittings as shown on the drawings and provide traps and wastes to bath, vanity units, sink top, shower tray stainless steel or similar. W.C's, tub, taps as selected Exterior hose taps - brass.
5. Drains or street channel Stormwater to be piped to stormwater main connection, or standard soak holes. Sewer drains to be first quality pipes, 100mm laid with even falls and easy bends to a main connection as directed. Provide and fix all necessary gully traps, terminal and back vents, cleaning eyes, inspection junctions and bends etc, as may be necessary to comply with the local authorities' regulations.
6. **NOTE** All underground pipes and gullies will be located in relation to the natural ground level and no responsibility will be taken by the contractor for subsequent ground work, which alters that level.

JOINER

1. Windows to be Aluminium unless detailed as Timber Aluminium windows shall be delivered to the site, stored on edge and protected from breakages, damage, plaster splashes etc. Timber windows to be of the sizes and types as indicated on the drawings, of standard construction and high class workmanship. The windows are to be glazed with a standard quality glass, with obscured glass to bathrooms and W.C. windows.
2. Doors Exterior door frames and doors are to be of standard sizes and of the types as shown on the drawing. Interior doors are to be flush type.
3. Fittings Construct the various units/tops as shown on the drawings.

ROOFER

1. **Generally** Refer to the drawings for the type of roofing to be used.
2. **Colour Tiles** Tile battens are to be nailed firmly to the rafters, spaced to suit the gauge of the tile. Tiles to be laid with standard laps and nailed down in accordance with standard practices. Hips and ridges to be covered in like material.

CONCRETER

1. **Materials** Concrete to be mixed with a test of 20,000 kPa after 28 days. Reinforcement to be round mild steel rods or reinforcing mesh, as detailed, free from scale, paint, grease, etc. Formwork shall be erected and braced in such a manner that the concrete shall finish to the dimensions shown or specified. The formwork is to be hosed out and kept wet before and while the concrete is being placed.
2. **Concrete Work** Construct the various footings as detailed on the drawings and reinforce as shown. Hard filling to be pumice or similar compacted in layers of 150mm depth maximum. Bind with 25mm of sand or use on-site soil for all hard filling. All floor slabs to be laid to true and straight surfaces, with a screed finish. Thickness and reinforcing as detailed on the drawings. Allow to build in all holding down bolts, pipes, wires, etc, as required, prior to the pouring of the concrete. Holding down bolts to be 375mm maximum from corners and at 1.2m centres maximum ramset down plates to floor at same spacing.

EXCAVATOR

1. **Generally** Excavate the site to the levels shown on the drawings where applicable.
2. **Excavate** As required for all wall footings, pile footings, steps etc, as shown on the drawings. Footing excavations are to be stepped to suit the slope of the ground, and kept level at the bottom, maintained free from fallen material before placing reinforcing or concrete foundations after . Deposit the surplus soil on the site, practical to the contractor, or as directed by the employer. Any excavations for power or water resources, or sewage and drainage to be refilled, but not reinstated to its original condition. Replanting or resealing of owners care.

INSULATION

1. Where applicable the building shall be insulated in accordance with Council requirements.
R1.8 Batts to wall areas
R2.2 Batts to ceiling areas

ELECTRICIAN

1. **Generally** This contract includes the supply and installation of the electric wiring system complete. The whole of the work shall be carried out strictly in accordance with the local authorities' By-laws and the electrical contractor is to obtain all permits from the supply authority and arrange for all inspections required.
2. **Supply** Arrange for a mains supply to the building from nearest boundary.
3. **Boards** Provide and set up as required one meter board and case with all necessary equipment thereon neatly labelled. Provide and set up where directed by builder, a switchboard panel with all necessary fuses, switches and main switches properly mounted and labelled, and hinged on one side. This panel can be combined with the meter board if convenient.
4. **Fittings** Provide and fix the lights, switches and power outlets as listed on drawings, allow to install stove. Wire up the thermostatically controlled hot water cylinder element, earth all metal wastepipes and metal fittings as required by the regulations.

5. Completion On completion of all work to fill out and present the appropriate certificate to the principal contractor, who will only authorise the connection of power once all payments pursuant to the contract documents are paid to their office.

PAINTER AND PAPERHANGER

1. Generally All paint and polyurethane is to be delivered to the job, exactly to the manufacturer's direction and currently usable.
2. Exterior Woodwork - prime, stop and paint in one undercoat and one finish coat with a good finish. Stained work - one coat of stain, the nail holes etc. are to be stopped. Metal work, including spouting downpipes, wrought iron, one coat metal primer and one finish coat. Hardies sheets - two coats. Galvanised iron roof to be left unpainted.
3. Interior All ceilings to be given two coats of flat ceiling paint, or textured. All wall area to be painted or lined with wallpaper, hung in single lengths, plumb, with butt joints unless otherwise stated. The quality of the wallpaper is not of the contractor's care, any defects which become pronounced due to the the nature of the wallpaper will not be rectified at the contractor's expense. When walls are sprayed, workmanship is to be of highest trade practice. Wallpaper to PC sum. Flush doors, if stained, only to be sealed, and given one coat of satin finish polyurethane. To be rubbed down between coats. All other interior finishing woodwork to be primed, stopped, undercoated and finished.

Design Steps 4 and 5 – Bracing Units Achieved (Wind and Earthquake)

The next step is to place selected wall bracing systems on the bracing lines. A range of Gib® bracing systems have been tested and the specifications and Bracing Unit ratings are listed below. Gib® Standard plasterboard systems often represent the majority of the wall bracing elements. Gib® Braceline or Gib® Toughline systems are used for narrow walls or when high Bracing Unit ratings are required. Gib® Noiseline and Gib® Ultraline Bracing Unit ratings generally fall between Gib® Standard plasterboard and Gib® Braceline.

Wall Heights Other Than 2.4m

The published Bracing Unit ratings are based on a 2.4 metre height. For other heights, the ratings must be multiplied by a factor $f = 2.4$ divided by actual wall height. The Bracing Unit ratings for walls higher than 2.4 metres will reduce, and the Bracing Unit rating for lower walls will increase. Factor f must not be greater than 1.3.

Construction Details

Framing

General framing requirements such as grade, spacings and installation shall comply with the provisions of NZS 3604. Winstone Wallboards recommends the use of kiln-dried machine stress graded framing (KD MSG). To achieve the published bracing performance the minimum actual framing dimensions are 90 x 35mm for external walls and 70 x 35mm for internal walls. System BR9 always requires a minimum of 90 x 35mm framing.

Wall bracing tests on Gib® Systems were undertaken without nogs. Nogs are not considered to add to the bracing performance of the wall.

Fastening Gib® Plasterboard Linings

10mm and 13mm Gib® Standard, 10mm and 13mm Gib® Ultralite, 10mm and Gib® Noiseline and 13mm Gib® Toughline may all be fastened using 32mm x 6g Gib® Grabber drywall screws or 30 x 2.8mm Gib® Nails. Gib® Braceline and 10mm Gib® Toughline must be fastened with 32mm Gib® Grabber Braceline screws, or 30mm Gib® Braceline nails and washers.

Gib® linings for designated bracing elements are fastened at 150mm centres around the perimeter of the bracing element. **The first fastener is always placed 50mm away from the sheet corner. See detail page 16.**

Fastening in the field of the bracing element is conventional and the screw and glue method is recommended. (See Fastener Layout details, pages 14, 15).

When fixing part sheets of Gib® plasterboard, a minimum width of 300mm is recommended for bracing elements.

Full height sheets shall be used where possible. Where sheet end butt joints are unavoidable they must be formed over nogs (or over the studs where horizontal fixing is permissible) and fastened at 200mm centres. Alternatively, the sheet end butt joints may be back-blocked.

Plywood (BR7) and Hardboard (BR8)

'Plywood' specified in BR7 is a grade C-D 7.5mm construction plywood manufactured to AS/NZS 2269:1994, fixed with 30 x 2.8mm Gib® Nails at 150mm centres around the perimeter of the bracing element and at 300mm centres to intermediate framing.

'Hardboard' specified in BR8 is 4.75mm standard or oil tempered hardboard manufactured by Fletcher Wood Panels Ltd., fixed with 30 x 2.8mm Gib® Nails at 150mm centres around the perimeter of the bracing element and at 300mm centres to intermediate framing.

Fire Resistance Ratings

10mm Gib® Braceline, 10mm Gib® Aqualine, 10mm Gib® Noiseline, 10mm and 13mm Gib® Ultralite and 10mm Gib® Toughline may be substituted for 10mm Gib® Fyrelite in fire rated constructions.

The fastener length for the fire rated system applies. The field of the braced element must also be fastened in accordance with the fire rated specification (adhesive not permitted).

Jointing and Stopping

All sheet joints must be paper tape reinforced and stopped in accordance with the publication entitled, "Gib Living Solutions® Site Guide".

Fastening the Bracing Element to Timber Floors

Fastening of the bottom plate of a Gib® wall bracing element to a timber framed floor must be in accordance with NZS3604 with pairs of 100 x 3.75mm nails at 600mm centres. In addition 6 or 12kN connections must be installed when specified for the particular bracing element type.

Fastening the Bracing Element to Concrete Slabs

Fastening of the bottom plate of a Gib® wall bracing element to concrete floors must be in accordance with NZS3604 for external walls, which includes a 12mm bolt (complete with a 50 x 50 x 3mm square washer) or a proprietary fixing with equivalent performance within 150mm (90mm for BR6) from both ends of the wall bracing elements.

On internal bracing lines, the bottom plate of Gib® Bracing elements may be fixed using 3.8mm shot fired fasteners fitted with 16mm discs, spaced at 160mm and 300mm from the end studs and thereafter at 600mm centres. This method only applies to Systems Gib1, 2, 3, 10, 11 and BR1, 2, 3.

Hold-Down Strap Placement (Refer Illustrations Pages 17 and 18)

Where 6kN connections are specified in the 'Additional Requirements' column, they are required only if the bracing element terminates within 1.2 metres from a door or window opening (see illustration, page 18).

Where 12kN connections are specified they must be installed at both ends of the bracing element in all cases.

Openings in Bracing Elements

Openings are allowed within the middle third of a wall bracing element's length and height. Neither opening dimension shall be more than one third of the element height. Wall linings are fixed to opening trimmers at 150mm centres. Small openings (e.g. power outlets) of 90 x 90mm or less may be placed no closer than 90mm to the edge of the braced element.

Angle Braces


Angle braces serve to keep frames square during transport and construction. They also act as part of the temporary bracing of a building under construction. Angle braces contribute only a fraction to the bracing of a completed structure. The performance of a completed building depends mainly on the wall linings and their fixings.

Where specified, metal angle braces must be placed at an angle no steeper than 55 degrees, and within the designated length of the bracing element. For elements longer than 3.6 metres, pairs of angle braces (in opposite directions) are required. Fixing of angle braces is with three 30 x 2.8mm Gib® nails to top and bottom plates, and two 30 x 2.8mm nails to intermediate framing.

Top Plate Connections


The top plate of a wall that contains one or more wall bracing elements shall be jointed according to the rating of the highest-rated individual wall bracing element as follows:

- Rating not exceeding 100 bracing units: A 3kN connection as shown or by an alternative fixing of 3kN capacity in tension or compression along the plate;
- Rating exceeding 100 bracing units: A 6kN connection as shown or by an alternative fixing of 6kN capacity tension or compression along the plate.



Guidelines for Intersecting Walls (all Gib® Bracing Sheet Types)

Gib® Bracing Elements may have intersecting walls with a minimum length of 200mm. Bracing element sheets shall be fixed and jointed as given on pages 14 and 15. Fasteners are required around the perimeter of the bracing element. Vertical joints at T-junctions (illustrated below) shall be fixed and jointed as specified for intermediate sheet joints. **The bracing element length must be no less than 900mm.**




Where Wall Bracing Elements are interrupted by T or L junctions (as illustrated in the 900mm example above) they should be considered as follows:

The bracing element has been cut to accommodate the junction. Nevertheless, in respect of calculating Bracing Units, the Bracing Element is deemed to be continuous for the whole length (900mm in this particular case).


Ceiling Diaphragms

Gib® ceiling diaphragms are strong and stiff horizontal bracing elements which effectively transfer loads over large distances. They may be used to space bracing lines further apart than 5 metres (single top plate), or 6 metres (double top plate). A ceiling diaphragm may be square or rectangular. Its length shall not exceed twice its width. The width being measured horizontally between supporting walls. Ceiling diaphragms under light and heavy roofs are required to comply with NZS3604:1999.




Limitations for 10mm or 13mm Gib® Standard plasterboard Ceiling Diaphragms

- Diaphragms not steeper than 25 degrees to the horizontal shall not exceed 7.5 metres in length.
- 10mm or 13mm Gib® Standard plasterboard is fastened at 150mm centres to the boundary members around the entire perimeter of the diaphragm.
Fasteners - 32mm x 6g Gib® Grabber drywall screws or 30mm x 2.8mm Gib® Nails.




Limitations for 10mm or 13mm Gib® Ultralite Ceiling Diaphragms

- Diaphragms not steeper than 25 degrees to the horizontal shall not exceed 10 metres in length.
- Gib® Ultralite is fastened at 150mm centres to the boundary members around the entire perimeter of the diaphragm.
Fasteners - 32mm x 6g Gib® Grabber drywall screws or 30mm x 2.8mm Gib® Nails.




Gib® Braceline Ceiling Diaphragms

- Diaphragms not steeper than 25 degrees to the horizontal shall not exceed 15 metres in length.
- Diaphragms not steeper than 45 degrees to the horizontal shall not exceed 7.5 metres in length.
- Gib® Braceline is fastened at 150mm centres to the boundary members around the entire perimeter of the diaphragm.
Fasteners - 32mm Gib® Grabber Braceline screws or 30mm Gib® Braceline nails and washers.



General Fixing Requirements for Gib® Ceiling Diaphragms

- Linings shall be installed over the entire area of the diaphragm.
- Fastening shall be no less than 12mm from sheet edges.
- Sheets shall be supported by framing members (e.g., ceiling battens) spaced at no more than 450mm centres for 10mm Gib® Standard, 10mm Gib® Ultralite and Gib® Braceline and at no more than 600mm centres for 13mm Gib® Standard and 13mm Gib® Ultralite.
- Sheets within the diaphragm area may be fastened and finished conventionally in accordance with the publication entitled, "Gib Living Solutions Site Guide" 1999. All joints shall be paper tape reinforced and stopped. It is recommended that sheet butt joints are formed off framing using Gib® back-blocking.
- Full width sheets with a length not less than 1800mm shall be used at the ends of the diaphragm. In the middle third of the diaphragm the sheet width may be reduced.
- Openings are allowed within the middle third of the diaphragm's length and width. Fixing of sheet material to opening trimmers shall be at 150mm centres. Neither opening dimension shall exceed a third of the diaphragm width. Larger openings, or openings in other locations, require specific engineering design.


Steel Battens

The Gib® Rondo and USG DONN Screwfix (FC37 and FC50) battens may be used to construct Gib® Standard, Gib® Ultralite and Gib® Braceline ceiling diaphragms.

- The battens shall be spaced at 450mm centres maximum for 10mm Gib® Standard, 10mm Gib® Ultralite and Gib® Braceline and at no more than 600mm centres for 13mm Gib® Standard and 13mm Gib® Ultralite. The battens are fastened through both flanges directly to the ceiling framing with 32mm x 8g Wafer Head screws.
- A steel perimeter channel is required at the perimeter of the diaphragm. The channel shall be fastened to the top plate with 32mm x 8g Wafer Head screws spaced at 300mm centres maximum.
- The linings are fastened to the perimeter channel at 150mm centres maximum with 25mm x 6g self tapping screws.
- Within the diaphragm area sheets may be fastened as described in "General Fixing Requirements for Gib® Ceiling Diaphragms" (page 19).

Alternative Double Top Plate Detail

- Alternatively, should an additional top plate (ex 150 x 40mm) be used, Gib® Rondo steel battens (35mm deep) shall be installed as detailed below.


