

- (a) The provision of the New Plymouth City District Planning Scheme that when new buildings are erected or any buildings are re-built or re-erected or are substantially rebuilt or re-erected on Lots 1-6 inclusive which have frontage to that part of Roto Street which has a width of not less than 20.12 metres no part of any such building shall stand within a distance of 17.68 metres from the middle-line of the said street;
- (b) Building-line restrictions being imposed under the provisions of Section 351BB(6) of the said Act that when new buildings are erected or any buildings are re-built or re-erected or are substantially re-built or re-erected on land having frontage to that part of Lot 42 shown as Roto Street and Cedar Place which has a width of less than 20 metres, but not less than 12.4 metres, no part of any such building shall stand within a distance of 10 metres of the middle-line of the said streets;
- (c) The provisions of Section 351F(4) of the said Act, that is to say, that as Lot 31 will have frontage to land which may be utilised or required in the future for street when new buildings are erected or any buildings are re-built or re-erected or are substantially re-built or re-erected on the said Lot no part of any such building shall stand closer than 10 metres from the middle-line of the future street or 2 metres in depth parallel to and in from the southern boundary of Lot 31;

and that His Worship the Mayor and the Town Clerk be authorised to affix the City Seal to and to sign on behalf of the Council the authenticated copy of this resolution.




