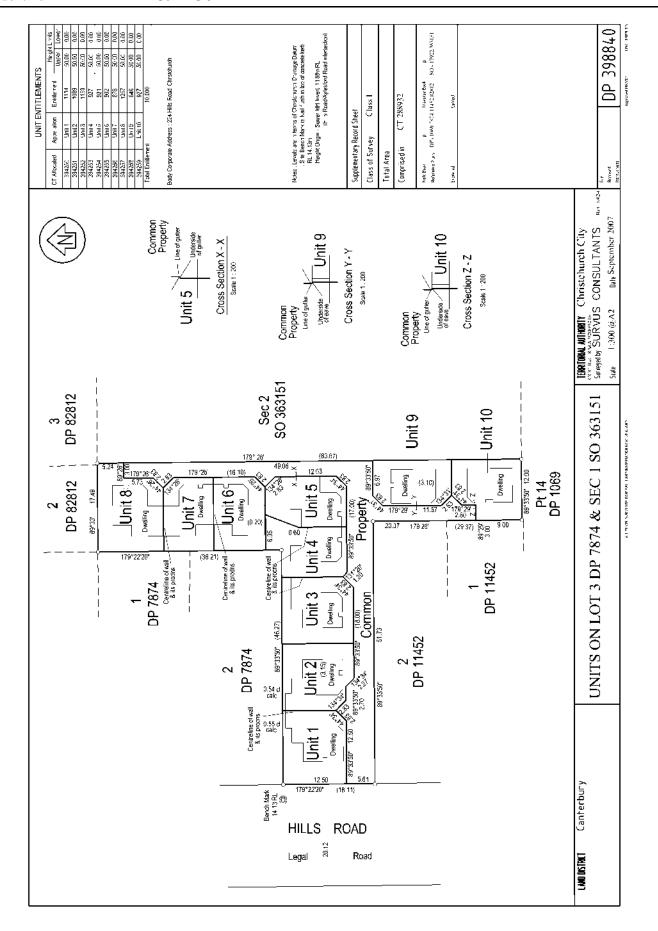

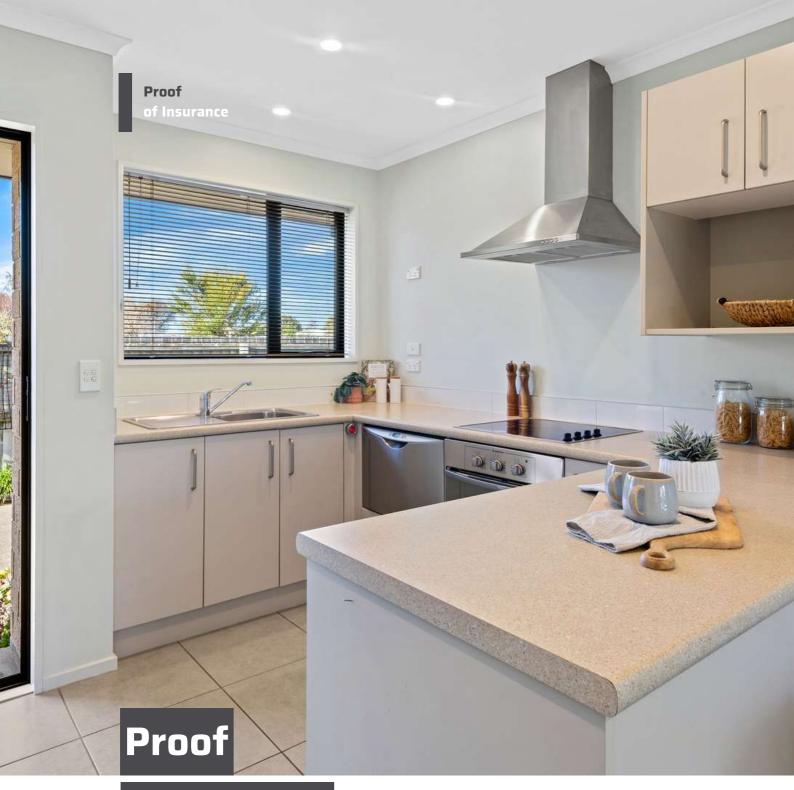

Cosmetic Damage	Cosmetic damage is used to record repairs to an element that can be done in situ e.g. minor cracking to plasterboard. For example a repair strategy may state "rake, stop and paint" and this is carried out without needing to remove or replace the damaged element. Where the plasterboard for example needs to be removed and replaced, this will be recorded as 'structural damage'.
Impact Damage	Impact damage is where an element or part of a building sustains earthquake damage and then breaks away or collapses causing damage to another part of the building. An example is a chimney that has collapsed and caused damage to roof tiles.
Structural Damage	The term structural damage is used where a repair requires an element to be removed and replaced e.g. major cracking to plasterboard or external cladding that has been dislodged. This term does not relate to the structural integrity of the building as a whole, but to the individual element only.

We have performed a pre-purchase inspection at the above address for units 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10. Unit 2

The inspections consisted of inspecting the following:

- Weather tightness
- Floor levels and wall verticality's
- Structural damage

The units are generally constructed from timber-framed walls clad with brick veneer. The roof construction is timber trusses supporting light-weight metal profile sheeting. The ground floor is concrete slab supported on concrete perimeter and internal thickenings.

On 16th December 2021, TM Consultants visited the site and provided a walkthrough visual inspection for structural damage on units 2, 3, 4, 5, 6, 9 and 10. Floor levels were measured using a Zip Level altimeter and wall verticalities were taken using a laser level. The site measurements are contained in Appendix A1.

The results of the inspection and any proposed repair methodology are contained in Appendix B.

- The floor levels are found to be within MBIE Canterbury Technical Guidance criteria of less than 0.5% slope, and floor level difference maximums are less than 50mm, therefore floor levels are satisfactory and no re-levelling is required.
- Wall verticalities were measured to be within 10mm and are within acceptable construction tolerations therefore condition of walls are satisfactory.

On 19th January 2022, TM Consultants visited the site and provided a walkthrough visual inspection for structural damage on units 1,7 and 8. Floor levels were measured using a Zip Level altimeter and wall verticalities were taken using a laser level. The site measurements are contained in Appendix A2.

• The floor levels are found to be within MBIE Canterbury Technical Guidance criteria of less than 0.5% slope, other than one location in unit 7 and one location in unit 8. The floor level difference maximums are less than 50mm. Minor levelling of the flooring to units 7 and unit 8 may be completed using floor levelling compound under the carpet to bring the floor

levels inside the 0.5% threshold in these spaces. We note this is a cosmetic issue only and is not reducing the structural performance of these units.

- Wall verticalities were measured to be within 10mm and are within acceptable construction tolerations therefore condition of walls are satisfactory.
- Unit 7 western concrete patio path was observed to fall towards the house by 10mm and we understand from the tenants that water ponds when it rains. Refer Appendix B for proposed repair options.

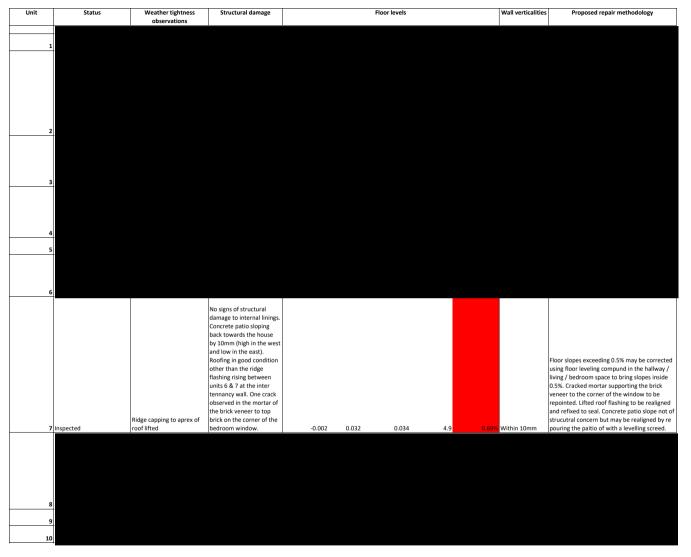


Appendix A2 – Site Measurements Units 1, 7 and 8 (Floor Level, Wall Verticality and Damage Survey)

Minutes of Body Corporate 398840:

- held at the offices of Patient and Williams, 192 Barbadoes Street, Christchurch;
- on Wednesday 18 January 2023
- at 11am.

Introduction and Welcome

Present, apologies and apologies with proxies.

Steven Rothwell (owner of unit 1) was present.

David Waller, Director of DJ Waller LTD (owner of units 2,3,4,6 and 10) was present.

Karen McConnachy – Enduring Power of Attorney for Margaret Gebbie (occupier of unit 7) was present.

No proxies were received.

No apologies were received.

Minutes of the previous general meeting:

The minutes of the meeting held on 18.1.22 were read to the attendees of the meeting and were approved by David Waller, seconded by Steve Rothwell.

The minutes were accepted as a true and correct record of the meeting held.

Financial year accounts:

It was determined that at this stage:

no accounts had been prepared for the Body Corporate to date;

that the only expense the body corporate has incurred and paid for is the insurance renewal.

All owners paid their share of the insurance premium renewed in December 2022 and this insurance premium was paid in full.

Accounts will need to be prepared in the future and the Body Corporate will have to decide who will prepare these accounts. It was decided that these will be simple accounts.

Appointment of auditor:

It was resolved by attendees that no auditor be appointed for the financial year 31 March 2022 to 31 March 2023 in accordance with section 132 (8) of The Unit Title Act 2010.

This motion was passed by Steve Rothwell and seconded by Karen McConnachy.

Financial year to 31 January 2023 – the attendees considered what the budget for the year to 31 January 2023 will need to cover. It was decided that it is important to get clarity as to what the common property at the complex consists of. David Waller believes that it consists of the underground services located down the driveway and the driveway itself. The underground services are electricity, water, sewage, telecommunications and drainage.

There was discussion as to whether the roofs are common property. Some units are attached and some are detached. Steve Rothwell said he would be surprised if the roofs were common property.

Tracey Patient is to check and endeavour to identify common property versus separate property of each owner.

The attendees agreed there was no point in rushing into a budget until the common property versus separate property is clarified. They want to be sure that when levies are sent to owners that it is justified in what the reason for the levies will be.

There was discussion as to whether a levy of \$200 per unit could be issued and it was decided that the repair and maintenance budget will be deferred until the next meeting.

It was agreed the next meeting will be held around October 2023 to ensure that decisions made relating to financial expenditure, levies and insurance renewal are made well prior to Christmas.

Steve Rothwell will contact Apex insurance and arrange to realign the renewal of the insurance to October of each year.

Electing a chairperson:

David Waller resigned as chairperson and Steven Rothwell nominated himself as chairperson. This was seconded by David Waller.

Steven Rothwell is accordingly appointed Body Corporate Chairperson.

Body Corporate Manager:

There was a general discussion as to whether a Body Corporate Manager is required, but it was decided that at this stage it is not necessary.

General Business:

Health and safety – no issues to raise.

Long term maintenance plan:

It was decided by the attendees that it is too early to put a long-term maintenance plan in place which will be relevant. Steven Rothwell said he would rather not spend money on professional reports at this stage.

It was decided a long-term maintenance plan is required and that the amount of the long-term maintenance plan can be decided at the next meeting to be held in October 2023.

It was reported that DJ Waller Ltd started repairs to the driveway but they need to address the repairs again and complete the repairs. Once the repairs were started, problems became apparent. David Waller reported the driveway was tested by Powell Fenwick and it is 150mm thick. This means the repairs can be completed by epoxy. David Waller will check with his crew and report back on the timeframe to complete repairs.

David Waller agreed to check the dip in the kerb and channel as raised by Karen McConnachy. Karen believes it needs a skim coat of epoxy and David Waller agreed to take a look at this.

Karen McConnach reports the driveway at the property is sometimes clogged and obstructed by either visitors or tradies at the property. She said in particular the property which she believes to be unit 9 has a lot of cars parked there which makes it very difficult for some of the elderly owners to get their cars out.

There was a discussion as to whether the Body Corporate would be involved in this and put a notice on the driveway that says no parking or whether Karen can put this notice up herself. It was agreed that Karen will put this notice up herself or chat to the unit owner in question.

David Waller confirmed the driveway has cracks, a section has been cut out and epoxy rods are being put in. The main part of the drive was not yet completed as the section that is cut out needs to be wider. It will be cut out wider and black grout put in. Karen asked if this was earthquake related and could a claim be made to EQC and David Waller confirmed it is not earthquake related and a claim cannot be made to EQC.

In terms of the budget there was discussion about the roof. It is long run steel and has a 25-year guarantee. It is about 12 years old.

There is discussion as to where the boundary fences are common property or separate property. Karen said that the boundary fence between unit 6 and 7 has a large conifer that is growing about a metre over the height of the fence and intruding in the yards of 6 and 7. It was agreed that Karen will discuss this with the owner of the property that contains the tree and if she has no joy with them then she is able to raise this with David Waller and he will assist.

David Waller reports the fire wall goes up to the roofline and he believes the roof is common.

David said all houses have their own gutter system and he thinks this is separate property but once the system enters through the rises then it becomes common property and that the firewalls will be common property.

It was agreed a bank account is required to be opened for the Body Corporate to collect future levies and pay repairs and maintenance. There was discussion as to who opened the account and how it will operate. It was agreed that Steve Rothwell as chairperson will arrange for the bank account to be opened and that

Steve Rothwell and Dave Waller will contact BNZ to find out their requirements to open an account. It was agreed most Body Corporate transactions will be completed by internet banking and whilst Steve will be able to complete the transactions, the access to the account will be by Steve Rothwell and David Waller.

<u>Unit title property ownership</u>. Unit titles are a common form of multi-unit property ownership. They allow owners to privately own an area of land or part of a building and share common property with other unit owners. Unit title developments may also be structured in varied ways including staged unit title developments and layered unit title developments.

This combination of individual and shared ownership of land and buildings, often in an intensive built environment, means owning a unit title involves a different set of rights and responsibilities than traditional house and land ownership.

Unit title developments have a body corporate management structure to ensure decisions affecting the development can be made jointly by the unit owners. The creation and management of unit title developments is governed by the Unit Titles Act 2010 and supporting regulations.

<u>Unit plan</u>. Every unit title development has a unit plan, which shows the location of the principal units as well as any accessory units and common property in the development. The unit plan is the formal record of all of the boundaries of the units, and the common property.

<u>Ownership and utility interests</u>. Each unit is allocated an ownership interest and a utility interest and such interests are relevant to the determination of many of the unit owner's rights and responsibilities under the Unit Titles Act 2010.

Ownership interest is a number that reflects the relative value of each unit to the other units in the development, and is used to determine a range of matters including the unit owners' beneficial share in the common property, and share in the underlying land if the unit plan is cancelled.

By default, the utility interest of a unit is the same as the ownership interest (unless it is otherwise specified on the deposit of the unit plan or subsequently changed), and is used to calculate how much each owner contributes to the operational costs of the body corporate.

<u>Body corporate operational rules</u>. The body corporate for a unit title development can make its own operational rules on the use of the development, and governance of the body corporate. These operational rules are subject to the provisions of the Unit Titles Act 2010 and regulations made under that Act.

All unit owners, occupiers, tenants and the body corporate must follow the body corporate operational rules that apply to their unit title development.

<u>Pre-settlement disclosure statement</u>. Before settlement of the sale of a unit, the seller must provide a pre-settlement disclosure statement to the purchaser, which includes information on:

- the unit number and body corporate number
- the amount of the contribution levied by the body corporate for that unit
- · the period covered by the contribution
- how the levy is to be paid
- the date on or before which the levy must be paid
- whether any amount of the levy is currently unpaid and, if so, how much
- whether legal proceedings have commenced in respect of any unpaid levy
- whether any metered charges (eg, for water) are unpaid and, if so, how much
- whether any costs relating to repairs to building elements or infrastructure contained in the unit are unpaid and, if so, how much

- the rate of interest accruing on any unpaid amounts
- · whether there are any legal proceedings pending against the body corporate
- whether there are any legal proceedings initiated by the body corporate or intended to be initiated by the body corporate
- whether there is any written claim by the body corporate against a third party that has not been resolved
- whether there have been any changes to the body corporate rules since the pre-contract disclosure statement was provided.

There are legal consequences on the seller for failing to provide the pre-settlement disclosure in the timeframes required by the Unit Titles Act 2010 including delay of settlement and cancellation of the contract.

Records of title. Previously known as a computer register or certificate of title, for a unit title development this document records the ownership of a unit, contains a legal description of the unit boundaries and records any legal interest which is registered against the title to the unit (for example a mortgage or easement). A copy of the record of title for a unit should come with:

- the unit plan attached. Unit title plans were discussed earlier in this section.
- a supplementary record sheet attached. A supplementary record sheet records the
 ownership of the common property, any legal interests registered against the common
 property or base land, and other information such as the address for service of the body
 corporate and the body corporate operational rules.

The common property in a unit title development does not have a record of title.

<u>Land Information Memorandum</u>. A land information memorandum (LIM) is a report which provides information held by the local council about a particular property. You must order and pay for a LIM from the applicable local council. Delivery times vary between councils. The information contained in a LIM will vary between councils, but is likely to include details on:

- rates information
- information on private and public stormwater and sewerage drains
- any consents, notices, orders or requisitions affecting the land or buildings
- District Plan classifications that relate to the land or buildings
- any special feature of the land the local council knows about including the downhill
 movement, gradual sinking or wearing away of any land, the falling of rock or earth,
 flooding of any type and possible contamination or hazardous substances
- · any other information the local council deems relevant

Full details of what a local council is obliged to provide in a LIM is contained in section 44A of the Local Government Official Information and Meetings Act 1987.

<u>Easements and covenants.</u> An easement is a right given to a landowner over another person's property (for example, a right of way, or right to drain water). A land covenant is an obligation contained in a deed between two parties, usually relating to the use of one or both properties (for example a covenant to restrict one party using their property in a certain way).

Easements or covenants may apply to:

- a unit and are usually recorded on the record of title for that unit.
- common property and will be recorded on the supplementary record sheet for the unit title development.
