
- I/we Sigrid Korsika & Tolver Walker, have a Policy of Insurance with Vero Insurance New Zealand Limited (Vero), under which I/we have made a claim for damage caused by Earthquake Activity on 4 September 2010 and/or in subsequent earthquakes, and which is not covered by the Earthquake Commission (the Claim).
- I/we agree to accept the amount of \$8827.31 (Eight thousand Eight Hundred & Twenty Seven dollars and Thirty One cents) less 0.00 (the total excess) from (Vero) in settlement of my claim (the settlement)
- 3. I/we acknowledge and agree:
- (a) The Settlement covers damage for my/our paths & driveway.
- (b) The Settlement has been calculated in proportion to my/our ownership of the property as recorded on the Certificate of Title.
- (c) It will be a term of the Policy and of any new or renewed Policy that Vero provides no cover for the property which is included in the Settlement until I/we provide evidence to Vero that the repairs are completed to a workmanlike standard.
- (d) Once repairs have been completed, Vero will reinstate cover to the repaired property subject to any normal underwriting conditions at the time of reinstatement.
- (e) Vero accepts no responsibility for any loss or liability arising from the repairs, including but not limited to any damage or loss to any other property or person.
- I/we declare that I/we have no entitlement to other insurances covering the Damage, and that no other party is entitled to the proceeds of the Claim.
- 5. The Settlement is accepted by the me/us in full and final settlement and discharge of the Claim and any claims, rights, demands and set-offs against Vero arising directly or indirectly out of, or in connection with the Earthquake Activity and/or the Building Work and/or the Insured Property Damage whether such claims arise under statute, common law, or equity; are in existence now or may arise sometime in the future; are known or unknown; in the contemplation of the parties or otherwise.
- 6. I/we agree, on behalf of ourselves and on behalf of our assigns, transferees, representatives or agents not to sue, commence, voluntarily aid in any way, prosecute or cause to be commenced or prosecuted against Vero or its advisers, reinsurers, agents or representatives any action, suit or other proceeding concerning or relating to the Claim, in this jurisdiction or any other.


