



These include carpets, fixed floor coverings, window furnishings, a dishwasher and light fittings, which, for the purpose of this report we consider provide an added value of \$15,000.

A detached single tandem garage exists offering a total floor area of 29.6 m². Construction includes a concrete foundation, concrete floor, metal exterior cladding, corrugated iron roof, and a roller door, power is provided to the garage.(Rear of garage to be upgraded).



Other Improvements

These include sectional layout, a share of the driveway, boundary fencing, rotary clothesline, outdoor areas.

Insurance Status

Our assessment is contingent on adequate agreed value replacement or full reinstatement insurance including natural disaster cover being held or being able to be obtained and maintained for the property under terms and conditions that are not excessively onerous. Should this not be possible, then the marketability and market value of the property could

be seriously affected.

In the case of an assigned insurance policy, some of the policy benefits can be less than those that would have been enjoyed by the original policy holder. Our valuation assumes that any assigned insurance policy includes full

reinstatement cover.

Healthy Homes Standards

The Healthy Homes Guarantee Act 2017 amended the Residential Tenancies Act 1986 and enabled the Government to create regulations that have set new standards for rental homes. These are called Healthy Home Standards. The Healthy

Home Standards set minimum requirements for:

Heating

Insulation

Ventilation

Draught Stopping

Drainage

Control of Moisture

We note that the Housing Minister has announced a one year delay in Healthy Homes Standards to July 1, 2025 for private

landlords.

With specific regard to the subject property, we would anticipate that the property is compliant with the above Healthy

Home Standards.

1.3 MARKET CONSIDERATIONS

COVID - 19

Following the initial COVID 19 lockdown in March 2020, there was a brief period of market uncertainty followed by very buoyant conditions from late 2020 until early 2022 with strong sales activity and evident value growth across all market

sectors.

Economic Factors

The Reserve Bank increased the Official Cash Rate (OCR) 50 basis points to 5.25% on 5 April 2023, this being the eleventh consecutive increase since October 2021 in attempt to curb high levels of inflation. Prior to then the OCR had reduced

or remained the same since September 2014.

The latest Consumer Price Index (CPI) rose 6.7% annually in March 2023, well above the Reserve Bank's target range of

1.0% to 3.0% per annum. The Reserve Bank is expected to continue to tighten monetary policy to temper the strong

inflationary pressure.


Over the last 18 months mortgage interest rates have been increasing sharply, in line with increases to the OCR but in the first few months of 2023 majority of the major banks have been reducing their longer term fixed-term rates. As of 17 May 2023, five-year fixed term mortgages with a 20.00% deposit or greater, are sitting between 5.99% and 6.29%, below the one-year fixed rates which are currently between 6.49% – 6.79%. Floating mortgage rates are generally still rising and currently sit between 8.14% to 8.39%.

Existing Housing Market


The housing market saw significant demand and a period of sharp growth from the first COVID-19 lockdown in March 2020 until the end of 2021 where there were initial signs that market activity was beginning to slow.

Tighter lending rules and further LVR restrictions were introduced towards the end of 2021, and this together with rising interest rates, inflation and the cost of living is limiting affordability and is impacting demand in the Christchurch housing market.

Key features of the market are shown below:




The trend line indicates that the Christchurch median sale price increase over a 12-month rolling period (e.g. April 2023 vs April 2022) has shown a rapid decline in the past 18 months following strong growth. In April 2023 the median price in Christchurch was 7.04% lower compared to April 2022, the seventh consecutive month of negative growth year on year.



According to REINZ, the Christchurch median sale price was \$660,000 in April 2023, compared with \$710,000 in April 2022. The trend in sales volumes has been steadily decreasing since mid 2021 indicating uncertainty in the market. Auction activity has been noticeably quiet in the last 12 months and figures from realestate.co.nz indicate that listings were down -4.00% in Canterbury between April 2023 and April 2022.






According to REINZ, in April 2023 the median selling period for a property in Christchurch was 36 days to sell, compared with April 2022 where it was 31 days. Generally, in the last two years there has been an increase in the days to sell, reflecting slowing market conditions.

Market Trends


- After a period of unprecedented value growth and sales activity the residential market is now slowing and since early 2022, we have seen a significant reduction in market activity
- Fewer qualified buyers in the market
- · Softening prices for new build properties, particularly townhouses and apartments
- Easing section prices throughout the region with the exception of land in the upper price residential locations and central City development land
- There has been an increase in build costs and delays in construction as a result of material and labour shortages
- · International uncertainty due to the Russia/Ukraine conflict and worldwide high inflationary trends
- Investors were a strong presence in the market in recent years however this is now reduced as they deal with:
 - Increasing interest rates
 - Ability to obtain mortgage finance
 - The cost of bringing properties up to Healthy Home Standards
 - Recent changes to the Residential Tenancies Act generally favouring tenants
 - The progressive phasing out of mortgage interest deductibility




