

Land Covenant

The Grantor creates the following covenants over the land of the Grantor in favour of the land of the Grantee (except where the Servient Tenement and Dominant Tenement is the same) as set out in Schedule A.

The Grantor herein covenants and agrees with the Grantee:

- 1 (a) The Grantor will not erect or place on the servient tenement any building other than a single new residential home and other new buildings as would usually be appurtenant or ancillary to a single residence.
- (b) Such new residential home and other new buildings are to be built from permanent materials which are aesthetic to the environment and which will not detract from the surroundings of the countryside.
- Construction of the dwelling is to be completed to lock up stage within 12 months from commencement of laying the foundations and within that 12 month period an all-weather vehicle access or driveway is to be formed to the housing site. Prior to the commencement of construction of any building, the vehicle access to the site is to be metalled.
- Lawns are to be laid and fences completed within a further period of 12 months from completion of the dwelling. Only new materials are to be used in the fence construction or repair thereof.
- 4 No building is to be constructed or placed within 15 metres of any right of way easement facility referred to on DP 411754.
- Once construction of the dwelling has been completed the Grantee will not allow to remain on the servient tenement any temporary dwelling, caravan, bus, trade vehicle or other equipment or materials or machinery unless garaged or screened so as to preserve the amenities and presentation of the lots that form part of the subdivision under DP 411754.
- The Grantor will not carry on or allow the servient tenement to be used for any activity that by reason of noise, smell, or general unsightliness, is offensive to other owners in the subdivision under DP411754, even if the activity is permitted by the district scheme.
- 7 Each servient tenement lot is to be kept tidy and free of debris at all times.
- 8 Further Subdivision
 - (a) The Grantor as registered proprietor of Lot 8 DP 411754 will not subdivide Lot 8 DP 411754.
 - (b) The Grantor as registered proprietor of any of Lots 9-13 DP 411754 will not subdivide any one of these lots into any more than two lots ("new Lots") and neither of the new lots may be less than 1.5 acres (600 m2) in area.
- The Grantor acknowledges and agrees with the Grantee that each lot in the subdivision forms part of a development which is intended to be established and maintained as a modern subdivision for private ownership and no usage principally for subsidise or communal housing shall be permitted.
- 10 The Grantor will undertake no commercial activity on the lot without first obtaining written approval of the Grantee.

Dispute Resolution

In the event of any dispute or disagreement whatsoever between any of the Registered Proprietors for the time being of any of the Servient or Dominant Tenement lots, any of such parties may require the matter to be resolved by arbitration in accordance with the provisions of the Arbitration Act 1996. The arbitrator shall be a sole arbitrator agreed to by the parties and failing agreement by appointment by the President for the time being of the local District Law Society. The parties record, however, that it is their intention in the event of any dispute or disagreement arising, to try to resolve such dispute or disagreement by negotiation or mediation with a view to avoiding the need to refer to arbitration in the first instance.

Enforcement

Should the Grantor or any subsequent Registered Proprietor of the Servient Tenement lot be in breach of any of the foregoing covenants, he, she, or they will on request from the Grantee or any subsequent Registered Proprietor of the Dominant Tenement lots (any of whom are included in the expression "the enforcer" in this clause) to immediately and permanently desist from and remedy such breach at his, her or their cost. The Grantor or any subsequent Registered Proprietor of the Servlent Tenement lots shall also pay to the enforcer the following:

(a) The enforcer's costs, fees and charges incurred in respect of ensuring compliance with these land covenants including any costs, fees or charges incurred in dealing with any claims against a
