This report has been prepared solely for the Earthquake Commission and is to be used only for work undertaken under the management of Fletcher EQR within the Canterbury Homes Repair Programme. No use by any other party is permitted without the prior consent of both Fletcher EQR and the Earthquake Commission.

### Observed Damage

A structural assessment and level survey of the dwelling outlined above has been carried out. The levels recorded on site are shown on sketch SK01.

Cracking in the floor slab along the construction joints has been observed where the joints have opened by a maximum of 20mm in some areas. Refer to sketch SK02 for locations of separation in floor slab along construction joints and widths of joint openings. The concrete slab does not appear to have settled differentially across the cracks. A 2mm crack in the concrete floor slab has also been observed and indicated on sketch SK02. There is one crack in the perimeter foundation on the North-western corner.

Some of the walls are out of plumb as a result of the movement in the concrete floor slab and the doors to the bathroom and North-western bedroom are jamming at the top. The bathroom door frame is out of level as it is likely that the bottom plate fixing has pulled away from the concrete slab. The wardrobe door in the North-eastern bedroom is jamming and the dining area slider is sticking. Refer to sketch SK02 for doors that are jamming.

Internally there is little damage to the wall linings. Externally the mortar joints of the brick cladding is cracked on the Southern elevation.

Externally there is evidence of land movement confirming the earthquake related movement in the dwelling. The concrete paving has pulled away from the neighbour's garage and also cracked in a number of areas on the Northern and Western elevations. On the Southern elevation there is cracking in the tarmac driveway and settlement in the area at the front of the garage.

**MS-SF2009****Repair Solution**

It is proposed to remove and replace two sections of the slab foundation in the areas indicated on sketch SK03 as the construction joints have opened in these areas and there are doors jamming indicating earthquake related movement. Refer to sketch SK03 for proposed target level.

In the Northern end of the house the ceiling members are to be propped using Acrow props or a similar system and walls removed as necessary to provide access for replacing the floor slab. When replacing the section of floor slab it is to be cut out 200mm from all external walls. The replacement section of slab is to be connected back into the existing slab using D10 starter bars epoxy grouted 150mm into the existing section at 600mm centres. New construction joints in the locations indicated on sketch SK03 are to be built into the new section of slab using MiTek Krack Mates. Refer to sketch SK04 for details for undertaking this work. The bottom plate of the internal stud walls are to be connected to the foundation using GIB HandiBracs as per the attached product specification.

An 800mm wide section of slab in the hallway and kitchen/dining area is to be removed and reconstructed as per the attached details in sketches SK05 and SK06. A new construction joint is to be built into the slab in the same location as the original as indicated in sketch SK03 using a MiTek Krack Mate. D10 starter bars at 600mm centres are to be epoxy grouted 150mm in to the existing foundation as per the attached details in sketches SK05 and SK06. The starter bars are to be installed into every second side of the new section of concrete slab.

The 6mm crack across the lounge floor as indicated in sketch SK02 is to have a new MiTek Krack Mate installed and filled using Ardex Crackbond JF-311 as per the attached product specifications.

The crack in the perimeter foundation on the North-western corner is to be remediated as per the attached crack repair in walls and foundations specification.

**Other Repairs:**

The cracks in the mortar joints of the brick cladding by the Southern entrance door are to be ground out and repointed.

### JOINT PREPARATION:

Remove all dust, debris, oil and any other contamination from the construction and/or saw cut joints. For best results re-cut joints with a dry diamond blade. Joints must be clean and dry. Install material into joint so that material is slightly higher than the face of the concrete. Allow Crackbond JF311 to set for approximately 45 minutes (at 75° F.) then use a sharp 8" wall scraper to shave excess material from top of slab.

### CARTRIDGE SET-UP:

While preparing cartridge for dispensing, keep cartridge in upright position to prevent material from leaking out of cartridge. Do not tilt cartridge until material is to be applied to the repair area.

**IMPORTANT:** During set-up of cartridge (purging air and equalizing) and initial dispensing of material, keep cartridge and nozzle assembly pointed straight up. **AFTER** purging/equalizing and initial shot of material, always keep cartridge and nozzle pointed downward to prevent material in nozzle from flowing back into cartridge.

**I.** Shake cartridge vigorously for 60 seconds, then stand cartridge upright for 5 minutes.

**II.** Insert cartridge into dispenser. Make sure it is properly positioned with shoulder of cartridge flush with front/top bracket of the dispenser. Remove plastic cap from the top of the cartridge. **IMPORTANT!** Before attaching nozzle, dispense a small amount of material into a disposable container until both materials flow evenly from cartridge. **V.** Allow the Crackbond JF311 to set for approximately 45 minutes (at 75° F.) then use a sharp 8" wall scraper to shave excess material from top of slab.

**VI.** Allow material to fully cure before subjecting repaired area to any type of traffic.

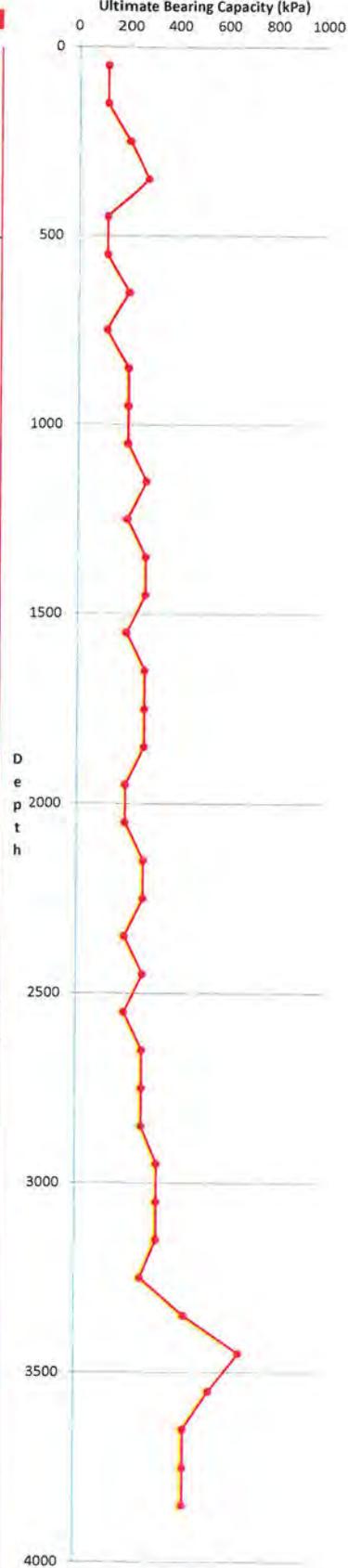

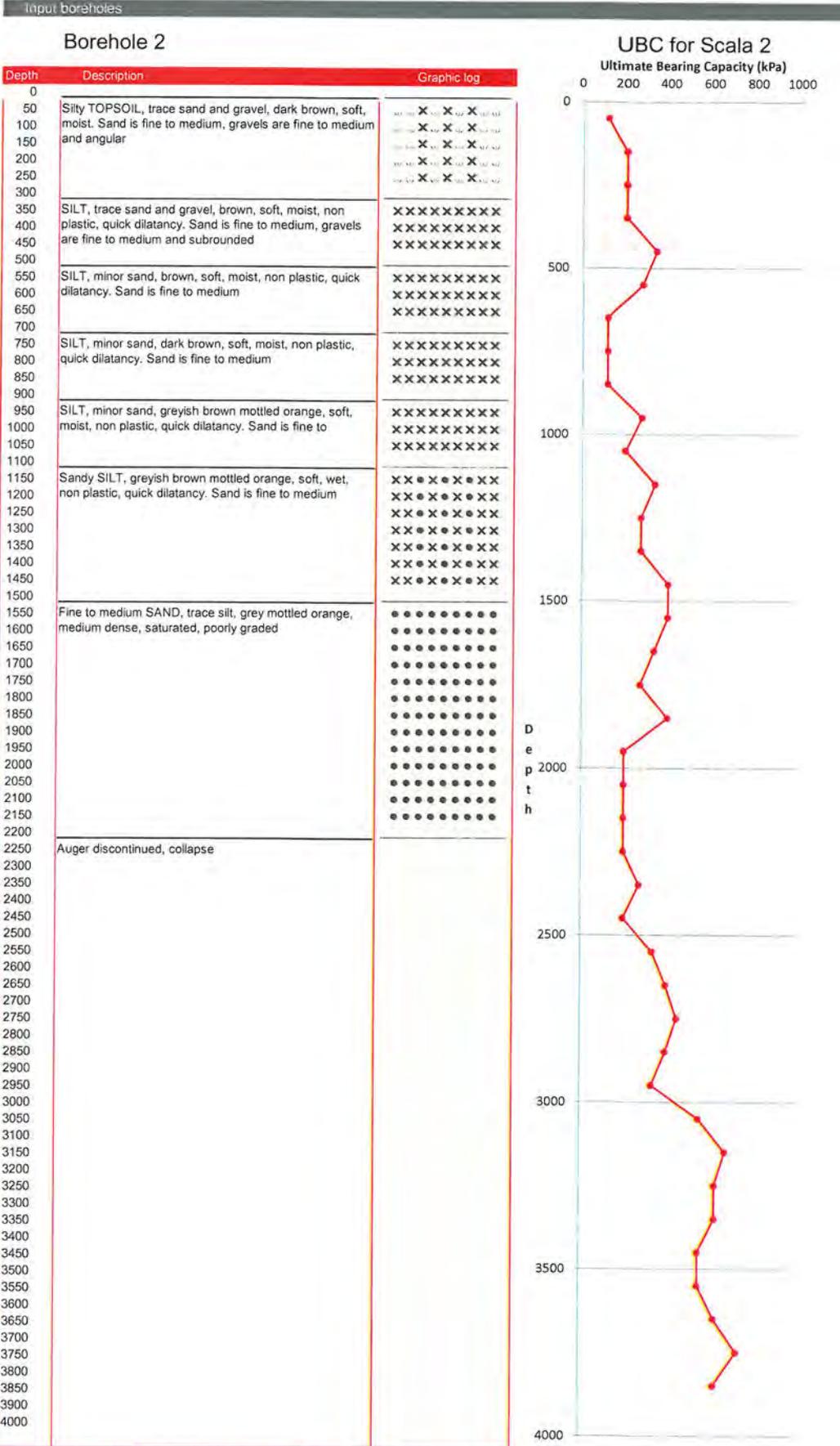

## Geotechnical Report

### *Purpose*

At the request of the allocated Structural Engineer (S. Regan) a geotechnical investigation has been carried out to determine the surrounding soil bearing capacity and classification.

### *Site description*

The dwelling is located in Technical Category 3 (blue) area on flat ground.

### *Investigation*

The investigation consisted of two combined hand auger and Scala penetrometer tests. Borehole one reached a depth of 2.6m below ground level (BGL) and borehole two reached 2.2m BGL. Scala penetrometer one and two both reached target depth of 3.9m BGL.

### *Results*

Borehole one is located near the south corner of the dwelling. The soil profile consists predominantly of inter bedded layers of silt and sand to a depth of 2.6m BGL. The hand auger was discontinued at 2.6m BGL due to collapse. The water table is located at 2.0m BGL. The ultimate bearing capacity inferred from the Scala penetrometer reaches 200kPa at 0.9m BGL, and then reaches 300kPa at 3.3m BGL where it remains consistently above 300kPa until target depth is reached.

Borehole two is located near the northern corner of the dwelling. The soil profile consists predominantly of silt to a depth of 1.5m BGL, sand is then present from 1.5m to 2.2m BGL. The hand auger was discontinued at 2.2m BGL due to collapse. The water table is located at 1.6m BGL. The ultimate bearing capacity inferred from the Scala penetrometer reaches 200kPa at 0.9m BGL, and then reaches 300kPa at 2.6m BGL where it remains consistently above 300kPa until target is reached.

Geotechnical investigation results in tandem with this report.

### *Notes:*

No interpretation of the findings has been made other than to determine indicative bearing capacity based on the Scala penetrometer tests.
