








#### LIQUEFACTION AND GROUND SHAKING

#### **Subject to the Following Conditions:**

- That the development shall proceed substantially in accord with the plans and information submitted in the application to the satisfaction of the Manager, Resource Management, Hastings District Council (Ref: Resource Consent RMA 20020539, Application Dated 13/12/02).
- 2. That the disturbed areas shall be re-vegetated within 12 months of the earthworks being undertaken.
- 3. That no earthworks shall be undertaken except in accordance with the recommendations of the geotechnical report prepared by Dezign Works submitted as part of the application.
- 4. That the applicant shall submit Form 4-3 "Statement of Professional Opinion as to Compliance of the Subdivision with the Subdivision Consent Conditions for Geotechnical Works" (Appendix 4.0-1 of the Proposed Hastings District Plan as Amended by Decisions on Submissions (July 2000) from a registered and professionally qualified engineer, to the Manager, Resource Management, Hastings District Council, on the completion of the engineering works.
- 5. That a monitoring fee of \$135 (incl. GST) shall be payable to cover the reasonable costs of monitoring compliance with the above conditions in accordance with Council's schedule of charges. In the event of non-compliance being detected by monitoring or justified complaint, the costs to Council of any additional monitoring shall be paid by the consent holder in accordance with the Council's advertised schedule of fees

#### With the Reasons for this Decision Being:

- 1. Conditions 1 and 2 ensure that the visual intrusion of the exposed cuts will be remedied
- 2. Conditions 3 and 4 ensure that the proposed earthworks will be stable, and will not result in any additional landslides.
- 3. Condition 5 ensures compliance with the approved plans
- 4. The proposal is consistent with the assessment criteria in that:
  - Due to the contours of the land and existing vegetation the work would not be highly visible by traffic along Hill Road.
  - There are no earthwork volume threshold limits that apply in the Rural Residential Zone.
  - The majority of the work will be the modifying of the existing access way, therefore minimising the cutting across hill faces and spurs.
  - That exposed earthworks will be re-grassed, therefore minimising the visual intrusion of the exposed cuts.

- 5. The proposal is consistent with the objectives, policies and other provisions of the Proposed District Plan in that any adverse visual effects created by the development will be avoided, mitigated or remedied.
- 6. The application meets the requirements of the Resource Management Act 1991.

- 1. That the development shall proceed substantially in accord with the plans and information submitted in the application to the satisfaction of the Manager, Resource Management, Hastings District Council (Ref: Resource Consent RMA 20030123, Application Dated 19/3/03).
- 2. That the disturbed areas shall be re-vegetated within 12 months of the earthworks being undertaken.
- 3. That no earthworks shall be undertaken except in accordance with the recommendations of the geotechnical report prepared by Dezign Works submitted as part of the application.
- 4. That the applicant shall submit Form 4-3 "Statement of Professional Opinion as to Compliance of the Subdivision with the Subdivision Consent Conditions for Geotechnical Works" (Appendix 4.0-1 of the Proposed Hastings District Plan as Amended by Decisions on Submissions (July 2000) from a registered and professionally qualified engineer, to the Manager, Resource Management, Hastings District Council, on the completion of the engineering works.
- 5. That a monitoring fee of \$135 (incl. GST) shall be payable to cover the reasonable costs of monitoring compliance with the above conditions in accordance with Council's schedule of charges. In the event of non-compliance being detected by monitoring or justified complaint, the costs to Council of any additional monitoring shall be paid by the consent holder in accordance with the Council's advertised schedule of fees.

#### With the Reasons for this Decision Being:

- 1. Conditions 1 and 2 ensure that the visual intrusion of the exposed cuts will be remedied
- 2. Conditions 3 and 4 ensure that the proposed earthworks will be stable, and will not result in any additional landslides with adverse visual effects.
- 3. Condition 5 ensures compliance with the approved plans
- 4. The proposal is consistent with the assessment criteria in that:
  - There are no earthwork volume threshold limits that apply in the Rural Residential Zone.
  - Only 75 metres of the track will require a greater than 2 metre vertical cut.
  - The majority of the entire track will be located just below the ridge line in order to minimise cuttings across hill faces.
  - The exposed earthworks will be re-grassed, therefore minimising the visual intrusion of the exposed cuts.

- The proposal is consistent with the objectives, policies and other provisions of the Proposed District Plan in that any adverse visual effects created by the development will be avoided, mitigated or remedied.
- 6. The application meets the requirements of the Resource Management Act 1991.

# Geotechnical Certification for Stage 2 (Lots 25 to 33 only), Eskridge Subdivision

#### 1 Introduction

This letter confirms that we were involved with this project initially in the role of geotechnical investigators and subsequently with limited (approximately fortnightly) construction inspections of earthworks in 2004 and 2005. Opus International Consultants Ltd (OIC) initially carried out detailed site inspections and in situ earthworks testing but was subsequently replaced as the geotechnical inspector/tester by Jacka Consulting Ltd (JCL) in late 2004.

Site observation and in situ testing data was supplied to us by OIC and subsequently JCL for our review. This letter describes our conclusions from that review.

#### 2 Technical review

In situ vane shear strength and air voids testing for compliance with the earthworks specification were conducted by OIC and JCL. Twenty eight Shear Strength and sixty four Nuclear Densometer (Air voids) tests were carried out during the construction period. The attached results showed that the shear strengths comfortably exceeded the minimum specification of 140 kPa and below the maximum requirement air voids of 10%. Table 1 below summarises these results.



Table 1 - Summary of in situ earthworks testing

Note: Shear strength readings >225 kPa were assumed to be 225kPa

The only non-complying results were a zone of fill about 3 m beneath finished ground level on Lot 28. This material recorded an average shear strength of 130 kPa compared with the specified minimum of 140 kPa. As the strength was only marginally less than specified and all the air voids achieved the specification, it was judged that this zone of fill did not require replacement. All other test results were acceptable.

#### 3 Conclusions

Based on our site limited inspections and review of site test data provided by others, we conclude that the construction works have been carried out in general accordance with the recommendations of our preliminary geotechnical report 19393 dated august 2003. There are, however, some fill slopes adjacent to the access tracks for Lots 28 and 33 that are steeper than the 2H:1V maximum recommended in the report. In addition, some engineered fill was placed at the head of the northern slope of Lot 32. The natural slope below Lot 32 is greater than 2H:1V. It is possible that some instability may occur in these fill slopes during extreme weather or earthquake events. Accordingly, we recommend that the generic building setback (from the break in slope) is increased for Lot 28 and Lot 32 and this is discussed in Section 4 below.

We also conclude that, based on our construction inspections and the review of the as built plans, earthworks on the main access road and internal access roads have been carried out in accordance with the recommendations in our investigation report dated August 2003. The alignment is effectively as shown on Dezign Works (HB) Limited drawing INT 04 C01 'Earthworks and Roading Site Plan' with appropriate minor site modifications to suit the localised topography and ground conditions. From our site inspections, we consider the final alignment to be suitable from engineering considerations.

From our observations and review, it appears that only clean fill has been used a fill material and the earthworks have been carried out in accordance with acceptable engineering standards. Copies of the cut and fill contour plan and final as-built drawing have been provided by Surveying the Bay and are attached to this letter.

To summarise, from our inspections and review of the site testing data, we are satisfied that the works have been undertaken in accordance with Conditions 8, 19, 20 and 22 of the Resource Consent.

#### 4 Building development

Attached is Form 4-6: "Statement of Professional Opinion as to Suitability of Land for Building Development Subdivision". On the form, we have indicated that specific design is required for building foundations within 8 m of the head of slopes exceeding 15° with the exception of Lot 28 which as described in Section 3.0, requires a 10 m setback (without specific design) due to a steep fill slope on the access track. We also recommend that a 14m setback (without specific design) is applied to Lot 32 due to fill being placed at the head of the steep natural slope. The recommended setback distance is necessary to allow for potential instability on the outer edge of slopes during seismic events and also for downslope creep of soil near the edge of building platforms during static conditions. Accordingly, any foundations constructed within this zone require specific design to allow for this potential instability. All foundations should be founded a minimum of 600 mm beneath adjacent ground level to minimise the effect of seasonal shrink/swell effects. At this depth, an allowable bearing pressure of 100 kPa (150 kPa Ultimate Limit State) is expected to be available.

It must be stressed that stormwater control is particularly important to slope stability. Under no circumstances should concentrated stormwater flows be discharged over the adjacent slopes and final site contouring should deflect stormwater flows away from houses. In general terms, all runoff from house roofs and hard stand areas should be collected and piped to the base of the slopes.

#### 5 Observation

The Eskridge subdivision was constructed in 2004 and 2005; the engineered fill slopes have performed with minimal instability in the subsequent years during numerous extreme rainfall events and earthquakes. It should be noted that during these weather events, many significant landslips have occurred in flatter natural sloping ground in the Hawkes Bay region.

## 6 Applicability

This report has been prepared for the benefit of Seafield Farms with respect to the particular brief given to us and it may not be relied upon in other contexts or for any other purpose without our prior review and agreement. To undertake this assessment we have relied upon test results provided to us by others.

During excavation and construction, the site should be examined by an engineer or engineering geologist competent to judge whether the exposed subsoil's are compatible with the inferred conditions on which the report has been based. However, it is important that we be contacted if there is any variation in subsoil conditions from those described in this summary report.
