### AVERAGE DAILY ENERGY USAGE



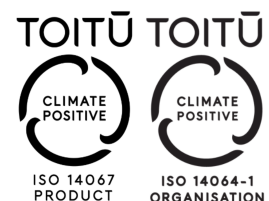
