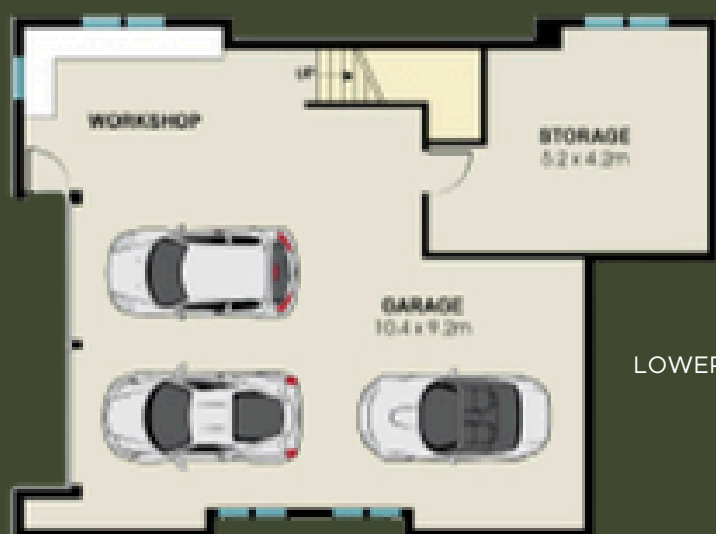

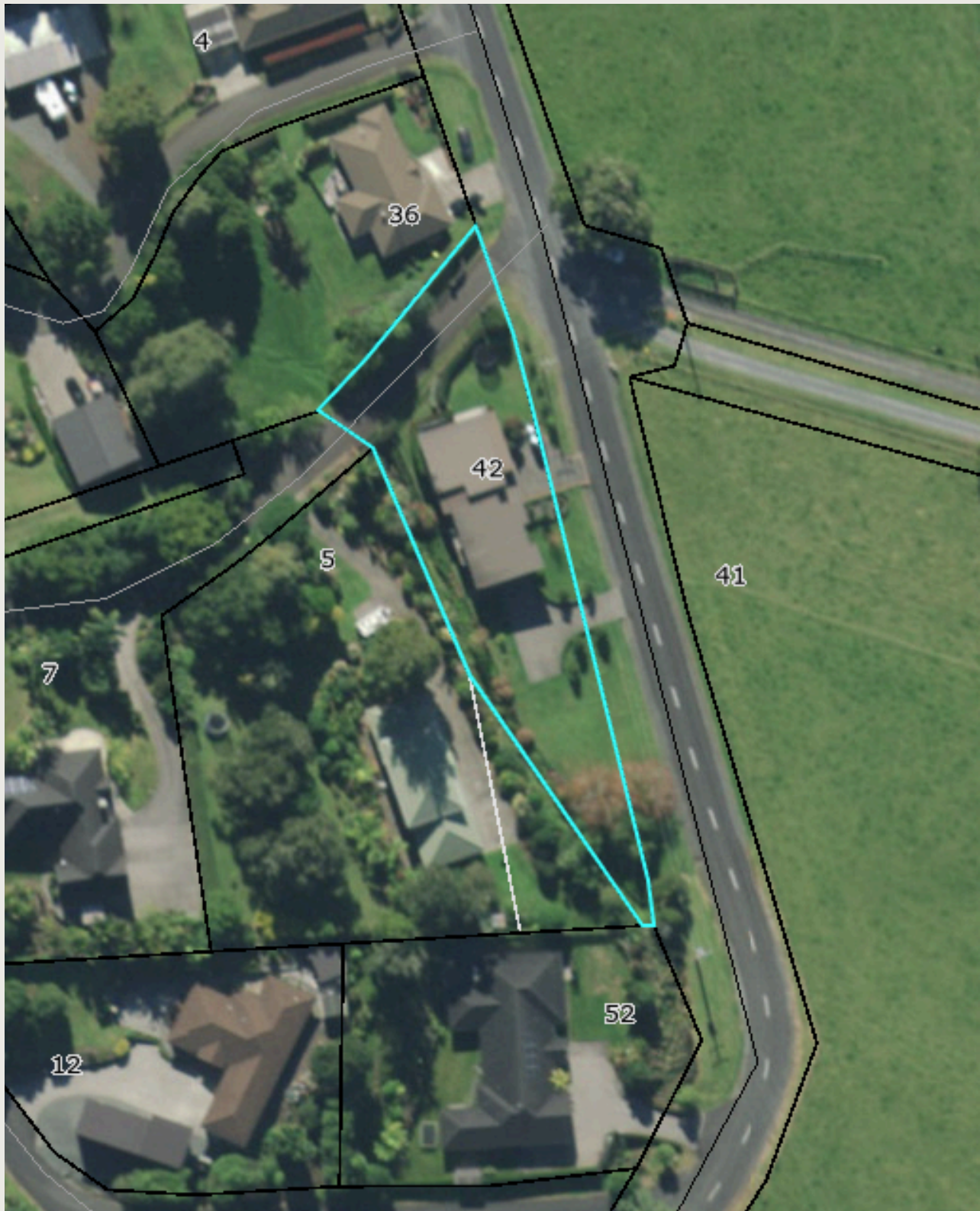


LOWER LEVEL
