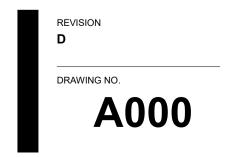

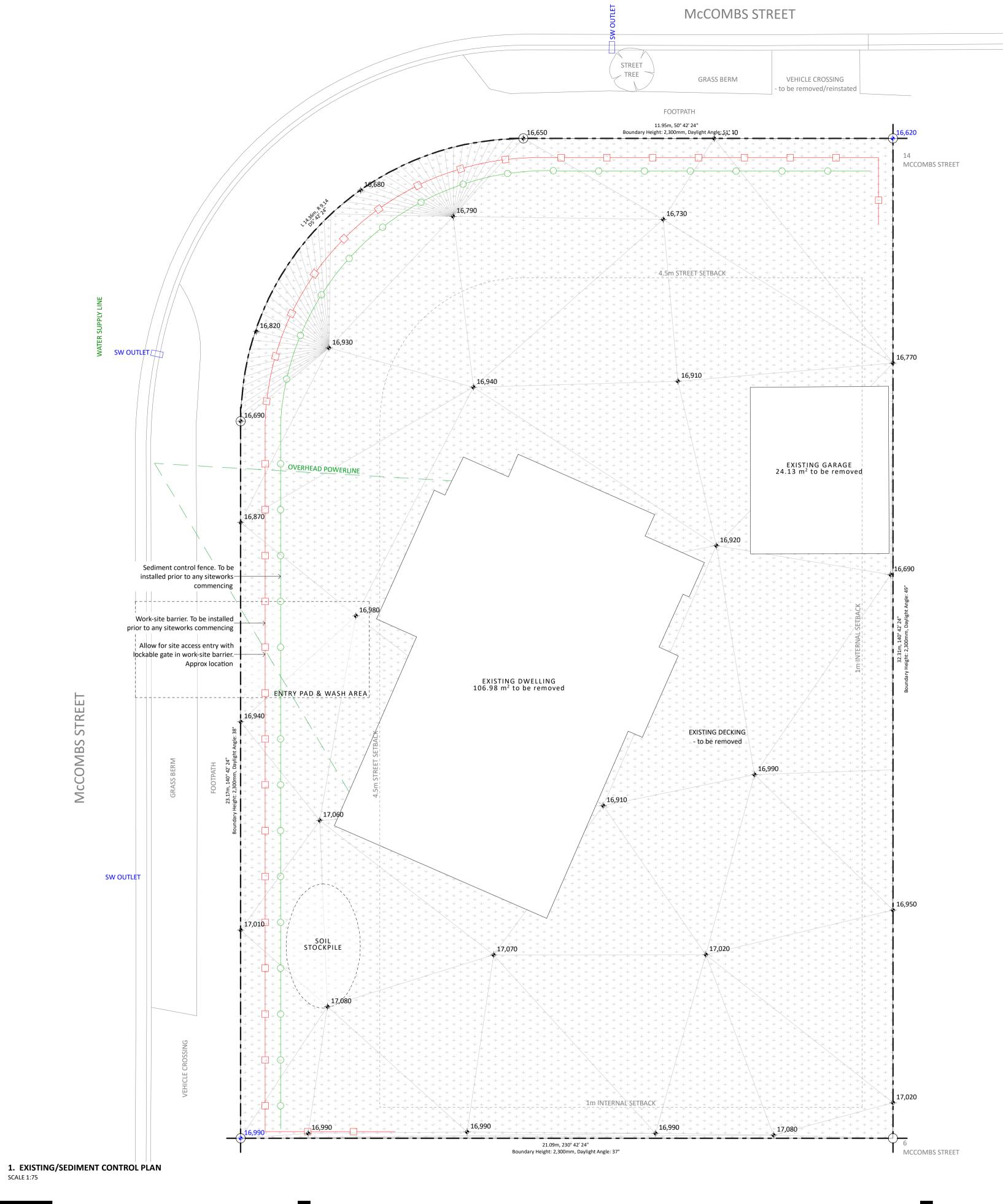

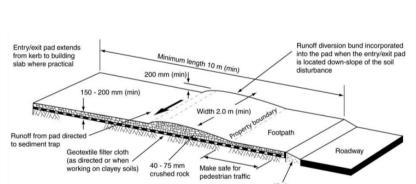


FIG. 3 STABILISED ENTRY/EXIT PAD

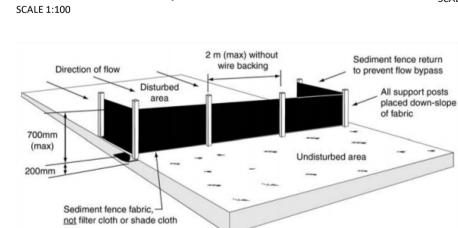


FIG. 9 SEDIMENT FENCE CONSTRUCTION
