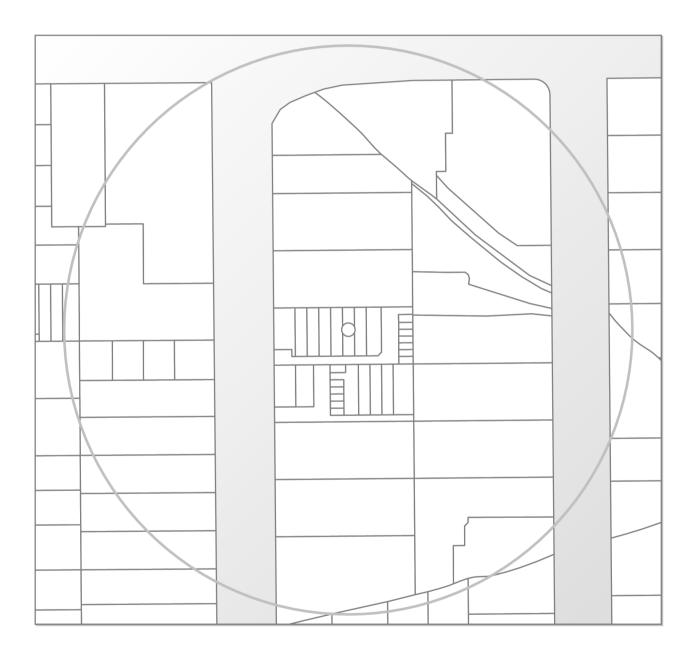

1 Introduction

1.1 Discussion

Tetrad Consulting Ltd has been engaged by Rosefern Homes Ltd to undertake a geotechnical investigation at 196 Hills Road for a residential development comprising a single block of eight two-storey units constructed with heavy weight cladding materials.

This report presents the results of a geotechnical investigation to characterize the subsurface soil profile and strength properties for foundation design and discussion of the following:

- Quantify liquefaction susceptibility for a design basis seismic event.
- Confirmation of Ministry of Business, Innovation and Employment land classification for the site.
- Provide foundation recommendations for the proposed development.

The scope of this geotechnical report does not include commentary on site-specific environmental issues, which is beyond the scope of our geotechnical engagement.

1.2 Supporting Documentation

The following design documentation has been provided by Petrie Architects for completion of this report:

• Architectural Concept Plan by Petrie Architects – "Hills Road Terraces"; dated 07 March 2024

2 Site Description

The setting is a flat residential site comprising of 196 Hills Road Street with a total land area of about 983 m² located along the south side of the street. The site is currently developed by a large single storey dwelling turned doctors office with an added extension to the rear and a detached garage.



Figure 1: Approximate location of subject site on the east side of Hills Road



3 Proposed Development

Architectural plans by Petrie Architects dated 28 July 2023 showed the site with eight attached two-storey residential units, constructed of heavy weight exterior cladding materials, lightweight framing, and a lightweight tin roof.

4 Ground Investigation

4.1 Historical Investigation

A range of shallow and deep testing was performed near/on the southern and northern boundaries of the site. Cone penetrometer tests (CPT's) and the shallow tests within 15 m of the subject site will be taken as site specific and referred to alongside onsite testing shown in Section 4.2 below.

The CPT, hand auger (HA) and Scala penetrometer (SP/DCP) test locations and are shown in Appendix A and summarised in Table 1 below.

4.2 Onsite testing

Three hand augers and Scala penetrometer tests to 3 m were performed across the site by Tetrad Consulting Ltd on 23/08/23. A Cone penetrometer test (CPT99651) was sourced from the NZGD and located on the northern boundary of the site. The hand auger (HA) and Scala penetrometer (SP/DCP) and Cone penetrometer test locations and are shown in Appendix A and summarised in Table 1 below.

4.3 Total test coverage

The historical and onsite tests assumed as site specific are shown together in Figure 2 below.

5 Subsurface soil conditions

5.1 Geology

A geological map of the area (Brown and Weeber, 1992) shows the site area as underlain with soils of the Christchurch Formation to approximately 20 m depth comprising beach, estuarine and coastal swamp deposits of sand, silt and peat. This is underlain by the Riccarton gravel formation, comprising well graded gravel with cobble sizes up to 100 mm.



5.2 Soil Profile from shallow testing

Onsite hand auger tests HA01- HA03 showed the soil profile comprised topsoil to a depth of up to 0.8 m and interbedded sands and to silts 3.0 m.

Nearby hand augers from NZGD log HASP_180282 (HA02- HA05) are close enough to the property boundary to be considered site specific. These tests showed topsoil to 0.4-0.5 m underlain by sandy silts/silty sands to 1.5-1.8 m depth. A 0.2 m thick layer of organic silt was observed from 2.0-2.2 m depth across all four subject hand augers underlain by blue plastic clayey silt. The soil profile correlates well with Tetrad's onsite shallow borehole testing.

Onsite Scala penetrometer tests returned the below blow count results in Table 4. Scala penetrometer blow counts exceeded 2 blows/100 mm penetration from 0.8 m depth, equating to an ultimate geotechnical bearing capacity of 200 kPa. Scala blow counts increased beyond 1.8 m depth in clayey silts as indicated in Table 3.

5.3 Soil Profile from CPT testing

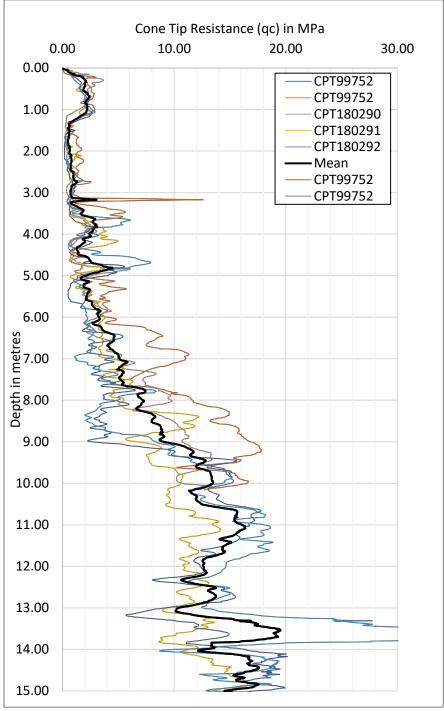


Figure 3: Cone tip resistance versus depth

Figure 3 below shows cone tip resistance profiles against depth for the NZGD sourced CPT tests shown in Figure 2. The cone penetrometer resistance values range between 0.5-1.0 MPa in the interbedded clayey silt and sand layers to 5.0 m depth. The Qc values increase with depth from 5 to 15 m with medium dense silty sands to 6-9 m and dense sand below 10 m.

5.4 Ground Water Table

To assess the ground water table depth, reference had been made to the GNS Science Median Groundwater Surface Elevations from the NZGD which indicate the water surface contour range based on long term observation records at each site. The water surface contours are stated in terms of the LVD 1937 datum, which is set at 9.043 m above the Christchurch Drainage Datum (CDD). Table 5 below shows the water surface contours for the 15th and 85th percentile in terms of the LVD datum.

When referenced to the CDD, the 15th Percentile water surface contour level translates to a water table depth (GWT) of 1.4m based on an average site ground level of RL 13.3 m as sourced from the Christchurch City Flood Management website. The 85th percentile water surface contour level translates to a GWT of 0.8 m based on a minimum site ground level of RL 13.03 m. This correlates reasonably well with the observed GWT depth from HA01 of 1.2 m below ground level. For liquefaction assessment an elevated ground water depth of 0.8m below the lowest ground level is considered appropriate at this site.

6 Seismic Assessment

6.1 Previous Earthquake Performance

The site has been subjected to repeated ground shaking from the Canterbury earthquake sequence. Reference to the New Zealand Geotechnical Database shows the conditional peak ground accelerations based on the method by Bradley et al (2012). The method combines the empirical strong motion attenuation with distance model, with the actual observation to produce conditional peak ground accelerations. Table 6 below summarises the PGA values for the 2010/2011 earthquake events.

 $PGA_{16,7.5}$ represents the 16^{th} percentile (i.e 84% probability of exceedance) scaled to a M7.5 earthquake. $PGA_{84,7.5}$ represents the 84^{th} percentile (i.e 16% probability of exceedance) scaled to a M7.5 earthquake.

The predicted mean PGA for each earthquake has been converted to an equivalent PGA for magnitude M7.5 earthquake in accordance with MBIE guideline recommendations by the method of Boulanger & Idriss 2014.

The adjusted PGA values are also shown with an 84% and 16% probability of being exceeded. The MBIE value in the table represents the 90% exceedance PGA which is accepted as being "well tested" for an SLS1 event. In this case, the site has been well tested to SLS1 and SLS2 levels of ground shaking from the September 2010 and February 2011 events with a mean $PGA_{50.7.5}$ value of 0.20g and 0.37g, respectively.

6.2 Liquefaction from CPT Tests

Liquefaction assessment of the nearby historical CPT tests described by Section 4.1 has been completed by the method of Idriss and Boulanger (2014).

In applying this method, a water level at 0.80 m has been adopted for triggering of liquefaction in the alluvial deposits.

A 'fines correction' coefficient (CFC) of 0.2 and a CRR PL value of 30% was adopted for the liquefaction analysis in the Idriss and Boulanger method to provide a 'best fit' with the LIDAR imagery data from the NZGD.

Liquefaction induced settlement has been quantified by the method of Zhang et al (2002). Table 7 below summarises the predicted liquefaction settlements rounded up to the nearest 5 mm to a test depth of 10 m for a SLS1 and ULS event with PGAs of 0.13g and 0.35g, respectively. A second serviceability earthquake event (SLS2) has also been considered with a PGA of 0.19g and Magnitude M6.0.



Across the NZGD sourced CPT's liquefaction is triggered significantly from 5 – 9 m under SLS1 loading and from 3.5 – 10 m under ULS loading. The expected lower/upper bound and mean earthquake settlements from the nearby discrete CPT's discussed in Section 4.1 and for three earthquake cases considered have been calculated by performing a simple probabilistic analysis. A confidence interval of 95% was adopted in the analysis to quantify the lower and upper bound estimates of differential settlement. The settlement values for each of the design earthquake cases are shown in Table 7 below. The probabilistic assessment considers the dispersion of the free-field settlement from the mean value for each of the five CPT's discussed. The objective of this approach was to assess the likely spread of free field settlement from the CPT cluster before assessing the maximum differential settlement. In this case, maximum differential settlement of 70 mm is expected for a SLS1 event increasing to 115 mm for SLS and 190 mm for ULS based on a 95 % confidence interval.

The predicted settlements are an index only of settlement damage at the site with a +/-50% probability of occurring during seismic shaking. The predicted settlements are 'free field' and do not consider additional settlement damage due to ground interaction with foundations which may lead to an increase in foundation settlement from foundation bearing failure, if not mitigated by specific foundation design. Refer to Appendix C for liquefaction settlement profiles.

6.3 Previous Earthquake Damage from EQC Observations

Table 8 below summarises the liquefaction observations sourced from EQC records obtained from the NZGD and only returned ground surface damage from the February 2011 event. The EQC records suggest the site is susceptible to moderate ground surface damage from earthquake ground motions equivalent to or exceeding a Magnitude M6.2 event. LiDAR data from the NZGD indicated approximate vertical ground settlement of up to 100 mm after the September 2010 and February 2011 seismic events.

6.4 Liquefaction Potential

We have assessed the 'Liquefaction Potential Indices' number for each of the liquefaction cases identified in Section above. The LPI number provides a performance-based assessment of liquefaction ground surface damage and is influenced by the ratio of the non-liquefiable crust layer to the total thickness of liquefiable soil deposit.

The LPI should be considered in the context of both the ground conditions and structure of interest. The ranges provided in Table 9 below are based on triggering calculations using Boulanger and Idriss (2014) method, and analysis and interpretation of liquefaction effects in the 2010-2011 Christchurch earthquake sequence. Table 9 has been reproduced from, 'Module 3: Identification, Assessment and Mitigation of Liquefaction Hazards": dated May 2016.

Liquefaction analysis of nearby historical CPT tests plots confirmed liquefaction potential Indices (LPI) values of up to 3 for a SLS1, 5 for a SLS2 event and 20 for an ULS event. These values translate to *Moderate* ground surface damage for a SLS1, *Moderate-to-High* for a SLS2 event, and *Severe-to-Very Severe* for an ULS event; therefore, moderate ground damage is predicted during SLS1 and SLS2 ground shaking, with ground deformation resulting in relatively small to moderate differential settlements.

6.5 Lateral Spread

Lateral spread risk has been assessed according to site and ground conditions, as well as proximity to significant waterways or steep changes in ground level. The subject property is generally level with a variance of 0.8 m in ground elevation over the site and is 34 m from a river.

Ground surface observations presented on the New Zealand Geotechnical Database (NZGD) indicates the site experienced ground cracking with cracks between 10-50 mm from past seismic events. Based on this observation, lateral spread damage is considered a moderate geotechnical risk at the site.

6.6 Technical Land Category Classification

Reference to the MBIE Technical Foundation Category Classification off the NZGD website indicates the site is TC3 rated land for the purpose of foundation design. Liquefaction analysis in Section 6.2 showed total *free-field* liquefaction of up to 70 mm for a SLS1 event and 190 mm for an ULS event to MBIE's index depth of 10 m. The predicted settlement values are consistent with the site's TC3 rating to MBIE's guidelines; therefore, we recommend a Technical Category 3 Classification for the purpose of foundation design.

6.7 Seismic Category

The thickness of the alluvial deposits beneath this area of the Christchurch area defines the site as Class D, 'Deep Soils', in terms of the seismic design requirements of NZS 1170.5.



7 Environmental Issues

We have undertaken a review of Environment Canterbury's 'Listed Land Use Register' (LLUR) (http://llur.ecan.govt.nz/). The LLUR is a public record of sites known to have been subject to historical and /or existing potentially contaminating land use activities prescribed in the Hazardous Activity and Industries List (HAIL). A review of the LLUR indicates:

"The Listed Land Use Register does not currently have any information about a Hazardous Activities and Industries List site on this land parcel".

Although the LLUR does not contain any records of potential HAIL at the subject site, the LLUR is not considered a complete record and is being continuously updated, and it is therefore recommended to contact the Christchurch City Council to enquire about any known hazardous activities at the subject site that may require consideration as part of any future consent application.

8 Flood Levels

The Christchurch City Council flood hazard maps at:

https://www.ccc.govt.nz/services/stormwater-and-drainage/flooding/floorlevelmap were accessed on the 28th August 2023. The CCC system shows that the site located in a flood management area, and accordingly the interim flood floor level will be required before lodging a building consent application.

9 Bearing Capacity

Shallow Scala tests completed on the 29^{th} of August 2023 returned a bearing capacity of 200 kPa from 0.8 m depth for a *lower bound* Scala test result of 2 blows per 100 mm of ground penetration at SP01 to SP03. Blow counts increased significantly from 1.8 m depth to refusal at 2.4 - 2.5 m depth. Scala penetrometer blow counts for soils below 1.1 m depth show blow counts between 2 - 4 blows/100 mm penetration.

Therefore, from both Scala Penetrometer and CPT derived bearing capacities, 200 kPa can be assumed from 0.8 - 1.8 m depth provided static settlement analysis is performed on the underlying weak layers to 5.0 m depth. The Scala Penetrometer test results are shown in Appendix B.

10 Foundation Settlement

Calculation of static settlement is from the one-dimensional consolidation method applied to the silts to 5.0 m depth. The elastic modulus has been assessed from the following empirical relationship of CPT tip resistance verses elastic modulus (Es). In this case, the following relationship was adopted with a lower bound q_c value of 0.5 MPa over the critical layers of nearby CPTs (minimum qc values of all CPT's mentioned in Section 4.1 taken).

The elastic modulus has been assessed from the following empirical relationship of CPT tip resistance verses elastic modulus (Es).

$$Es = 2.5q_c - in MPa$$

Total static settlement of approximately 60 mm is predicted in the critical silt layer to 5.0 m for the lower bound cone tip resistance (qc) values for the CPT's described in Section 4.1 and based on an applied foundation load of 25 kPa for combined self-weight of the building, foundation slab and increase in material density of the gravel raft.

Accordingly, differential settlement up to 36 mm is predicted and translates to approximately 14 mm over a 6 m span when applied over the shortest distance (16m) between the CPT locations.



Seismic differential settlement of 70 mm is prediction from the deterministic CPT values for a SLS1 event and is applied over the shortest distance (16m) between the CPT locations.

Combined Seismic and Static settlement translates to approximately 40 mm of settlement over a 6 m span which exceeds the foundation performance requirement in Section B1/VM4 of the NZBC for shallow waffle slab foundations. Therefore, specific design of the gravel raft is required to moderate differential settlement and is discussed further in Section 11 below.

11 Foundations

11.1 Discussion

Appendix D shows the proposed development comprising eight two-storey residential units constructed of heavy-weight cladding with light weight framing and roofing materials in accordance with NZS 3604 type construction. As such, we have considered foundation options outlined in MBIE's Part C: "Repairing and rebuilding houses affected by the Canterbury earthquakes", December 2012, consistent with the TC3 Classification as discussed in Section 6.6 above.

Discussion with architect and structural engineer indicates a raised floor level is required to mitigate flood risk.

Ground surface damage during SLS1 and SLS2 ground shaking can be expected at this site with moderate seismic differential settlement consistent with the low LPI values predicted in Section 6.4. Approximately 40 mm of differential settlement over a 6 m span is predicted from combined static and SLS1 seismic settlement, with most of the static settlement expected in the clayey silt material to 5 m depth.

During a ULS event severe ground surface damage can be expected manifested by large permanent lateral ground displacements and/or significant ground distortion. Accordingly, a relevellable concrete slab foundation as described in Section 11.2 below combined with a reinforced gravel raft would be suitable for the proposed multi-unit development and is expected to moderate differential settlement damage during SLS1 and SLS2 ground shaking, whilst mitigating irreparable damage to the units during an ULS event.

11.2 Reinforced Gravel Raft with relevellable Waffle Slab

The Option 4 relevellable shallow foundation system is required to meet the performance objectives of the MBIE guidelines which requires the foundation to provide enough stiffness to support the imposed reduced gravity load of the buildings under a 2 m loss of edge ground support and 4 m loss of internal ground support.

Discussion with the architect and structural engineer indicate a raised floor level is required to mitigate flood risk, and therefore the waffle slab foundation could be specifically engineered as a double pod system (thicker slab) to meet the required interim flood floor level.

The block of eight two storey units (see Appendix D) has a foundation aspect ratio of 4.2 which doesn't comply within the MBIE guidelines' definition of a regular shaped building. A relevellable shallow foundation system is required with a reinforced gravel raft to moderate settlement damage from static and seismic settlement.

A specifically designed 0.8 m thick gravel raft is required to provide a stable building platform for construction of the relevellable waffle slab system.

The exposed silty soils at the gravel raft base provide an ultimate bearing capacity of 200 kPa from 0.8 m.

Excavation for the reinforced gravel raft is required to at least 0.8 m below the lowest adjacent ground level followed by placement of Bidim A19 geo-cloth over the exposed soils. The base of the gravel raft shall extend



at least 0.6 m beyond the foundation footprint. The gravel raft edges should be battered at 1H:2V and shall be constructed as follows.

- The gravel raft shall be constructed from a well graded fill material comprising stone with at least two subangular faces as per MBIE guideline recommendations.
- The gravel material shall be placed in 150 mm thick layers and compacted to 95 % of the MDD value in accordance with NZS 4431:2002.
- After placement of each compacted hardfill layer, a TriAx-160 geogrid (or similar) shall be laid before placement of the next gravel layer (2 layers of geogrid required in total).
- The compacted fill density should be confirmed via NDM testing at random intervals not exceeding 3 m in each direction on the first and last layer of compacted material.

In the case where extension of the gravel raft beyond the foundation edge is restricted by either a physical boundary line or from a legal easement instrument, the effected edge of the gravel raft should be reinforced by additional layers of geogrid to reinforce the entire depth of the gravel raft. The additional layers of geogrid shall be spaced at 150 mm vertical intervals and shall extend at least 3 m into the body of the gravel raft.

Refer to Appendix D for the proposed development layout.

12 Further Geotechnical Investigations

12.1 Earthworks

During development of the site appropriate stormwater and erosion control measures should be implemented and monitored throughout construction. Erosion control is likely to require the introduction of silt fences, or other similar devices, to intercept soil run-off and improve the quality of the stormwater that will be discharged from site.

12.2 Dewatering during Gravel Raft Excavation

With the high water inferred from the CPT tests and in agreement with the GNS water surface contours off the NZGD, dewatering would be required during excavation of the gravel raft. The near-surface clayey silt soils would likely slow ground water seepage into the excavation, however the development of excess pore pressures due to release of the overburden soil weight may cause softening of the exposed soils at the base of the excavation. The excavation should be left for a period of a few days to allow adequate dissipation of the excess pore pressures in the exposed soils before placement of the gravel raft.

12.3 Pavement Design

For design of flexible pavement areas, we recommend a CBR value of 2%, based on an averaged Scala blow count of 1 blows/100 mm from 0.40 m depth.

12.4 Review of Foundation Design

To ensure the recommendations in this report have been interpreted correctly, we recommend that Tetrad Consulting Ltd is provided with the final foundation design drawings for an independent review. At the time of construction an appropriate level of construction monitoring will be required to confirm that the inferred near-surface soil profile from the CPT test is consistent with the observed soil profile during foundation excavation. Any notable variation (organic material, soft spots etc.) of the exposed soil, identified during construction should be brought to the attention of the geotechnical engineer before commencing foundation works.



Table 10 below states the mandatory geotechnical site inspections to be carried out by a suitably qualified geotechnical engineer during the construction phase of the shallow ground improvement phase:

13 Limitations

This report has been prepared for Rosefern Homes Limited and the Christchurch City Council for the purpose of supporting a building consent application for the proposed multi-unit residential development at the subject property.

No liability is accepted by this company or any employee of this company with respect to its intended use by any other person or persons.

This report has been based on the results of cone penetrometer tests completed at discrete locations; therefore, subsurface soil conditions are 'inferred' based on interpreted data and could vary from the test locations at the time of the geotechnical assessment. Should exposed soil conditions vary from those described herein Tetrad Consulting Ltd requests that it be notified immediately.

The geotechnical investigation was confined to geotechnical aspects of the site only and did not involve the assessment for environmental contaminants.

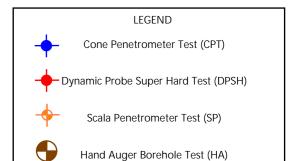

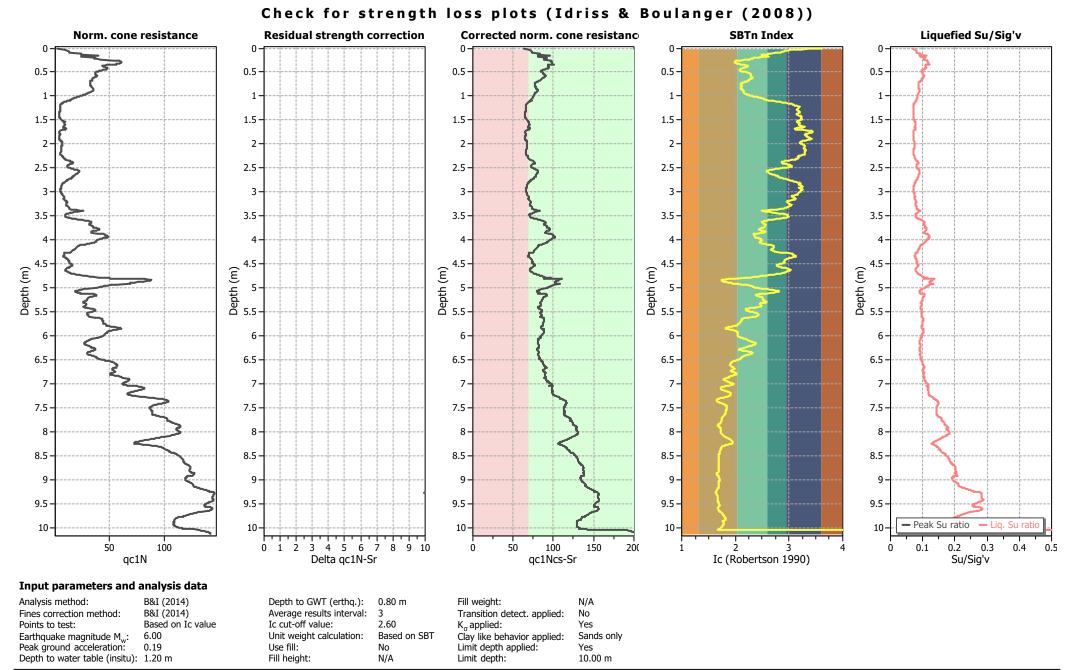
