SCHEDULE C

- For a period of 15 years from 1 April 2006 the registered proprietors of any of the lots set out in Schedule B (the property), shall not erect or place on the property any dwelling or building unless full working drawings (including site plan) showing design, exterior colour, cladding and other materials have been approved in writing by the Transferor (or nominee). Such consent shall not be arbitrarily or unreasonably withheld.
- 2. The Transferor will not be liable because of any action it takes or fails to take in respect of any dwelling or building erected on the property as a result of these restrictions or otherwise and the registered proprietors for the time being of the servient and dominant tenement shall indemnify and keep indemnified the Transferor from any costs, claims, suits, liabilities or otherwise however arising out of or by virtue of these restrictive covenants.
- 3. The Transferor shall not be liable to pay for or contribute towards the expense of construction or maintenance of any fence between the property and any contiguous land of the Transferor. This provision shall not endure for any purchaser or registered proprietor of the contiguous land.
