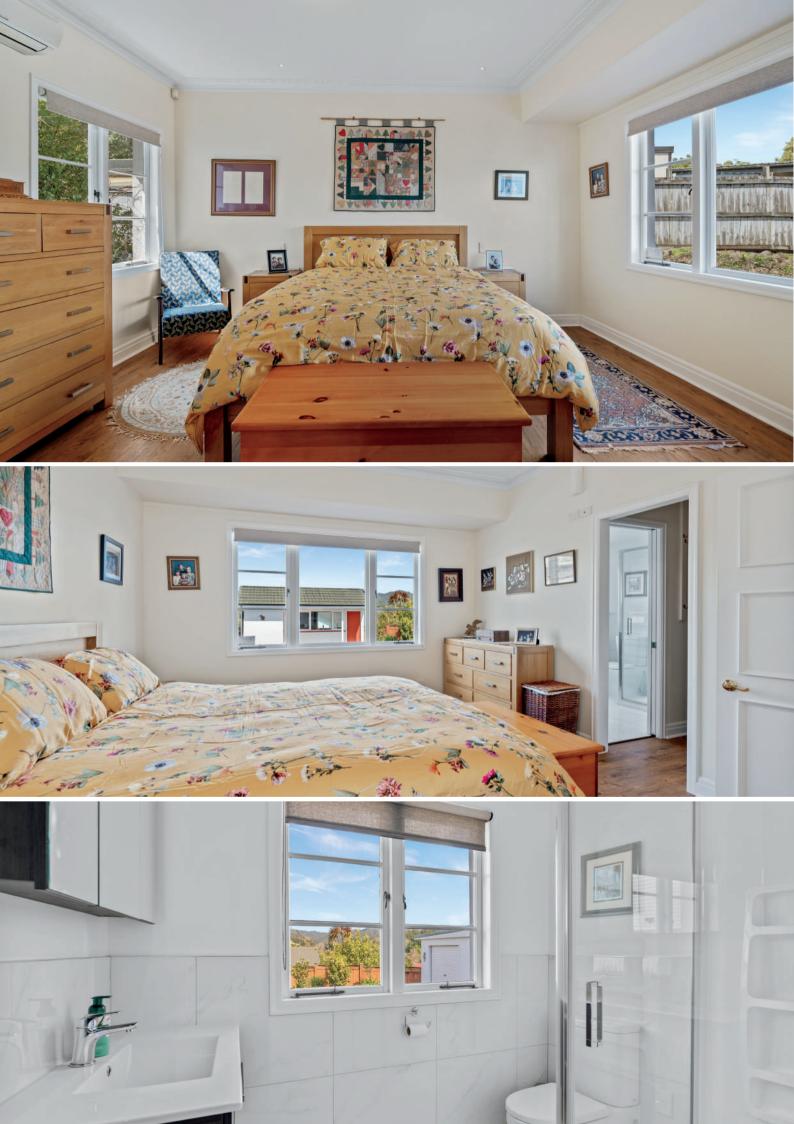

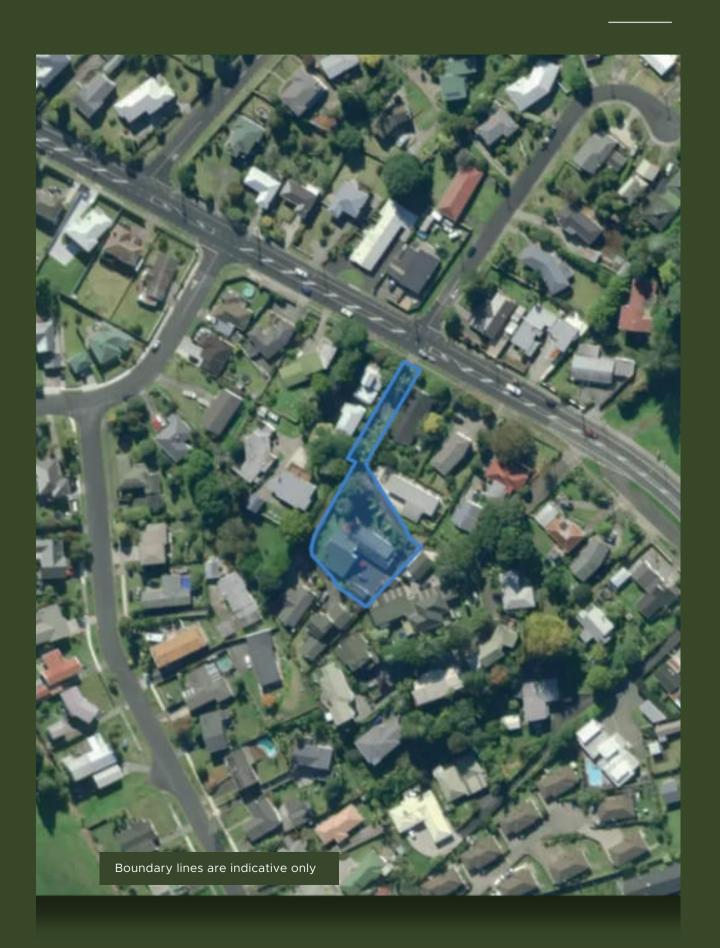


### FLOOR PLAN

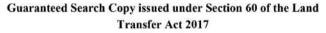
