1. The Covenantor shall be bound by the following covenants:

The Covenantor shall not at any time hereafter construct or erect nor permit to be constructed or erected on each lot of the burdened land:

- (a) Any building except one private dwelling and ancillary buildings with garages and/or carports.
- (b) Any dwelling or ancillary buildings other than a new dwelling and ancillary buildings constructed from new materials <u>TO THE INTENT</u> that no existing dwelling or other building shall be moved and re-sited on the burdened land.
- (c) Any dwelling which has a floor area of less than 145 square metres unless prior approval is given by Challenge Manawatu Limited for a lesser area.
- (d) Any dwelling or building which has been constructed or partly constructed away from the burdened land.
- (e) Any dwelling or building except one constructed of new permanent low maintenance materials of good quality and in particular no dwelling or building incorporating the following materials:
 - (i) unpainted roofing iron or garage doors;
 - (ii) exterior sheet cladding or extended weatherboard products or similar unless prior approval is given by Challenge Manawatu Limited;

2. The Covenantor shall not:

- (a) Commence to erect or permit the commencement or erection of any dwelling or other works on the burdened land without having first submitted the plans, site plan and specifications therefor and having obtained from Challenge Manawatu Limited written approval of the same (copies of which may be retained by Challenge Manawatu Limited for later verification); and
- (b) Alter in any significant manner any plans or specifications which may have been given approval as aforesaid or to deviate significantly therefrom, or to permit any significant deviation therefrom in the construction of any dwelling or other works without first obtaining the written approval of the Covenantee to any such change, such approval not to be unreasonably or arbitrarily withheld; and
- (c) Apply to the Local Authority for a building permit or proceed with the erection of any dwelling or other building on the said burdened land until approval has been obtained as required above and once such approval has been obtained the Covenantor will carry out and complete the work in accordance with the plans and specifications approved by Challenge Manawatu Limited and in particular, will complete exterior finishing and painting within six (6) months from the date on which construction commences; and
- (d) Except when the building operations are in progress, place or permit or allow to be brought onto or remain on the said burdened land any temporary dwelling, caravan, trade vehicle, trailer, trade equipment or machinery, materials, debris, rubbish or vehicles of any unsightly nature unless the same are adequately garaged or screened to prevent offence to any adjoining land and to preserve the amenities of the neighbourhood; and

- Park or permit to be parked large motorised vehicles or trade vehicles over night within the (e) Formed road carriageway adjacent to and/or in the vicinity of the burdened land; and
- (f) Use, in respect of any fencing to be constructed on boundaries either exclusive to or adjoining the burdened land:
 - (i) (ii) iron or corrugated iron fence cladding;
 - second-hand materials;
- (g) Construct any fence having a street frontage without obtaining the prior written approval of the Covenantee as to the height of such fence. The Covenantor shall pay for construction and maintenance of any fence constructed on the boundary of any adjoining land owned by Challenge Manawatu Limited and shall not seek contribution from Challenge Manawatu Limited for such construction or maintenance costs.
- з. The covenants set out in clauses 1 and 2 herein shall automatically expire as to any of the lots of burdened land that are required to vest as road or reserve in any subsequent subdivision completed by Challenge Manawatu Limited upon the approval of such further subdivisional plan by the Palmerston North City Council.
