

To whom it Concerns,

Enclosed is a copy of the invoice sent to me for a call out to my property regarding a blocked toilet problem. I am reluctant to pay this bill as i am unhappy with the way your staff handled the job.

On the initial visit on 5th July 2010 your workmen used a toilet plunger and left thinking it was fixed. They were on the property for only 10 -15 minutes at the most. Although it seemed to lower the water level in the toilet bowl initially, it was obvious to me that evening that the problem was not solved and the toilet continued to overfull itself as if there was a blockage somewhere.

On phoning your company back you sent your workers back and they attempted to clear the pipes using the waterblast hose, for which they were on the property for perhaps 30 minutes all up. This still did not solve the problem and the toilet continued to get worse over the days that followed.

As i was unhappy with the outcome of the job and the way your workers communicated with me about the job, I contacted another company and they have since offered me a better service with a better outcome ie: a toilet that does not overflow.

My complaint is that your workers were very unhelpful in the way they communicated with me throughout the process. It felt like pulling teeth trying to get any information or advice on what the problem was or options on solving it. They did finally, after some effort on my behalf, tell me i would maybe need to get a video inspection but didn't explain what this involved until once again I had to extract it from them. Their way of handling the job was uninvolved and blase' as opposed to the other company I called in who talked through every step explaining what they were doing or could do and attempted a few different approaches to try and fix it, all in the same amount of time that your workmen were on the property.

And to be left still without a functioning toilet and a \$101.25 bill to follow felt like a rip off. I appreciate that they came and made an attempt of sorts but I feel I did not get value for my money that's for sure, which is why I have not paid the bill and await your response to this letter.
