1 These covenants shall:

- (a) run with Lots 36 and 56 on Deposited Plan 495706 ("Servient Tenement"); and
- (b) be for the benefit of and appurtenant to each of the Computer Freehold Registers for Lots 33 to 71 (inclusive) on Deposited Plan 495706 ("Dominant Tenement"); and
- (c) all expire on 1 January 2026 and be void for all purposes including prior breach.

2 Interpretation:

2.1 For the purposes of these covenants:

- (a) "Entrance Feature" means the entrance feature constructed by Horncastle Homes Limited on the Entrance Strip;
- (b) "Entrance Strip" means the strips of land shown as marked I on Lot 36 Deposited Plan 495706 and marked J on Lot 56 Deposited Plan 495706;
- (c) "Land" means any lot having the burden and/or benefit of these land covenants as described in clause 1 above;
- (d) "Horncastle Homes" means Horncastle Homes Limited;
- (e) "Subdivision" means all of the residential lots on Deposited Plan 495706.

3 Entrance Feature

3.1 Without receiving the prior written approval of the Grantee, the Grantor shall not alter the design, exterior coating/finish, colour or structure of the Entrance Feature as constructed on the Entrance Strip.

3.2 The Grantor shall also be responsible for the cleaning and maintenance of the particular Entrance Feature situated on the Grantor's land. The maintenance required shall be to a reasonable standard taking into account:

- (a) "fair wear and tear";
- (b) the original condition at either the time the title for the land issued or the date on which the code compliance certificate for the first dwelling erected on that property was issued by the local authority, WHICHEVER IS THE LATER; and
- (c) the standard of buildings and structures within the subdivision.

3.3 Any dispute as to whether a Grantor has complied with the requirements of clauses 3.1 and 3.2 shall be determined by Horncastle Homes or an architect nominated by Horncastle Homes.

4. Enforcement:

4.1 If there is any breach or non observance of the foregoing covenants (and without prejudice to any other liability which the Grantor may have to any other person having the benefit of these covenants) the Grantor in breach agrees to and shall at their cost:

- (a) forthwith upon receipt of a written notice being given by any Grantee (or its agent or any other party having the benefit of these covenants) to the party in breach, carry out such remedial work specified in the notice and any other work so as to remedy such breach or non performance of those covenants; and
- (b) pay the reasonable legal costs (calculated on a solicitor and own client basis) of the Grantee in taking steps to enforce these covenants if the Grantee establishes that a breach of the covenants has occurred.




