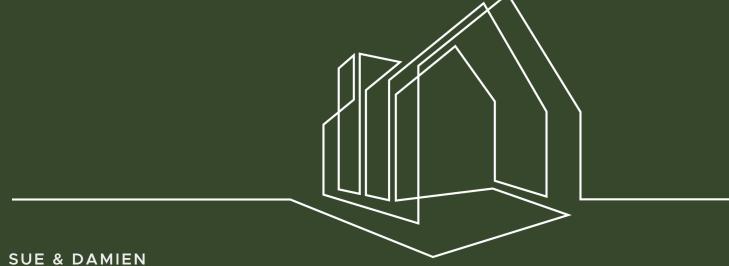

1.0 Introduction

RS Eng Ltd (RS Eng) has been engaged by DHS Construction to investigate the suitability of their client's property (Lot 5 DP 546886) for residential construction. The purpose of this report is to assess the suitability of the building site, making foundation and earthworks recommendations and detail the design of an on-site wastewater disposal system and stormwater attenuation system.

The client proposes to construct a four-bedroom terraced dwelling founded on a conventional concrete slab with masonry block retaining and a waffle raft concrete slab.

2.0 Site Description

This 2970m² property is located on the western side of Fantail Lane, approximately 300m northwest of its intersection with Clapham Road. The property encompasses a ridgeline aligned northwest to southeast. Slopes on the north-eastern side of the ridge are moderately graded (approximately 15°). Slopes falling towards the southwest are steeply graded (approximately 20° -40°) which is bounded by the Hatea River and covered in native bush. An earth fill bund is located along the crest of the steep southwestern slopes, with fill being placed on the building area from the neighbouring site. An existing driveway provides access to the proposed building platform. Groundcover for the remaining site is mown lawn.

3.0 Desk Study

3.1 Referenced/Reviewed Documents

The following documents have been referenced in this report:

- GNS Geology Of The Whangarei Area Edbrooke & Brook 2009.
- Property Consent Notice: 12045418.3.
- Soil & Rock Consultants "Geotechnical Completion Report for Residential Subdivision, 84 Sands Road, Glenbervie, Whangarei, 6 May 2020."
- Soil & Rock Consultants "Geotechnical Investigation for Proposed Residential Subdivision, 84 Sands Road, Glenbervie, 8 November 2019."

3.2 Site Geology

The GNS 1:250,000 scale New Zealand Geology Web Map shows that the property is located within an area underlain by Kerikeri Volcanics, which is described as follows: "Basalt lava, volcanic plugs and minor tuff."

3.3 Aerial Photography




Figure 2: 1969 Aerial Image, Red Marker Indicates Building Area (Source: www.retrolens.nz)

RS Eng has undertaken a review of historical aerial photography, specifically an image from 1969, refer to Figure 2 below. Due to the majority of property being covered in bush and regenerating scrub, it is difficult to observe any slope features. The construction of Fantail Lane has since been completed as part of the subdivision, as well as earthworks which have been carried out over the area and within the wetland to the north.

3.4 Subdivision Report

The underlying subdivision was reported on by Soil & Rock Consultants as referenced above. The property was divided into three areas categorised as Zone A, Zone B, And Zone C. the following relevant recommendations and statements were made.

- "We consider that sloping ground within residential lots of the subdivision is stable in the 'global' sense and suitable for residential development from that point of view, however shallow soil creep cannot be ruled out where slopes are steeper than 1V:4H."
- Residential building platforms have been formed during earthworks within 'Zone A: Residential
 Building Zone' and Zone B: Specific Design Zone'. There will be no structures within 'Zone C:
 No-Build Zone' however, some of the building platforms are in close proximity to Zone C which
 should be considered by the designer of any structure in that area.
- The soils present are considered to lie in Site Class M Moderately Reactive. Surface movements of up to 44mm should be expected and allowed for in design.
- Any proposal to excavate deeper than 600mm (exclusive of topsoil and spread/piled foundation excavations) shall be referred to a Geotechnical Engineer for advice.
- We consider that the stiff natural soils over most of 'Zone A: Residential Building Zone' provide
 a suitable founding stratum for spread footings and/or short (Senton) piles. A Dependable
 Bearing Capacity of 150kPa (Ultimate Bearing Capacity = 300kPa, Øbc = 0.5) is available for
 shallow foundations designed to NZS3604:2011 and embedded into stiff natural ground
 and/or engineered fill to the requirements of Section 5 (Expansive Soils).
- Piled foundations may be required as follows:
 - Where the structural demands are greater than that given for shallow foundations.
 - Where steep slopes (steeper than 14°) are present.
 - Where bridging of services is required.
- If piles are required, they should be of the bored type. Static design of bored piles can be carried out using the following parameters: A Design End Bearing Capacity of 450kPa (Ultimate End Bearing Capacity = 900kPa, Øpc = 0.5) is available for piled foundations embedded at least 3.0m into stiff natural ground (Structural design may require deeper embedment).
- Zone B: Specific Design Zone' is defined as areas that are generally suitable for residential development, however, require a site-and-proposal-specific geotechnical investigation, specific design of building foundations (e.g. piled foundations) and potentially also design for slope stability works (e.g. barrier pile walls, installation of buttress drainage etc) depending on the geometry and scale of earthworks proposed at the time.
- Specific design of foundations and further subsoil investigation may be required prior Building Consent application for the lots within Zone B.
- The site-specific investigation, assessment and design should be undertaken by a Chartered Professional Engineer experienced in geotechnical engineering.

Our recommendations previously reported in this regard are that the 'areal' dispersal rate of
the wastewater dispersal system should not exceed 3.0L/m2/day and that in-ground soakage
systems are not suited to either wastewater or stormwater dispersal. The dispersal should
take the form of pressure-compensated dripper lines (wastewater) or a dispersal system that
is located within the topsoil layer and designed to 'bubble-up' and disperse within the topsoil
(not soak into the underlying clayey subgrade) for both wastewater and stormwater."

The relevant Consent Notice Conditions for the property state the following.

- "The location and foundation of any building shall be certified by a suitably experienced Chartered Professional Engineer prior to issue of any Building Consent, noting the location of instability areas on Council's Geographical Information Systems maps.
- At the time of building consent provide suitable evidence/design to illustrate that stormwater attenuation will be provided for all impervious surfaces to ensure compliance with Chapter 4, and more specifically Section 4.1.1 of Council's Environmental Engineering Standards 2010, to the satisfaction of the Development Engineering Officer.
- On Lots 1-8 a maintenance contract for the on-site wastewater system shall be in place at all times which includes inspections and maintenance of both the wastewater treatment and disposal systems.
- At the time of building consent, provide suitable evidence to illustrate that stormwater disposal across any boundaries will not exceed that which existed pre-development for storm events up to and including the 1% annual exceedance probability (+20% to accommodate for climate change)."

3.5 Natural Hazard

The Whangarei District Council has designated this property as being within a zone of low and high instability hazards. The proposed dwelling is located within both of these zones. The following is a definition of the Low Instability Hazard Zone:

"Erosion or landslide morphology is not apparent. Not considered to be at risk of instability. May, however, be at risk as a result of natural events, or development. Steeper slopes may be subject to soil creep."

The following is a definition of the High Instability Hazard Zone:

"This land appears to be either subject to erosion or slippage, or is likely to be subject to erosion or slippage within the next 100 years based on geomorphic evidence. This land is generally considered to be geotechnically unsuitable for development, unless works can be undertaken to avoid, remedy or mitigate the hazard."

4.0 Field Investigation

Technicians from this office visited the property on 9 February 2022 to undertake a walkover inspection and two hand augered boreholes. The walkover inspection observed a bund of fill placed above the steep slopes to the west of the building area. A pile of fill from the neighbouring excavations was also placed at the building area. Small localised features of shallow seated instability (approximately 1.0m deep) were evident approximately 60m northwest of the proposed dwelling on the southwestern facing slope within the native bush where slopes become steep, likely due to erosion.

The hand augers were dug to a maximum depth of 4.0m. Geotechnics Shear Vane readings were taken at regular intervals throughout the hand augers. See Appendix A for hand auger test locations and results.

5.0 Subsoil Conditions

Interpretation of subsurface conditions are based on the investigations shown on the drawings in Appendix A. The conditions are summarised below.

- Topsoil was recorded at depths of up to 200mm.
- Residual soils were encountered to a maximum depth of 2.0m, consisting of clayey SILT, being very stiff, moist and having low plasticity. In-Situ Undrained Shear Strengths range between 94kPa to greater than 200kPa.
- Completely weathered basalt was encountered to a depth between 2.0m 4.0m, consisting
 of clayey SILT, being very stiff, moist and having low plasticity. In-Situ Undrained Shear
 Strengths range between 117kPa and 143kPa.
- Groundwater was not recorded during investigations and is considered unlikely within 5.0m of the ground surface given the underlying geology and surrounding topography.

6.0 Geotechnical Assessment

6.1 Slope Stability

The common mechanism of slope failure on this terrain is a shallow seated translation failure, generally caused by uncontrolled stormwater eroding the toe support of the slope, or improper development. The walkover inspection observed an existing fill bund placed on the edge of the steep western slope. This can lead to surcharge loading of the slope, and as such, RS Eng recommend the existing fill be removed.

Localised shallow seated slope instability (approximately 1.0m deep) was observed during the walkover inspection on the steep southwestern facing slope (>35°) approximately 60m northwest building site. The Kerikeri Volcanic soils on this terrain is generally considered stable at slopes up to 30°.

The building plans show a small portion of the garage area located within Hazard Zone C: No Build Zone as per the subdivision report. As this area does match the steep slopes indicated using NRC LiDAR contours, it is likely this zone has been interpreted from the WDC Hazard maps.

RS Eng completed a cross section through this area and steep southwestern facing slope, adopting a conservative 20° regression line from the base of the Hatea River. This indicated approximately 2.0m of material which could be subject to potential instability. It is recommended that a soldier pile wall is installed adjacent to the garage and drive designed to provide 2.0m of retaining below existing ground level. See attached drawings in Appendix A for soldier pile wall location.

Ground slopes at the building area are in the vicinity of 13° - 15°. As per the subdivision report recommendations, foundations on slopes steeper than 14° require specific design to account for shallow soil creep.

Provided the recommendations of this report and complied with, RS Eng considers the building works to be at a low risk of slope instability.

6.2 Liquefaction

Considering the proposal is positioned on land underlain by the Kerikeri Volcanic Group, and is elevated approximately 57 meters above sea level (OTP Datum), RS Eng considers the risk of liquefaction to be low.

6.3 Expansive Soils

The clayey soils encountered on-site are likely to be subject to volumetric change with seasonal changes in moisture content (wet winters / dry summers); this is known as expansive or reactive soils. Apart from seasonal changes in moisture content other factors that can influence soil moisture content at the include:

- Influence of garden watering and site drainage.
- The presence of large trees close to buildings. Large trees can cause variation in the soil moisture content for a distance of up to 1.5 times their mature height.
- Initial soil moisture conditions during construction, especially during summer and more so during a drought. Building platforms that have dried out after initial excavation should be thoroughly wet prior to any floor slabs being poured.
- Plumbing leaks.

Based on the recommendations of the subdivision report by Soil & Rock Consultants who completed specific laboratory testing at the subdivision stage, RS Eng concur with the Class M – 'Moderately Reactive' soil classification as per AS 2870 and B1/AS1 of the NZ Building Code.

6.4 Shallow Soil Creep

Seasonal changes in moisture content of clayey soils cause shrink/swell effects (expansive soils). On slopes generally in excess of 14° the seasonal shrink/swell characteristics and gravity cause the surface soil to slowly move downslope. This can be accelerated and exaggerated by stock. Soil creep can affect shallower slope angles underlain by weaker materials, but may not affect steeper slopes when soil strengths are high.

Shallow creep was not evident on the moderate slopes at the building site, however the slopes have recently been filled and re-contoured, meaning the visual features that typically indicate soil creep may not have had time to become apparent over the ground surface. As per recommendations on the subdivision report, soil creep cannot be ruled out where slopes are steeper than 1V:4H (14°). RS Eng therefore recommend foundations on slopes exceeding 14° be designed to account for 1.0m of horizontal forces associated with soil creep.

7.0 On-site Wastewater Disposal

7.1 Site Evaluation

The land available for effluent disposal is moderately sloped (less than 15°) and linear convergent. Subsoil investigation have assessed the soil as Category 4 as per AS/NZS1547. Water supply is via two rainwater storage tanks, and it is proposed to use standard water reduction fixtures across the dwelling. We recommend the use of a secondary treatment system loading sub surface pressure considering the slopes available exceed 10°.

7.2 Design

The proposed dwelling has four bedrooms. The design calculations are presented in Table 1 below.

7.3 Northland Regional Council Discharge Compliance

Table 2 below demonstrates compliance with the Northland Regional Council's New Regional Plan.

As the disposal field is located on slopes steeper than 10°, as per the Northland Regional Council's (NRC) New Regional Plan, a 10m vegetated buffer zone is required downslope of the disposal field. RS Eng has been advised by the NRC that the buffer zone is to be included as part of the disposal field, and thus must also comply with the surface water setbacks and other relevant rules. Due to the placement of the dwelling and driveway on the property, proposed earthworks and no building zone outlined in the subdivision report, a buffer zone of only 6.0m was achieved. Additionally, the buffer zone does not comply with the 5.0m setback from the roadside drain, however the effluent disposal field and reserve area comply with this requirement. Accordingly, a Resource Consent from the Northland Regional Council will be required.

7.4 Assessment of Environmental Effects

As mentioned above, due to the limited space available for wastewater disposal, a 10m buffer zone downslope of the lowest irrigation to comply with the NRC New Regional Plan surface water setback rules is not achievable. Resource Consent will be required from the Northland Regional Council.

The disposal field is to be planted, and an irrigation loading rate of 3.0mm/day has been adopted in system design. The drip line will be trenched a minimum of 50mm – 100mm into the topsoil and covered with bark or mulch. A 5.0m vegetated buffer zone will be implemented below the irrigation lines. Stormwater control over the disposal field will be managed by a retaining wall located up slope acting as a stormwater cut-off drain. Stormwater from impervious surfaces will be collected and directed to a dish drain on the driveway which is proposed to feed the roadside drain. Accordingly, the risk of surface water breakout or contamination from the disposal field is considered to be low.

Based on the above assessment of environmental effects, RS Eng consider the risk of environmental effects beyond the property boundary as a result of the proposed wastewater discharge to be no more than minor.

8.0 Stormwater Assessment

8.1 Attenuation

Considering the recommendations in the Consent Notice, stormwater attenuation is required. The new dwelling is proposed to have a roof and new drive area of $304m^2$ and $189m^2$, respectively. Impervious surfaces allow little or no infiltration of stormwater into the ground causing a greater volume of rainfall runoff. To maintain pre-development stormwater flows from the property stormwater attenuation is required. This minimises any potential adverse effects on downstream properties and/or council services.

The Whangarei District Council (WDC) Environmental Engineering Standards (EES) requires attenuation of stormwater runoff from any increase in impervious areas so that post development peak flows are less than 80% of pre-development. The WDC EES specifies that the flows be attenuated for the 20% and 1% Annual Exceedance Probability (AEP) events.

It is proposed to direct stormwater runoff from the roof of the new dwelling into two rainwater storage tanks with restricted outlets which reduce the peak flows to predevelopment levels. The attenuation tank restricts stormwater runoff from the roof sufficiently to compensate for the increased flows from the paved area.

The pre-development and post-development runoff was modelled using HydroCAD. The United States Department of Agriculture Technical Release 55 (TR55) Type 1A method was adopted for calculating the run-off flow, using rainfall depths from HIRDS 4 (High Intensity Rainfall Design System, NIWA) including an addition 20% for climate change as required by WDC EES. The subsoils have been assessed as clayey silts, designated as Group C soils with fair grass cover, from WDC EES. Table 3 includes a summary of the stormwater attenuation modelling.

The WDC EES Section 4.12.3 states that when stormwater is being re-used (i.e. water supply from rainwater tanks) then a reduction in attenuation volume is allowed. Table 4.4 of the WDC EES specifies a 50% reduction in attenuation for 304m² using two 25,000L water tanks. Included below is the calculation of storage adjustment to account for this in HydroCAD.

9.0 Engineering Recommendations

9.1 Site Subsoil Class

In accordance with NZS 1170.5:2004, Section 3.12.3 the site has been assessed for its Site Subsoil Class. Based on the observation listed above RS Eng considers the site soils lie within Site Class C "Shallow Soil Site."

9.2 Earthworks

To form a level access to and create a building platform for the proposed dwelling, earthworks are proposed. To suitably develop the building area, we recommend as follows:

- Cuts and fills shall be limited to a maximum depth of 3.0m and 2.0m respectively without further geotechnical assessment.
- Cuts exceeding a depth of 1.0m shall be retained by a wall specifically designed by a Chartered Professional Engineer without further geotechnical assessment.
- No fill shall be placed within 10.0m of the crest of the steep western facing slopes.
- All fills shall be retained by a wall specifically designed by a Chartered Professional Engineer without further geotechnical assessment.
- Cut batters not supported by a wall should be sloped at angles less than 1V to 3H (18°).
- Any retaining wall shall be specifically designed by a Chartered Professional Engineer to account for at least 1.0m of shallow soil creep below existing ground level, using the assessed parameters detailed in Table 4 below.
- The soldier pile wall west of the dwelling shall be specifically designed by a Chartered Professional Engineer to account for at least 2.0m of shallow soil creep below existing ground level, using the assessed parameters detailed in Table 4 below.
- Site works shall generally be completed in accordance with NZS4431.

9.3 Shallow Foundations

It is proposed to construct a timber framed type dwelling founded on masonry block wall with conventional concrete slab and a waffle raft concrete slab. To suitably found the proposed dwelling RS Eng recommend the following.

• All leading-edge foundations (including deck foundations) on slopes exceeding 14°shall be specifically designed by a Chartered Professional Engineer to resist the lateral soil forces associated with at least 1.0m of shallow soil creep below existing ground level.

The following recommendations have been made for foundations that do not require specific design for shallow soil creep:

- The waffle raft slab shall be specifically designed for Class M soil and be placed on a minimum of 150mm compacted granular hardfill extending 1.0m beyond the building envelope.
- Isolated standard NZS3604 type foundations shall extend to a minimum depth of 0.5m below cleared ground level to account for moderately expansive soils.
- Conventional concrete slab foundations in accordance with NZS3604 and NZS4229 will be suitable provided they extended to a minimum depth of 0.5m below clear ground level to account for moderately expansive soils.

Notwithstanding the recommendations of this report, for specific design of shallow foundations RS Eng has assessed the following:

- 300kPa Ultimate Bearing Capacity (Geotechnical Ultimate).
- 150kPa Dependable Bearing Capacity (Ultimate Limit State).
- 100kPa Allowable Bearing Capacity (Serviceability Limit State).

9.4 Soldier Pile & Timber Pole Retaining Walls

Soldier pile and retaining walls shall be specifically designed by a suitably experienced Chartered Professional Engineer familiar with the contents of this report, using the assessed soil parameters presented in Table 4. Where retaining walls are located adjacent to buildings and boundaries effects of deformation should be considered.

9.5 Masonry Retaining Walls

Masonry retaining walls shall be specifically designed by a suitably experienced Chartered Professional Engineer familiar with the contents of this report, using the assessed soil parameters presented in Table 5. Where retaining walls are incorporated in buildings or located adjacent to buildings and boundaries effects of deformation should be considered.

For specific design of masonry retaining wall foundations, RS Eng has assessed the following:

- 300kPa Ultimate Bearing Capacity (Geotechnical Ultimate).
- 150kPa Dependable Bearing Capacity (Ultimate Limit State).
- 100kPa Allowable Bearing Capacity (Serviceability Limit State.

9.6 Stormwater Disposal

Uncontrolled and concentrated stormwater discharges can result in erosion and slope instability. RS Eng recommends that stormwater overflow from the attenuation tanks be directed to a dish drain installed in the driveway, which shall be directed to the roadside drain east of the proposed dwelling. The driveway shall also be shaped to direct water to the dish drain.

10.0 Drawing Review

It is recommended that RS Eng Ltd carry out a review of final development drawings prior to submittal for building consent and / or resource consent. The review is to confirm that the recommendations outlined in this report have been applied in full and correctly to the design.

11.0 Construction Monitoring and Producer Statements

RS Eng recommend a suitably experienced Chartered Professional Engineer monitor the construction of the following works:

- Foundation excavations to confirm foundations extend into suitable ground.
- Testing of compacted hardfill to confirm compliance with NZS4431.
- Soldier pile / retaining wall foundations to confirm foundations extend into suitable ground.

Any works not inspected will be excluded from future producer statements (PS4) to be issued by RS Eng. In any event, where doubt exists regarding inspections, this office should be contacted for advice, and provided with reasonable notice of inspections.

12.0 Conclusions

It is the conclusion of RS Eng Ltd that the building area is suitable for the proposal provided the recommendations and limitations stated within this report are adhered to.

On-site Wastewater Disposal Details

Irrigation Field Installation Details

- Use a system producing secondary treated effluent.
- Use 249m (minimum) of Sub Surface Pressure Compensating Drip irrigation line, with Arkal filters, flushing and air release valves fitted.
- Irrigation line is to be laid in a 50-100mm (minimum) trench (sub surface) or covered in mulch surface).
- Irrigation line is to be laid with the contour.
- Disposal Field to be Planted.
- System to be installed and maintained as per manufacturer's recommendations including regular de-sludging of the primary treatment tank.
- Disposal area to be protected from stock and vehicles.
- Refer to "How to look after your septic tank" (published by the Northland Regional Council) when protecting the disposal area.
- The system will require the use of water reduction fixtures, i.e. dual flush 6/3 litre water closets, shower-flow restrictors, aerator tap fittings and water conserving automatic washing machines.

Irrigation Line Specification

- Distribution is to be via drip irrigation line with self-compensating pressure drip emitters.
- Install an Arkal disc filter at the outlet of the treatment system. Install pressure checkpoints
 on either side of the filter to allow for gauges to check for blockages. Install pressure
 checkpoints at the end of each lateral.
- Install either manual or automatic flushing valves at the end of each lateral. Install air release valves in the high points of the irrigation field.
- Allow 5m head loss from semi-blocked filter and ensure 12m of end pressure for the lowest emitter in the field.
- Ensure there is laminar flow through all lines in the field. Ensure flushing velocity is greater than 0.5m/s.
- Use drip irrigation line with 1.0m dripper spacing and 1.0m spacing between lateral.
