### Continuation of "Estate or interest to be transferred, or easement(s) or profits à prendre to be created"

The Transferor transfers the land in the above Certificate of Title to the Transferee and the Transferee hereby covenants and agrees with the Transferor as follows:

1. In this Transfer the following words have the following meanings:

"Agreement" means the Agreement for Sale and Purchase between the Transferor and the Transferee for the sale and purchase of the land described in the Certificate of Title.

"Certificate of Title" means the certificate of title for the land that is transferred by this Transfer.

"Head Title" means certificate of title 99999 (Wellington Registry).

"Further Subdivision Area" has the same meaning as in the Agreement for Sale and Purchase.

2. The Transferee hereby covenants and undertakes that the Transferor may, in its name or by any Director or officer of the Transferor, undertake in the name of the Transferee all or any of the following:

(a) Remove any restrictive or land covenant that may be registered against the Certificate of Title, the Head Title or any title arising from or forming part of the Further Subdivision Area;

(b) Create any new restrictive or land covenant in respect of the areas referred to in (a) above whether in addition to or in replacement or substitution of existing restrictive or land covenants; and

(c) Consent on behalf of the Transferee to any plan of subdivision of the Further Subdivision Area.

3. The Transferee further covenants with the Transferor that should the Transferee sell transfer or assign its interest in the land described in the Certificate of Title, the Transferee shall obtain from the Transferee, transferee or assignee an appropriate Deed (to be prepared by the Solicitors for the Transferor) whereby the transferee or assignee covenants to:

(a) Grant to the Transferor a Power of Attorney in the same form as that given by the Transferee to the Transferor pursuant to the Agreement for Sale and Purchase; and

(b) Comply with the provisions of clause 23.0 and 31.0 of the Agreement for Sale and Purchase; and

(c) Not sell or transfer, assign or otherwise dispose of the land described in the Certificate of Title without first obtaining the execution by the transferee or assignee of a similar Deed and Power of Attorney in favour of the Transferor in terms of this clause.

This Transfer is for the benefit of the land of the Transferor shown as Lot 1 Deposited Plan 335661 being the land described in Certificate of Title 146085 (Wellington Registry) but these covenants are not to be noted on that Title.
