





### Continuation of "Estate or Interest or Easement to be created"

1. The Transferor as registered proprietor transfers the land in Certificates of Title 53D/994, 53D/995, 53D/996, 53D/997, 53D/998, 53D/999, 53D/1000, 54A/1, 54A/2, 54A/3, 54A/4 (Wellington Registry) (collectively, the "Land") to itself, the Transferee and the Transferee covenants with itself, the Transferor and the Transferor's executors, administrators and assigns that the registered proprietor or proprietors for the time being of the Land will at all times observe and perform all of the covenants and obligations contained in the First Schedule to the intent that all of the Land shall:
  - (a) be subject to the burden of the restrictive covenants contained in the First Schedule for the benefit over or in respect of all other lots; and
  - (b) have the benefit of the restrictive covenants contained in the First Schedule over or in respect of all other lots.
2. The Transferee shall, as regards the stipulations and restrictions set out in the First Schedule, be liable only in respect of breaches of them which occur while the Transferee is the registered proprietor of the Land or any part of it in respect of which any breach occurs.

### FIRST SCHEDULE

1. The registered proprietor or registered proprietors for the time being of the Land will not permit, or bring onto or let remain on the Land any unregistered or unwanted motor vehicles or any rubbish or debris.
2. The Land will be kept in such good tidy and visually pleasing condition as would normally be expected in a high quality rural residential subdivision.
3. The registered proprietor or registered proprietors for the time being of the Land will not use the Land, or any part of it, or any dwelling or building erected on the Land as a "place of assembly" as defined in the Proposed Kapiti Coast District Plan dated 22 December 1997.
