"THAT IN EXERCISE OF THE POWERS CONFERRED ON IT BY SECTION 186 OF THE MUNICIPAL CORPORATIONS ACT 1954 THE WHANGAREI BOROUGH COUNCIL HEREBY RESOLVES BY WAY OF SPECIAL ORDER TO PERMIT THE LAYING OFF OF A STREET DESCRIBED IN THE SCHEDULE HERETO AT A WIDTH FOR THE WHOLE OF ITS LENGTH OF LESS THAN 66 FEET BUT NOT LESS THAN 50 FEET SUBJECT TO THE CONDITION THAT NO BUILDING SHALL AT ANY TIME BE ERECTED ON ANY SECTION FRONTING THE PROPOSED STREET (REFERRED TO IN THE SCHEDULE HERETO) WITHIN A DISTANCE OF EIGHT FEET FROM THE SIDE LINE OF THE SAID STREET."


