




Declaration

1. I confirm that I am the legal owner of the trees/s described in the agreement or that I am authorised to act on the tree's

owner's behalf. I also confirm that I am the legal owner of the Property or that I am authorised to act on the property owner's behalf in granting access to the Property.

2. I acknowledge that Northpower has provided me with an information sheet explaining my obligations and responsibilities as a tree owner as outlined in the Electricity (Hazards from Trees) Regulation 2003.
3. I acknowledge that Northpower has advised me of the:
 - o Risk trees present to the safety of people, property and to Northpower's power line;
 - o safety issue associated with cutting and trimming trees around power lines, and
 - o Legal requirements of cutting trees near power lines and the circumstances that require electrically qualified tree workers to carry out the work.
4. I accept my responsibility for the future maintenance of my trees and agree to keep them out of the Notice Zone (explained in the information sheet) at my expense.
5. I acknowledge that if I fail to adequately maintain my trees I am liable for the resulting cost of repairing any damage to power lines and other property.
6. I consent to Northpower and its contractors (including any vehicles or necessary equipment) entering the Property to undertake the tree maintenance work specified above and I agree to pay the costs (if any) specified above for those works.
7. I agree to immediately notify Northpower if I or the legal owner of the tree/s or Property intend to sell or transfer ownership of the tree/s or the Property to another person before the Specified Tree Work has been completed. I also agree to make any potential purchaser or transferee aware of this agreement as soon as possible.
8. I agree to reimburse Northpower, its employees, contractors and agents for any claims, costs, losses or damage of any kind which they suffer or incur in connection with a breach by me of this agreement including but not limited to giving a false or misleading statement or representation under clause 1 above.
