
Easement Instrument

1. The Registered Proprietor shall not erect or permit to be erected upon the subject land:
- (a) any dwelling with an internal floor area of less than 100m<sup>2</sup> excluding any garaging or outbuildings unless approved by Glennie Architects Limited;
  - (b) any pre-used dwelling;
  - (c) any dwelling building structure or fence constructed of pre-used materials (excluding bricks);
  - (d) any front yard boundary fence exceeding a height of 1.2 metres;
  - (e) any dwelling building or structure with an external wall cladding of hardiplank or other cladding of similar composition or construction provided however Linea board or products of similar composition shall not be a breach of this covenant;
  - (f) any building, dwelling or structure of a radically unconventional design. The opinion of Glennie Architects Limited shall prevail in the event of any dispute;
  - (g) any dwelling, building or structure that exceeds the height of 5 metres above the natural ground level of the lot at the point of construction;
  - (h) any building dwelling or structure that is not of a recessive colours to the intent that any such colours shall blend harmoniously with the natural features and environment of the area;
  - (i) any outbuildings other than such as are tidy, neat and designed and built to a high standard commensurate with the general standards of the subdivision.
  - (j) any building or structure to be erected on the lot under a building consent that permits temporary occupation of such building or structure nor shall the registered proprietor permit any caravan to be kept on the lot for temporary or permanent occupation;
  - (k) any more than one household unit;
  - (l) any dwelling or building of more than one storey;
  - (m) any dwelling, building or structure that has not been completed within 12 months of the starting of foundations (for the purposes of this clause completed shall mean the completion of exterior decoration and the issuing of a final code of compliance for building works);
  - (n) any garage that is not attached to the dwelling and fully enclosed and completed in materials similar to those of the dwelling;
  - (o) any dwelling, building or structure closer than 1 metre to any boundary;
  - (p) any garden shed that is visible from the street frontage to the intent that any such shed shall either be located behind the dwelling and/or garage or satisfactorily screened;
  - (q) any roof or wall cladding that has not been pre-coated or pre-coloured;
  - (r) any dwelling, building or structure without having first submitted copies of plans and specifications Glennie Architects Limited or its Nominee and obtaining written confirmation from the said Company or Nominee that the



- (s) proposed structure complies with these restrictions, with such submission to be made prior to submitting such plans and specifications to Council for building consent, provided however such confirmation shall not be unreasonably withheld.
2. The Registered Proprietor acknowledges that the above restrictions shall last for 15 years from the date of the deposit of the plan creating title and the below restrictions shall last forever.
3. The Registered Proprietors shall not permit the following:
- a. Subdivision of the land in such a way as to create an additional lot. The purposes of this clause "subdivision of the land" shall have the same meaning as is set out in Section 218 of the Resource Management Act 1991.
  - b. The parking or storage of commercial vehicles, motor homes, boats, storage containers or similar items which are visible from the street frontage.
  - c. Unless permitted by the proviso to this clause use nor permit the use of the property for other than private residential purposes to the intent that such property shall not be used for institutional residential purposes or as a hostel, lodge, boarding house, day care centre, group living accommodation or for purposes associated with the sex industry. For the purposes of this clause "institutional residential purposes" shall include the use of the property for housing purposes by central or local government agencies or public or private health sector or educational agencies. This clause however shall not prevent the property being used for home based employment by the occupier provided such use has been consented to by Council and further provided that this exemption does not relate to use related to the sex industry.
4. The Servient owner acknowledges that they are responsible for any damage caused to any roadway, road reserve, crossing, footpath, right of way, common area or the remaining land on the subdivision by them or their contractors, particularly during periods of construction and/or landscaping when heavy machinery and vehicles are in use. Any damage caused shall be repaired immediately. The Registered Proprietor Servient Owner indemnify the Dominant Owners for any costs, claims or actions in respect of all such damage.



