

Pursuant to section 60 of the Transit New Zealand Act 1989, the Transit New Zealand Authority hereby gives notice that it varies the notice declaring public highways to be State Highways published in the *Gazette*, 24 March 1960, No. 20, page 384, by deleting from the Schedule the paragraphs described in the First Schedule hereto and substitute therefore the paragraphs set out in the Second Schedule hereto.

**First Schedule**

Paragraphs deleted from North Island section Parts I and II of the Schedule of the said notice. Part I "No. 57 State Highway (Levin-Palmerston North via Shannon)—commencing in Levin and proceeding thence to Palmerston North via Shannon, Tokomaru and Linton."

**Part II Levin**

No. 57 State Highway. From the intersection of Oxford Street and Queen Street, along Queen Street to Bartholomew Road junction at the eastern boundary of Levin Borough."

**Second Schedule**

Part I, No. 57 State Highway (Levin-Palmerston North via Shannon). Commencing at the junction of Kimberley Road and S.H. 1 south of Levin and proceeding along Kimberley Road, Arapaepae Road and thence to Palmerston North via Shannon, Tokomaru and Linton.

Part II Levin, No. 57 State Highway from the intersection of Arapaepae Road and Tararua Road northwards along Arapaepae Road to its intersection with Queen Street.

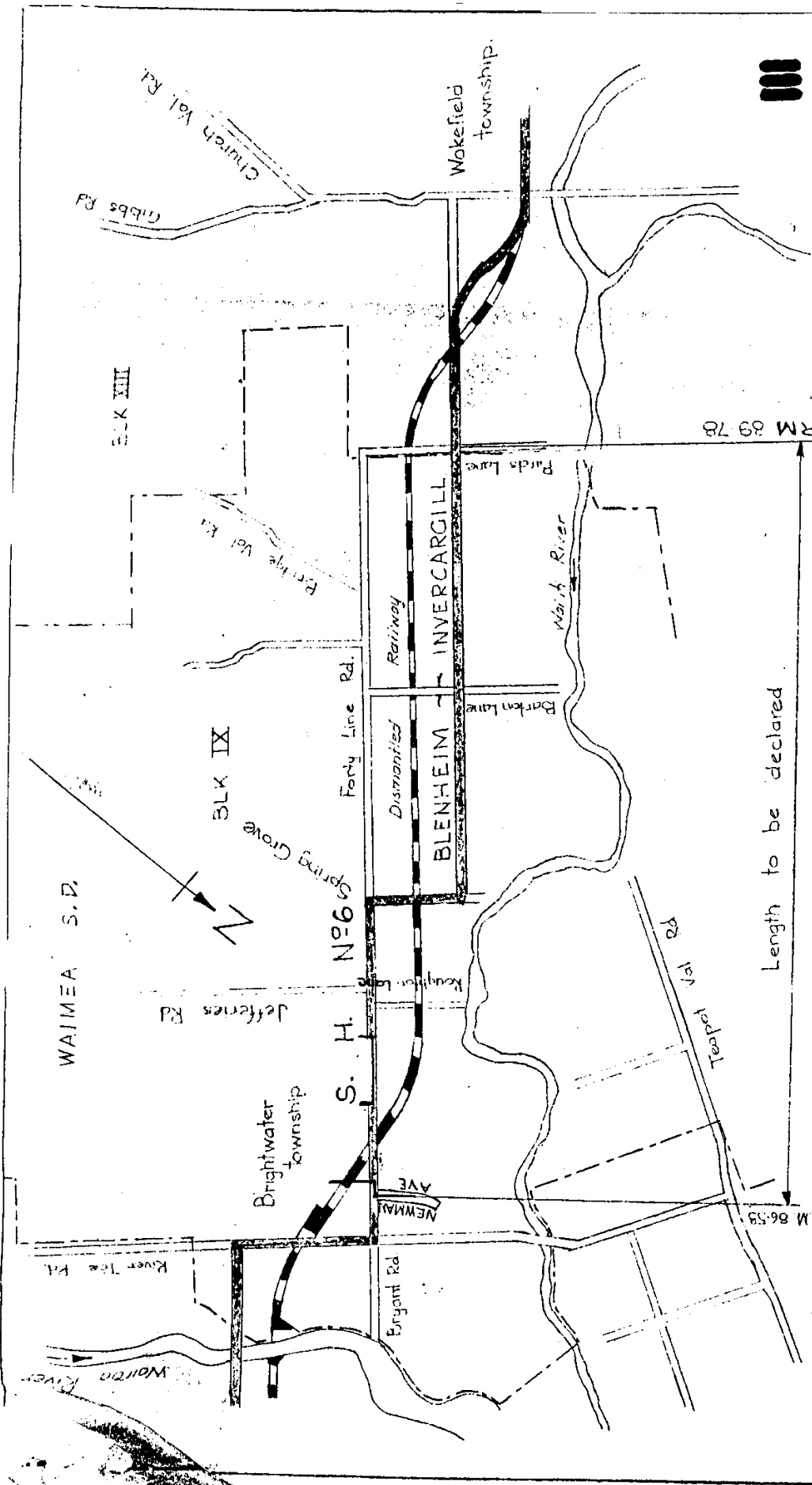
**Second Schedule**
