This certificate does not include information about:

- orders made against the body corporate by an adjudicator, a tribunal or a court;
- matters raised at recent committee meetings or body corporate meetings; or
- the lawful use of lots, including whether a lot can be used for short-term letting.

Search applicable planning laws, instruments and documents to find out what your lot can be used for. If you are considering short-term letting your lot, contact your solicitor, the relevant local government or other planning authority to find out about any approvals you will need or if there are any restrictions on short-term letting. ### Becoming an owner

When you become an owner of a lot in a community titles scheme, you:

- automatically become a member of the body corporate and have the right to participate in decisions about the scheme;
- must pay contributions towards the body corporate's expenses in managing the scheme; and
- must comply with the body corporate by-laws.

You must tell the body corporate that you have become the owner of a lot in the scheme within 1 month of settlement. You can do this by using the BCCM Form 8 Information for body corporate roll. Fines may apply if you do not comply.

### How to get more information

You can inspect the body corporate records which will provide important information about matters not included in this certificate. To inspect the body corporate records, you can contact the person responsible for keeping body corporate records (see below), or you can engage the services of a search agent. Fees will apply.

Planning and development documents can be obtained from the relevant local government or other planning authority. Some relevant documents, such as the development approval, may be available from the body corporate, depending on when and how the body corporate was established.

### Building management statement

A building management statement is a document, which can be put in place in certain buildings, that sets out how property and shared facilities are accessed, maintained and paid for by lots in the building. It is an agreement between lot owners in the building that usually provides for supply of utility services, access, support and shelter, and insurance arrangements. A lot can be constituted by a community titles scheme's land.

## By-laws and exclusive use areas

The body corporate may make by-laws (rules) about the use of common property and lots included in the community titles scheme. You must comply with the by-laws for the scheme. By-laws can regulate a wide range of matters, including noise, the appearance of lots, carrying out work on lots (including renovations), parking, requirements for body corporate approval to keep pets, and whether smoking is permitted on outdoor areas of lots and the common property. However, by-laws cannot regulate the type of residential use of lots that may lawfully be used for residential purposes. You should read the by-laws before signing a contract.

### What by-laws apply?

The by-laws that apply to the scheme are specified in the community management statement for the scheme provided to you by the seller.

The community management statement will usually list the by-laws for the scheme. If the statement does not list any by-laws, Schedule 4 of the Body Corporate and Community Management Act 1997 will apply to the scheme.

In some older schemes, the community management statement may state that the by-laws as at 13 July 2000 apply. In these cases, a document listing the by-laws in consolidated form must be given with this certificate.

## Lot entitlements and financial information

### Lot entitlements

Lot entitlements are used to determine the proportion of body corporate expenses each lot owner is responsible for. The community management statement contains two schedules of lot entitlements – a contribution schedule of lot entitlements and an interest schedule of lot entitlements, outlining the entitlements for each lot in the scheme. The contribution schedule lot entitlement for a lot (as a proportion of the total for all lots) is used to calculate the lot owner’s contribution to most body corporate expenses, and the interest schedule lot entitlement for a lot (as a proportion of the total for all lots) is used to calculate the lot owner’s contribution to insurance expenses in some cases. Lots may have different lot entitlements and therefore may pay different contributions to the body corporate’s expenses.

### Common property and assets

When you buy a lot in a community titles scheme, you also own a share in the common property and assets for the scheme. Common property can include driveways, lifts and stairwells, and shared facilities. Assets can include gym equipment and pool furniture.

The body corporate is usually responsible for maintaining common property in a good and structurally sound condition. An owner is usually responsible for maintaining common property or assets that their lot has been allocated exclusive use of, or for maintaining improvements to common property or utility infrastructure that is only for the benefit of their lot. The body corporate may have additional maintenance responsibilities, depending on the plan of subdivision the scheme is registered under. If there is not enough money in the sinking fund at the time maintenance is needed, lot owners will usually have to pay additional contributions.

## Contracts and authorisations

A body corporate may engage service contractors to provide services to the body corporate to assist in the management of the scheme.

If the Standard Module, Accommodation Module, or Commercial Module apply to a community titles scheme, the body corporate may also authorise a person to conduct a letting agent business for the scheme, that is, to act as the agent of owners of lots in the scheme who choose to use the person's services for the letting of their lot.

A service contractor who is also authorised to be a letting agent for the scheme is called a caretaking service contractor. Together, an agreement to engage a person as a caretaking service contractor and authorise a person as a letting agent is typically referred to as 'management rights'.

The maximum term of a service contract or authorisation entered into by a body corporate is:

- 10 years if the Standard Module applies to the scheme; and
- 25 years if the Accommodation Module or Commercial Module applies to the scheme.

You may inspect the body corporate records to find information about any engagements or authorisations entered into by the body corporate, including the term of an engagement or authorisation and, for an engagement, duties required to be performed and remuneration payable by the body corporate.

1. The contribution schedule principle under section 46(7) of the Body Corporate and Community Management Act 1997 (BCCM Act) on which the contribution schedule lot entitlements for the community titles scheme has been decided is the relativity principle.
2. The relativity principle referred to in paragraph 1 above the principle that the lot entitlements must clearly demonstrate the relationship between the lots in the community titles scheme by reference to one or more particular relevant factors.
3. Section 46A(3) of the BCCM Act states that a relevant factor (as referred to in paragraph 2 above) may, and may only, be any of the following:
  - a. how the community titles scheme is structured;
  - b. the nature, features and characteristics of the lots;
  - c. the purposes for which the lots are used;
  - d. the impact the lots may have on the costs of maintaining the common property;
  - e. the market values of the lots.
4. Individual contribution schedule lot entitlements for the community titles scheme were decided by reference to the following factors:
  - a. The nature, features and characteristics of the lots in the community titles scheme;
  - b. The purposes for which the lots in the community titles scheme are used; and
  - c. The impact the lots in the community titles scheme may have on the costs of maintaining the common property within the community titles scheme,and, in having reference to these factors, it is considered just and equitable for there to be a variation, ranging from a minimum of 867 to a maximum of 981, in the contribution schedule lot entitlements for the community titles scheme.
5. After having decided to use the relativity principle and by reference to the factors referred to in paragraph 4 above, the individual contribution lot entitlements for the community titles scheme were decided on the basis that certain features or characteristics of lots in the community titles scheme impact on the costs to the body corporate of repairing, maintaining, capital replacement and cleaning the common property, for example:
  - a. a lot which has a greater external surface area will have a higher contribution schedule lot entitlement than a lot which has a smaller external surface area because there is a higher cost of repairing,

maintaining, replacing and cleaning that part of the common property surrounding the lot with the greater external surface area; and

- b. the greater the floor area of a lot, the greater the prospective demand on the common property to protect, support, service and generally benefit the lot with corresponding greater cost to the body corporate in the provision of and in the repair, maintenance, capital replacement and, as applicable, cleaning of the common property provided to the lot.

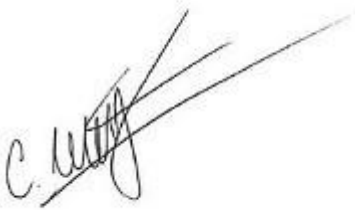

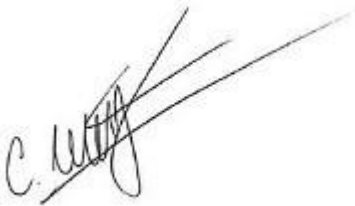

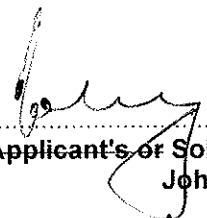

#### PRINCIPLES FOR DECIDING THE CONTRIBUTION LOT ENTITLEMENT FOR A LOT

1. The contribution schedule principle under section 46(7) of the *Body Corporate and Community Management Act 1997* (BCCM Act) on which the contribution schedule lot entitlements for the community titles scheme has been decided is the relativity principle.
2. The relativity principle referred to in paragraph 1 above is the principle that the lot entitlements must clearly demonstrate the relationship between the lots in the community titles scheme by reference to one or more particular relevant factors.
3. Section 46A(3) of the BCCM Act states that a relevant factor (as referred to in paragraph 2 above) may and may only be any of the following:
  - a. how the community titles scheme is structured;
  - b. the nature, features and characteristics of the lots;
  - c. the purposes for which the lots are used;
  - d. the impact the lots may have on the costs of maintaining the common property;
  - e. the market values of the lots.
4. Individual contribution schedule lot entitlements for the community titles scheme were decided by reference to the following factors:
  - a. the nature, features and characteristics of the lots in the community titles scheme;
  - b. the purposes for which the lots in the community titles scheme are used; and
  - c. the impact the lots in the community titles scheme may have on the costs of maintaining the common property within the community titles scheme,

and, in having reference to the following factors, it is considered just and equitable for there to be a variation, ranging from a minimum of 867 to a maximum of 981, in the contribution schedule lot entitlements for the community titles scheme.

5. After having decided to use the relativity principle and by reference to the factors referred to in paragraph 4 above, the individual contribution lot entitlements for the community titles scheme were decided on the basis that certain features or characteristics of lots in the community titles scheme impact on the costs to the body corporate of repairing, maintaining, capital replacement and cleaning the common property, for example:
  - a. a lot which has a greater external surface area will have a higher contribution schedule lot entitlement than a lot which has a smaller external surface area because there is a higher cost of repairing, maintaining, replacing and cleaning that part of the common property surrounding the lot with the greater external surface area; and
  - b. the greater the floor area of a lot, the greater the prospective demand on the common property to protect, support, service and generally benefit the lot with corresponding greater cost to the body corporate in the provision of and in the repair, maintenance, capital replacement and, as applicable, cleaning of the common property provided to the lot.

#### **PRINCIPLES FOR DECIDING THE INTEREST LOT ENTITLEMENT FOR A LOT**

The interest schedule lot entitlements for lots in the community titles scheme reflect the respective market values of the lots and are calculated using the market value principle.

**1. Interpretation****1.1 Definitions**

Words and phrases defined in the Body Corporate and Community Management Act 1997 have the same meaning in this document unless the context indicates otherwise.

In these by-laws the following terms have these meanings unless the contrary intention appears:

**Act** means the Body Corporate and Community Management Act 1997 and includes all regulations made under it.

**Air Conditioning Central Plant** means the air conditioning plant and equipment installed in the Building that provides cooling and heating for the Building.

**Air Conditioning Management System** means the air conditioning management system installed in the Building that measures the individual use the Air Conditioning Central Plant for each lot in the Building including, without limitation, air conditioning plant and equipment and associated software systems.

**BMS** means any BMS registered over the Scheme land or a part of it.

**BMS Areas** means any shared access areas referred to in the BMS.

**Building** means the building containing the lots in the Scheme and includes, where the context permits or requires, any other buildings or improvements on or within the Scheme land.

**Body Corporate** means the body corporate for the Scheme.

**Common Property** means the common property for the Scheme.

**Dining Terrace** means the dining terrace on the south-east corner of level 3 of the Building.

**Invitee** means any person on the scheme land with the permission of an Occupier.

**Key** means any device used to operate a lock to a door in the Scheme.

**Lot** means a lot in the Scheme.

**Manager's Lot** means Lot 100 on SP241590.

**Occupier** means an owner of a lot, a tenant of a lot, a licensee of a lot, or any person resident in a lot.

**Planning Scheme** means the planning scheme that includes the Scheme land.

**Scheme** means the community titles scheme for which this is the community management statement.

A reference to "you", or "your" means every person who is bound by these by-laws, other than the Body Corporate.

**1.2 Interpretation**

In these by laws:

- (a) the singular includes the plural and vice versa and words importing a gender include other genders; and
- (b) other grammatical forms of defined words or expressions have corresponding meanings; and

- (c) "person" includes a firm, a body corporate, an unincorporated association or an authority; and
- (d) a reference to:
  - (i) a document includes any variation or replacement of it and all schedules, annexures and exhibits to the document; and
  - (ii) a law includes regulations and other instruments under it and amendments or replacements of any of them; and
  - (iii) a thing includes the whole and each part of it; and
  - (iv) a group of persons includes all of them collectively, any two or more of them collectively and each of them individually; and
- (e) "including" when introducing a list of items does not limit the meaning of the words to which the list relates to those items or to items of a similar kind.

### **1.3 Obligations and rights extend to exclusive use areas**

Obligations, restrictions and rights in these by-laws:

- (a) relating to Lots also apply to exclusive use areas except as expressly stated in these by-laws; and
- (b) relating to Common Property do not apply to exclusive use areas except as expressly stated in these by-laws.

Provisions of the Act relating to Common Property continue to apply to exclusive use areas except to the extent they are lawfully modified in these by-laws.

## **2. General Rules**

### **2.1 Use of Lots**

- (a) The Manager's Lot may be used as a building manager's office, for letting or sale of Lots and for other purposes allowed by law.
- (b) Lots may only be used as residences and for ancillary purposes allowed from time to time under the Planning Scheme. However, Lots must not at any time be used for sex work.

### **2.2 Noise**

You must not make or allow any noise in a Lot or on the Common Property or in any BMS Area that would unreasonably interfere with the enjoyment by others of a Lot or the Common Property. If noise is unavoidable then it must be reasonably minimised.

### **2.3 No obstruction of other lawful use**

You must not obstruct the lawful use of the Common Property or in any BMS Area by other people.

### **2.4 Rubbish on the common property**

You must not throw or leave rubbish on the Common Property or in any BMS Area except in bins provide by the Body Corporate and you must promptly clean up any mess you make on the Common Property or in any BMS Area.

### **2.5 Children must be supervised**

Children under seven years of age must be supervised by a responsible person over 15 years of age while on the Common Property.

## 2.6 External appearances of Lots

You must not (without the prior written consent of the Body Corporate) paint, affix or display any sign, advertisement, notice, poster, placard, banner, pamphlet or similar article or hang and washing, towels, clothing, bedding or other articles so that they are visible from outside your Lot or your exclusive use area, other than washing hung on a clothes line of the type and in the location applicable on the creation of the Scheme.

## 2.7 Smoking

You must not smoke in any part of the Common Property.

## 2.8 Compliance with Laws and BMSs

- (a) You must not store or use flammable materials in your Lot or the Common Property, unless you have written consent from the Body Corporate. However, you may keep reasonable quantities of things that are normally kept in a home.
- (b) You must not have or use a gas barbecue, pizza oven or any form of cooking appliance that requires a flame on your balcony.
- (c) You must not do anything that may breach any laws about fire safety or that might reasonably be expected to increase fire insurance premiums for the Scheme.

## 2.9 Fire risks and fire insurance

- (a) You must not store or use flammable materials in your Lot or the Common Property, unless you have written consent from the Body Corporate. However, you may keep reasonable quantities of things that are normally kept in a home.
- (b) You must not have or use a gas barbecue, pizza oven or any form of cooking appliance that requires a flame on your balcony.
- (c) You must not do anything that may breach any laws about fire safety or that might reasonably be expected to increase fire insurance premiums for the Scheme.

## 2.10 Fire Alarms

- (a) You must ensure that you do not cause a false fire alarm.
- (b) You will be responsible for all costs of the Body Corporate incurred as a result of causing any fire alarm to be set off, including all call out charges of the Fire Brigade.

## 2.11 Skateboards etc

Skateboards, roller blades, bicycles, go-carts and similar things must not be ridden on the Common Property.

## 2.12 Pets

- (a) With the exception of a pet that is a guide, hearing or assistance dog (that you have a right to have in your Lot and on the Common Property under section 181 of the Act), you must not without the Body Corporate's written approval:
  - (i) bring or keep an animal in your Lot or the Common Property; or.
  - (ii) permit an invitee to your Lot to bring or keep an animal in your Lot or the Common Property.
- (b) If you are given approval under this by-law, you must:
  - (i) ensure that the animal is not a nuisance, if it is a dog then being a nuisance includes barking and being aggressive;

- (ii) not allow the animal to wander on the Common Property and it must be carried, in an appropriate pet cage, or be on a leash when outside your Lot;
  - (iii) not allow it to go to the toilet on the Common Property;
  - (iv) ensure that if your animal urinates or defecates on Common Property then you must immediately clean up any mess;
  - (v) ensure that the animal does not create foul odours or pest problems in your Lot;
  - (vi) ensure that all dogs and cats wear identification tags;
  - (vii) ensure that no animals enter the pool, BBQ or other recreational areas on the Common Property;
- (c) If you fail to comply with the conditions in by-law 2.12(b), the committee of the Body Corporate may at your cost remove the animal from the Scheme.
- (d) Animals that are not pets are not permitted within the Scheme.

### **2.13 Post Box Clearance**

You must regularly clear your post box.

### **2.14 Use of plumbing etc.**

The plumbing, gas and electrical equipment and systems in your Lot must not be used for any purpose for which they were not designed. You must turn off the hot and cold water supply and gas supply to your Lot if your Lot will be unoccupied for more than a month. If you do not comply with this by-law, you agree that a representative of the Body Corporate may enter your Lot and turn off any cold water supply and gas supply to your Lot.

### **2.15 Damage and interference with equipment**

- (a) You must not damage any part of the Common Property or any Body Corporate assets, including lawns, gardens and furniture owned by the Body Corporate.
- (b) You must not interfere with any plant and equipment in the Common Property or in the BMS Areas.

### **2.16 Deliveries with trade access**

- (a) All tradespeople must enter and leave the Building through the car park.
- (b) All deliveries of furniture or large goods must be through the loading dock. The ground floor foyer must not be used for this purpose without the prior consent of the Body Corporate.
- (c) The Body Corporate will manage access to the loading docks and lifts in the Building and you must not use a loading dock or lift unless that has been booked with the Body Corporate.

### **2.17 Air conditioning Residual Current Device**

The switching off of a Residual Current Device circuit breaker installed in a Lot and being part of the Air Conditioning Plant will affect not just the air conditioning for that Lot but for the air conditioning for the entire floor where that Lot is located. Doing so is also a breach of section 166 of the Act for which a penalty of 100 penalty units applies. You must not switch off such a Residual Current Device circuit breaker without the prior written consent of the Committee.

### 3. Pool, Dining Terrace and other Facilities

#### 3.1 Rules for use

- (a) The following rules apply to the pool, Dining Terrace and the barbecue areas on the Common Property:
- (i) you must accompany your Invitees when they are using these facilities; and
  - (ii) you must not use the pool or the barbecue areas between 9.00 p.m. and 6.00 a.m.; and
  - (iii) you must not take any glass into the pool area or fitness room;
  - (iv) children under the age of twelve (12) must be accompanied by an adult;
  - (v) when you have finished using a barbecue area you must clean the barbecue plate and the tables and chairs and remove all of your rubbish; and
  - (vi) you must clean and remove all rubbish from the Dining Terrace after using it; and
  - (vii) The Body Corporate may close these facilities when necessary for maintenance or other work.
- (b) If you fail to clean the barbecue area or Dining Terrace as set out in by-law 3.1(a), the Body Corporate may clean the areas and recover the cost of doing so from you.
- (c) The following rules apply to the fitness room:
- (i) the fitness room is limited to people 16 years and over in all circumstances;
  - (ii) the fitness room is a quiet area and must only be used for exercise between the hours of 6.00 a.m. and 9.00 p.m.;
  - (iii) no alcoholic drinks are allowed in the fitness room;
  - (iv) you must sit or lie on a towel when using the gym equipment and wipe off the equipment after you use it, and you must wear closed-in shoes, a shirt and pants at all times;
  - (v) you must only use the equipment in the way and for the purposes for which it is designed and intended;
  - (vi) you must not move equipment unless moving it is a normal expectation for its use;
  - (vii) when you finish using equipment you must:
    - A put it back, if it has been moved;
    - B turn it off unless another person is waiting to use it;
  - (viii) you must not alter any equipment or change or change settings other than as a necessarily required for the proper use of the equipment;
  - (ix) you must not try to repair equipment if it is broken or not functioning; and
  - (x) you must not remove any equipment from the fitness room except with the specific authority of the Body Corporate.

### 3.2 Booking facilities

- (a) The Body Corporate may operate a booking system for the barbecue areas and the Dining Terrace. If there is a booking system, the Body Corporate:
- (i) may set time-periods to allow reasonable use of those facilities; and
  - (ii) may set a maximum advance period during which bookings will be taken; and
  - (iii) may set a maximum number of bookings that can be taken from the occupiers of a Lot in a particular period (for example, no more than 3 bookings a month), but this must not be used to prevent people using a facility when it will otherwise be unoccupied; and
  - (iv) may appoint someone (such as a resident caretaker) to manage the bookings; and
  - (v) must take reasonable steps to ensure that all occupiers are able to have fair and reasonable access to the facilities; and
  - (vi) may ban a person from making bookings for up to three months if, more than twice in 30 days, the person makes a booking and does not use it or cancel it more than 24 hours in advance.
- (b) The Body Corporate may keep the Dining Terrace locked when not being used and in that event must ensure that residents are able to obtain the keys to use it when they have a booking or they are otherwise unoccupied.
- (c) If a booking system applies to a facility then you may not use that facility unless you have a booking or there is no booking for the time you are using it.

## 4. Security

### 4.1 Locking your doors and windows

- (a) Windows and external doors in Lots must be locked when nobody is in the Lot.
- (b) You must not alter the security locking device installed on the entry door to your lot or install any deadbolt locks, security screens, other similar locking devices on your entry door to your Lot without Body Corporate approval (which will not be granted if the installation of any such device will compromise compliance by the Body Corporate or you with any relevant law including, without limitation, fire safety laws).

### 4.2 Body corporate to control building security

The Body Corporate must provide a security Key and access control system (security system) regulating access to and within the Scheme. This security system may restrict your access to floors of the Building that only contain other Lots. The security system may include the keeping of a master Key for the Scheme which enables entry into Lots. The Body Corporate may give a copy of any such master Key to any manager, caretaker or letting agent for the Building.

### 4.3 Security system

- (a) Under the security system, the Keys and access controls provided for individual Lots will allow access to:
- (i) the Building; and
  - (ii) the floor containing your Lot;
  - (iii) the car park; and
  - (iv) some facilities in the Common Property.

- (b) The following rules apply to the security system:
- (i) the Body Corporate must supply Keys to each owner of a Lot; and
  - (ii) the Body Corporate need not supply you with additional or replacement Keys unless you pay the costs of those Keys; and
  - (iii) if you lose a Key you must notify the Body Corporate as soon as possible; and
  - (iv) the Body Corporate must cancel Keys that are reasonably believed to be lost; and
  - (v) you must comply with the security system, including closing doors and gates; and
  - (vi) you must not do anything that may affect the operation of the security system; and
  - (vii) you must advise the Body Corporate of the name of any occupant or other person (other than a lot owner or immediate members of a lot owner's family) to whom you propose to provide a Key; and
  - (viii) the Body Corporate may cancel Keys that it reasonably believes are being held or used by persons who should have been but were not notified to the Body Corporate under by-law 4.3(b)(vii); and
  - (ix) you must keep Keys in a secure, non-public area at all times when Keys are not with you personally.
- (c) The Body Corporate may also provide Keys and access controls to its employees and contractors. The access given to employees and contractors must be limited to the needs of their jobs.

## **5. Cleaning, maintenance, alterations, etc**

### **5.1 Cleaning and maintenance for Lots**

- (a) You must keep your Lot:
- (i) clean and remove rubbish at least weekly; and
  - (ii) maintained in good condition and you must repair any problems with internal plumbing and wiring.
- (b) Your cleaning obligation applies to any exclusive use area for your Lot, unless the relevant exclusive use by-law says that the Body Corporate is responsible for cleaning the area.
- (c) You must maintain your Lot in good condition. You must maintain the plant and equipment, wiring and plumbing that is in your Lot or that exclusively serves your Lot so that the plant and equipment is safe and operates properly. You must comply with the manufacturer's recommendations about periodic maintenance and servicing for the air conditioner for your Lot (if any). This by-law does not oblige you to maintain plant and equipment, wiring and plumbing that, under the Act, is the responsibility of the Body Corporate.

### **5.2 Plants and gardens**

If you have plants on your balcony or a garden in your Lot then you must keep them in good condition. Any dead plants must be removed. If you have a garden then you must keep it reasonably free of weeds. This by-law also applies to any exclusive use area you have that includes a garden or lawn.

### **5.3 Pest Control**

You must keep your Lot free of pests (including termites) to the extent you reasonably can. You must treat the Lot for pests in accordance with treatment schedules specified by the Body Corporate from time to time and give the Body Corporate evidence that you have complied with this obligation. The Body Corporate may elect to have pest treatments for the common property or for the whole of the Scheme Land.

#### **5.4 Alterations and improvements to Common Property**

- (a) You must not:
- (i) alter the Common Property or Body Corporate property; or
  - (ii) install equipment or machinery of any type on the Common Property,
- unless you have written approval from the Body Corporate.
- (b) The Body Corporate must not unreasonably refuse this approval and may specify acceptable external window and balcony coverings, locks and security bars that can be installed without specific approval.

#### **5.5 Notice of damage**

You must promptly notify the Body Corporate of any damage found to any water or gas pipes, electrical or service cables and other fixtures which comprise part of the Common Property.

#### **5.6 Floors and ceilings**

You must not change flooring and ceiling materials without consent from the Body Corporate. That consent must not be unreasonably refused if your proposed change will not result in additional noise travelling to other Lots.

#### **5.7 Other alterations to Lots**

- (a) You must not alter your Lot, including by enclosing balconies and terraces with shutters, glazing, louvres or similar permanent fixtures, in a way that is contrary to a requirement of the Planning Scheme or a development approval for the Scheme.
- (b) The external appearance of window coverings, like blinds and curtains in your Lot, must be approved by the Body Corporate. The Body Corporate may set standards, such as the colour of curtain linings. If a standard is set then it may be used without further reference to the Body Corporate.
- (c) You must not make alterations to the exterior of your Lot without the prior written consent of the Body Corporate.
- (d) You must not remove or weaken a load-bearing wall in your Lot without the approval of the Body Corporate, which must not be unreasonably refused, but may be given subject to conditions.
- (e) You must not install, replace or otherwise alter any air conditioning plant or equipment in your Lot without the approval of the Body Corporate, which will not be unreasonably refused if the Body Corporate are satisfied that the air conditioning plant and equipment is compatible with the Air Conditioning Management System or the Air Conditioning Central Plant. The Body Corporate may request that you obtain a certificate from the manufacturer of the Air Conditioning Central Plant certifying that the new or altered air conditioning plant or equipment is compatible with the Air Conditioning Management System and the Air Conditioning Central Plant.

#### **5.8 Requirements about works**

If you make alterations to, or install things on, the Common Property or your Lot then you must:

- (a) comply with conditions imposed by the Body Corporate when approval was given for the work (this does not mean all alterations to your Lot must be approved by the Body Corporate); and
- (b) first obtain any approvals required by-law for the work and give copies of those approvals to the Body Corporate; and
- (c) ensure that the work is done properly by appropriately skilled and qualified tradespeople; and
- (d) complete the work as soon as reasonably possible after you start; and
- (e) clean up any mess and fix any damage caused by the work; and

- (f) keep the alterations or things installed in good condition at all times.

## **6. Rubbish and rubbish bins**

- (a) You must put your household rubbish only in the chutes and bins provided in the Building for that rubbish and you must comply with Body Corporate directions about:
  - (i) bags and wrapping for rubbish;
  - (ii) where to put glass and recyclable rubbish.
- (b) Other rubbish bins on the Common Property are only for general rubbish created while on the Common Property and not for household rubbish.
- (c) You must comply with Brisbane City Council requirements about the material that is put into the recycling bins.

## **7. Management**

### **7.1 Plant room security**

The Body Corporate must keep the following areas of the Common Property locked:

- (a) electrical substations or control panels; and
- (b) fire service control panels; and
- (c) rooms containing telecommunication and data exchanges or hubs; and
- (d) plant and machinery rooms,

unless doing so would be contrary to a law. You must not enter or open these areas unless you have written approval from the Body Corporate.

### **7.2 Store rooms for the Body Corporate**

The Body Corporate may use appropriate parts of the Common Property to store equipment used for gardening, cleaning and maintenance. These storage areas may be locked and you must not enter them without consent from the Body Corporate.

### **7.3 Letting service**

The only person who may provide a letting service from any part of the Scheme land is a person who has a letting authority from the Body Corporate and is the owner or occupier of the Manager's Lot.

## **8. Supply of services to Lots**

### **8.1 Services to which this by-law applies**

This by-law applies to the supply of any of the following services in the Scheme to Lots:

- (a) hot water from a central hot water system;
- (b) gas for the air conditioning system in Lots;
- (c) town water;
- (d) any form of energy;
- (e) any data, television or telecommunications service.

In this by-law these are called the **Utility Services**.

## 8.2 Engagement for supply

Under the Act, the Body Corporate may engage a person to supply Utility Services for the benefit of Lots and Common Property. If the Body Corporate engages a person to supply a Utility Service to Lots then you must not take the Utility Service from the relevant supply system unless:

- (a) if the supply of that Utility Service to your Lot is able to be metered, connected to Air Conditioning Central Plant and Air Conditioning Management System and there is a functioning supply meter to measure the supply to your Lot; and
- (b) there is a current agreement with the relevant contractor for the supply of the Utility Service to your Lot.

## 8.3 Supply of Utility Services by Body Corporate requires agreement

- (a) By-law 8.3(b) applies where:
  - (i) the Body Corporate is the supplier of a Utility Service to Lots; and
  - (ii) the Body Corporate is required or entitled to charge for the supply of that Utility Service to the Lots.
- (b) The Body Corporate must not supply the Utility Service to your Lot, and you must not take the Utility Service from the relevant supply system, unless:
  - (i) if the supply of that Utility Service to your Lot is able to be metered, there is a functioning supply meter to measure the supply to your Lot; and
  - (ii) there is a current agreement with the Body Corporate for the supply of the Utility Service to your Lot (**Supply Agreement**) and the Body Corporate has not suspended the supply to your Lot.

## 8.4 Requirements for Supply Agreements

A Supply Agreement with the Body Corporate:

- (a) must comply with any requirements of the law; and
- (b) must oblige the owner or occupier of the Lot to pay the Body Corporate for the supply of the Utility Service during billing periods determined by the Body Corporate committee (which must be the same for each Lot); and
- (c) must provide that the amount payable for a Utility Service supplied to a Lot is to be the aggregate of:
  - (i) the fees and costs that the Body Corporate incurs in respect of the Utility Service specifically for the supply to the Lot, such as a fee paid to a contractor for meter reading, or a fee paid to a body corporate manager for billing services;
  - (ii) the cost of the quantity of the Utility Service supplied to the Lot; and
  - (iii) to the extent reasonable possible, the balance of the cost to the Body Corporate of the relevant Utility Service, divided between the Lots and Common Property in proportion to the metered supply to each Lot in the billing period; and
- (d) may include arrangements to secure payments to the Body Corporate, including any of the following:
  - (i) a system for the pre-payment of the service using meters that will cut off the supply when the amount prepaid is used up (which may also include emergency reserve provisions);
  - (ii) payment of a security deposit determined from time to time by the Body Corporate committee (which must be calculated on the same basis for each Lot);

- (e) entitle the Body Corporate to cut off the supply of the Utility Service to a Lot if the owner or occupier of the Lot does not pay an account within the payment period specified by the Body Corporate committee (which must be the same for each Lot).

## 8.5 Entitlement to Supply Agreement

- (a) The Body Corporate may refuse to enter into a Supply Agreement for a Lot with a person who is not the owner of the Lot. The Body Corporate need not apply this rule consistently and may apply this rule as the Body Corporate considers necessary to minimise the risk of bad debts.
- (b) The Body Corporate must not refuse to enter into a Supply Agreement with you if:
  - (i) you are the owner of the Lot; and
  - (ii) you have paid any required security deposit or supply prepayment; and
  - (iii) you are not in arrears for the previous supply of a Utility Service and by-law 8.6 does not apply to you.

## 8.6 Restrictions about arrears

The Body Corporate may only require you to pay arrears incurred with respect to your Lot under a Supply Agreement with another person (**Defaulting Party**) if:

- (a) the arrears were incurred while you own the Lot (whether by your tenant or another person living in the Lot); or
- (b) you become the owner of the Lot as trustee, executor or beneficiary of the estate of the Defaulting Party or of a person to whom paragraph 8.6(a) would apply; or
- (c) you own the Lot because of a transfer relating to a family or defacto law matter between you and the Defaulting Party or between you and a person to whom paragraph 8.6(a) would apply.

This by-law does not give the Body Corporate the power to claim these arrears from you. However, the Body Corporate may make the payment of these arrears a condition of entering into a Supply Agreement with you.

## 8.7 No interference

You must not in any circumstances interfere with a Utility Service meter for your Lot or any of the plant and equipment under which a Utility Service is supplied to your Lot or any part of the Air Conditioning Management System, other than to carry out maintenance that:

- (a) is your responsibility; and
- (b) has been approved in writing by the Body Corporate and is carried out by a tradesperson approved by the Body Corporate.

This by-law does not apply to pipes within your Lot that only service your Lot.

## 9. Parking and driving

### 9.1 Bicycles

- (a) Bicycles must be kept in a bicycle storage area in the Common Property or an exclusive use area for your Lot.
- (b) The Body Corporate may create a secure bicycle store to which by-law 4 will apply.

## **9.2 Exclusive use bicycle store**

The Manager's Lot has the exclusive use of the bicycle storage area identified on the allocation table in Schedule E for the occupier use for providing a secure bicycle storage service for the occupiers of other Lots by agreement with them. This is an exclusive use by-law that attaches to the Manager's Lot.

## **9.3 Driving and parking**

- (a) You may only drive on the parts of the Common Property designed for that purpose. The maximum speed limit is 10 kilometres per hour.
- (b) Car parks identified by the Body Corporate as visitor car parks are for the use of visitors only and must not be used by occupants of lots.
- (c) You may only park in the exclusive use car park, if any, for your Lot. Exclusive use car parks may be used only for cars and similar vehicles up to 2.5 tonne gross vehicle mass.

## **10. Exclusive use car parks**

### **10.1 Rights attach to Lots**

The rights given in this by-law attach to the relevant Lots.

### **10.2 Specified rights of exclusive use**

The Lots set out in Schedule E have the exclusive use of the car parks marked on the attached plans respectively identified in Schedule E.

### **10.3 Car park exclusive use allocations**

The original owner for the Scheme is authorised to allocate to Lots the exclusive use of car parks that are shown on the exclusive use car parking plan and have not been allocated to a Lot. To make allocations under this by-law, the original owner must give the Body Corporate:

- (a) a written notice that states the Lots for which exclusive use car parks are to be allocated and the car parks to be respectively allocated for the exclusive use of those Lots; and
- (b) written consent to the allocations from the registered owner(s) of the relevant Lots.

The original owner can make allocations under this by-law any number of times.

### **10.4 Reallocations and recording allocations and reallocations**

- (a) Lot owners may agree to reallocate exclusive use car parks in the way allowed under the Act.
- (b) The Body Corporate must take all steps required to formalise authorised allocations and agreed reallocations of exclusive use car parks. The Lot owners who agree a reallocation are responsible for registering the new community management statement required to record the reallocation (unless the new statement will include other changes) and must pay the registration fees and the Body Corporate's costs of the preparation of the new statement.

### **10.5 Other matters about exclusive use car parks**

- (a) Exclusive use car parks may only be used for parking: bicycles, registered cars, registered utility vehicles, registered motorcycles, boats on registered trailers, registered box trailers and registered four wheel drive vehicles.
- (b) A bicycle, vehicle or trailer must not be parked in a car park unless all parts of the vehicle or trailer are within the exclusive use area.

- (c) You must not carry out any maintenance or repair work or external cleaning on a bicycle, vehicle or trailer while it is in an exclusive use car park. However, emergency repairs are permitted to the extent they are required to make a vehicle or trailer mobile.
- (d) The Body Corporate is entitled to pass through an exclusive use car park where necessary to obtain access to a part of the Common Property. This right also applies to a service contractor or letting agent who requires access to Common Property, including an occupation authority area.

## **10.6 Storage cages**

You may not install a storage cage within your exclusive use car park without prior written consent from the Body Corporate.

## **10.7 Cleaning and maintenance**

The Body Corporate is responsible for cleaning, maintaining and repairing the exclusive use car parks, other than:

- (a) cleaning or repair required because of a breach of this by-law 10 by the owner or occupier of the relevant Lot; and
- (b) the removal of grease and oil stains and spills.

As far as reasonably possible without damaging the car park surface, you must keep your exclusive use car park free of grease and oil stains and spills. If you do not comply with your obligations under this by-law 10, a representative of the Body Corporate may do so at your cost.

## **11. Storage spaces**

### **11.1 Rights attach to Lots**

The rights given in this by-law attach to the relevant Lots.

### **11.2 Specified rights of exclusive use**

The owners of the Lots set out in Schedule E have the exclusive use of the storage spaces marked on the attached plans respectively identified in Schedule E.

### **11.3 Original owner allocations**

The original owner for the Scheme is authorised to allocate to Lots the exclusive use of storage spaces. To make allocations under this by-law, the original owner must give the Body Corporate:

- (a) an exclusive use plan that identifies the storage spaces for which exclusive use is to be allocated; and
- (b) a written notice that states the Lots for which exclusive use storage spaces are to be allocated and the storage spaces to be respectively allocated for the exclusive use of those Lots; and
- (c) written consent to the allocations from the registered owner(s) of the relevant Lots.

The original owner can make allocations under this by-law any number of times.

### **11.4 Reallocations**

- (a) Lot owners may agree to reallocate exclusive use storage spaces in the way allowed under the Act.
- (b) The Body Corporate must take all steps required to formalise the authorised allocations and agreed reallocations of exclusive use storage spaces.

## **11.5 Maintenance**

The Lot owners with exclusive use rights are responsible for cleaning and maintaining their exclusive use storage spaces. To be clear, by-laws about, fire systems and services, cleaning, pest control and rubbish removal for Lots also apply to the exclusive use storage spaces. The Body Corporate is responsible for structural maintenance of the exclusive use storage spaces.

## **11.6 Alterations require Body Corporate's approval**

Lot owners may not make improvements or alterations to exclusive use storage areas, without the Body Corporate's written approval. Alterations may be permitted in the instance of privacy, of an agreed colour, style and to a height that does not interfere with the sprinkler system.

## **Access through storage spaces to Common Property**

The Common Property is authorised to pass through an exclusive use storage space when necessary to obtain access to Common Property. If utility infrastructure is behind an exclusive use storage space then the owner and occupier of the relevant Lot must ensure that the Body Corporate has a key for the storage space if necessary to obtain access to that utility infrastructure.

## **12. Exclusive use area**

### **12.1 Special rights**

The owner of lot 100 has the exclusive use of the area M1 identified in the allocation table for the following purposes:

- (a) installing and operating vending machines or otherwise selling goods to and providing services for occupants of the Building;
- (b) installing and operating information displays and signs, reading materials, internet and communications facilities

and associated furnishings and equipment.

The occupier of the Manager's Lot may use the general power outlets and communications connections in this exclusive use area when exercising these rights.

The rights given in this by-law attach to the Manager's Lot.

### **12.2 Cleaning and maintenance**

The Body Corporate is responsible for cleaning, maintaining and repairing the exclusive area, other than repair required because of damage caused by the occupier of the Manager's Lot.

## **13. Other matters**

### **13.1 Obligations of occupiers who are not owners of Lots**

- (a) An occupier of a Lot who is not the owner of the Lot must comply with obligations of the owner of the Lot with respect to cleaning and pest control for the Lot and exclusive use areas for the Lot.
- (b) The imposition of maintenance obligations on the owner of a Lot under these by-laws does not prevent the owner from passing that obligation onto an occupier of a Lot.
- (c) The obligation of an owner of a Lot to comply with maintenance, repair or replacement obligations in these by-laws is not affected because the owner has entered into an agreement under which another person is also obliged to comply with those obligations.
- (d) An obligation of a tenant under these by-laws is not affected even though, under the tenant's tenancy agreement or tenancy law, the landlord is required to comply with the obligation.

### 13.2 Invitees and children

You must make sure that your Invitees and children comply with these by-laws.

### 13.3 Recovery of money spent by Body Corporate

If you, or your guest, child, employee, contractor or agent, damage the Common Property or any Body Corporate asset and the Body Corporate incurs a cost fixing that damage, then you must, on demand, pay the Body Corporate the amount it spent.

### 13.4 Pay television and communications services

This by-law applies if a person wants to supply pay television or communications services to Lots. The Body Corporate may allow that person to install equipment on Common Property and to connect that equipment to the common electricity supply. The Body Corporate may enter into an agreement with the person with respect to the installation, ownership, operation, maintenance and removal of the equipment.

### 13.5 Display unit

Despite any other by-law, the original owner may use any Lot it owns as a display unit and may have signs and other sales advertising materials and displays on the common property while the original owner owns any Lot.

### 13.6 State Development, Infrastructure and Planning Mandated Conditions

- (a) The development approval for the Scheme requires that this community management statement contain the following provisions:
- (i) the Building must incorporate all elements of sustainability (P1 to P15) as per recommendations in the approved sustainability report prepared by Cundall for Citimark, titled ULDA Development Application: Sustainability 10002360 Building 6, Hercules St, Hamilton, Rev C dated 9 September 2010;
  - (ii) a suitable system of lighting must be operated from dusk to dawn within all areas where the public will be given access, including car parking areas;
  - (iii) all external lighting areas lights the Building, particularly entrances and vegetated areas but does not overspill into other buildings or the sky;
  - (iv) all external lighting is in accordance with AS4282-1997 Control of the Obtrusive Effects of Outdoor Lighting so as not to cause nuisance to nearby residents or passing motorists;
  - (v) lighting over publically accessible footpaths covered by permanent awnings to a minimum of 20 lux (horizontal plan) at footpath level;
  - (vi) the Body Corporate must provide and maintain unimpeded and safe 24-hour public access through the public plaza area linking Hercules Street with the Portside Wharf Retail Mall, and ensure that access ways are designed to cater for disable persons in accordance with "Australian Standard AS 1428.1";
  - (vii) all balconies are to remain unenclosed with no shutters, glazing, louvres or similar permanent structures; and
  - (viii) all recommendations to mitigate potential noise impacts made in the Environmental Amenity Impact Assessment report will be incorporated into the project design and during the construction and operational stages.
- (b) References in this by-law 13 to drawings, documents, clauses etc are references to those things contained in the development approval for the Scheme.

**13.7 Liquor licence application**

The Body Corporate is authorised to provide consent on behalf of each Lot owner concerning an application for a liquor licence.
