The Operative District Plan (2021) records which properties in the District have these special features and overlays located on them. This property is zoned General Residential in the Operative District Plan (2021).

This property was created via subdivision in 2020 under resource consent numbers RM190153 and RM190153A. Copies of the Decisions are provided with this LIM.

A Section 221 Consent Notice was imposed as part of this subdivision which requires certain conditions to be complied with on an on-going basis. For detail refer to the attachments provided with this LIM.

There are no known easements.

Copies of the Deposited Plan (DP 547543) and Record of Title are provided with this LIM.

It is recommended that the Record of Title is checked for any interests registered against the property such as easements or covenants.

RESOURCE CONSENT RM190153: To undertake a 17-lot residential subdivision, a local purpose reserve, new road to vest, a balance allotment associated earthworks and front yard setback encroachments that do not comply with the permitted activity standards. (Found on related property: 1494126624).

There is no record of any further resource consents for this property.

The adjacent road carriageway (Kaiwaru Place) is shown to contain some specific features on it that are recorded in the Operative District Plan (2021).

These features are:

Special Amenity Feature or Landscape - distinctive highly valued landscape or landform. SAL19 Ngarara Dunes Special Amenity Landscape (A sequence of dune ridges and intervening wetlands and dune lakelets).

High Voltage Electricity Transmission Lines - there are restrictions on any development on this property within 20 metres each side of the centre-line of the high voltage transmission lines. These restrictions mean that any addition or construction of buildings (excluding accessory buildings) or structures within that area on this property will require a resource consent. The transmission lines are subject to the Ministry for the Environment National Environmental Standard for Electricity Transmission Activities.

This standard sets out a framework of permissions and consent requirements for activities on existing electricity transmission lines, for example a network utility operator can operate, maintain and upgrade the existing lines.

More detail can be found on the Ministry for the Environment website: www.mfe.govt.nz Compliance with the New Zealand Electrical Code of Practice for Electrical Safe Distances (NZECP34:2001) is mandatory under the Electricity Act 1992.

All activities regulated by NZECP34, including buildings, structures, earthworks and the operation of mobile plant, must comply with that regulation. Activities should be checked for compliance even if they are permitted by the District Plan. Natural Hazards

A Natural hazard is defined as any atmospheric or earth or water related occurrence (including earthquake, tsunami, erosion, volcanic and geothermal activity, landslip, subsidence, sedimentation, wind, drought, fire, or flooding) the action of which adversely affects or may adversely affects human life, property, or other aspects of the environment.

If this property has been the subject of a Resource Consent or Building Consent since 1 July 2020 a geotechnical assessment may have been supplied with that application. A geotechnical report may contain advice about ground conditions at that site including liquefaction, slope stability assessment as well as commentary on ground bearing capacity. All available Building Consent geotechnical assessments are located in attached building files. Coastal Erosion and Inundation Hazards

Council holds a number of reports that assess the possibility that areas of the Kāpiti Coast District shoreline may be susceptible to current and future coastal erosion and inundation. The available information on coastal hazards that are specific to the District are available on the following link: www.kapiticoast.govt.nz/coastal-science. The science of coastal erosion and inundation continues to develop as national and international best practice changes, and new information is released. The information received by Council will therefore outline different perspectives.

Currently, information specific to the Kapiti Coast District includes:

- Council-commissioned assessments by Jacobs NZ Ltd, including coastal area-specific risk assessments, a hazard and susceptibility assessment, and the coastal hazards GIS map viewer allowing you to assess how any particular property may be affected.
- A community commissioned coastal hazard risk assessment report by Dr Willem de Lange and related predicted shoreline maps.
- Advice from the Ministry for the Environment and the Department of Conservation on coastal hazard risk identification and management of coastal risks.

Council will consider the information and its possible impact on Kāpiti properties, as part of its review of coastal provisions in the Council's Operative District Plan. On 30 January 2025 Council resolved that this work is a priority to progress.

Earthquakes

Greater Wellington Regional Council holds information on earthquake risks in the Kapiti Coast District. This information, along with associated Earthquake Risk Maps, can be found on the Greater Wellington Regional Council website www.gw.govt.nz/.

Earthquake fault traces within the Kapiti Coast are mapped in the Operative District Plan (2021). These are shown (if applicable) on the District Plan Features Map provided with this LIM and are available on our website [Operative District Plan 2021 \(kapiticoast.govt.nz\)](http://Operative District Plan 2021 (kapiticoast.govt.nz)).

Fire

Due to its climate and geographical features, the Kapiti Coast District can be susceptible to risks of fire, including wildfire. More information on this risk can be found in the [District Plan](#), while mapping of the rural wildfire fire risk across the Wellington Region on the Greater Wellington Regional Council website ([GWRC rural wildfire risk](#)).

Liquefaction

Due to its geographic location and soil typology, the Kapiti Coast District may be susceptible to liquefaction in the event of an earthquake. More information on this risk can be found in the [District Plan](#), while mapping of [combined earthquake risk](#) including liquefaction, can be found on the Greater Wellington Regional Council website.

Tsunami Evacuation Zones

Tsunami Evacuation Zone Maps have been developed by the Greater Wellington Regional Council to assist emergency preparedness by identifying the area's residents may need to evacuate in the event of a tsunami.

Each map has three evacuation zones: red, orange and yellow. The updated tsunami evacuation maps for Kapiti can be viewed at the Council's website at www.kapiticoast.govt.nz/our-district/cdem/get-prepared/tsunami-zones/.

Other Information

The adjoining road carriageway (Ngarara Road) is shown to be subject to flood hazards in the Operative District Plan (2021), and the latest Flood Hazard Maps.

The flood hazard identified on the maps provided with this LIM is based on the projected future flooding risk to the property including climate change projections.

The maps show the projected flood extent arising from the 1% AEP or 1% Annual Exceedance Probability Flood Event (that is, a flood event that has a 1% probability of occurring in any one year, often referred to as a 1 in 100-year storm), incorporating the projected 2090 climate change impacts, in conjunction with a 20-year return period high tide.

The nature of the controls imposed by the District Plan depends on where individual sites are located within the 1 in 100-year flood extent, which flood hazard map (operative or latest) is referenced in legislation or the District Plan, and which flood hazard category applies.

The adjoining road carriageway (Ngarara Road) is shown to be subject to ponding on the Operative District Plan (2021) Flood Hazard Maps, and the latest Flood Hazard Maps.

Ponding are areas where slower-moving flood waters could pond either during or after a flood event. A Ponding Area may be affected by a direct flood risk. Ponding can be associated with rivers and streams as well as the piped stormwater network. Ponding is a direct risk.

The adjoining road carriageway (Ngarara Road) is shown to be subject a stream corridor on the Operative District Plan (2021) Natural Hazard Maps, and the latest Flood Hazard Maps.

A stream corridor flood hazard is the minimum area able to contain a flood of up to a 1% AEP event magnitude and enable flood water to safely pass to the stream confluence or the sea. It includes flood and erosion prone land immediately adjacent to the stream.

The adjoining road carriageway (Ngarara Road) is shown to be subject an overflow path in the Operative District Plan (2021) Natural Hazard maps, and the latest Flood Hazard Maps.

Overflow paths generally occur in lower-lying areas on the floodplain which act as channels for flood waters. They can be natural, or artificially formed, and are often characterised by fast flowing water during a flood event. An overflow path is a direct hazard.

Site History: This site meets the Ministry for the Environment Hazardous Activity and Industry List (HAIL) classification for Category A - Chemical manufacture, application and bulk storage; Activity 8 - Livestock dip or spray race operations.

Evidence of the HAIL activity was confirmed after a Detailed Site Investigation was received from Geo & Hydro - K8 Ltd [Ref: CLMG-6-179]. The full details of the listing are in a file note held by the Greater Wellington Regional Council [Ref: CLMG-12-1347] and were confirmed as a HAIL site by a suitably qualified and experienced practitioner in accordance with NESCS (2012) requirements.

May 2020: A Remedial Action Plan (Ref: CLMG-12-1420) and Site Validation Report (Ref: CLMG-12-1419) was submitted to Greater Wellington.

As a result of the Site Validation Report, and the removal of the accessible contaminated soil, the majority of the site was reclassified to `Contamination Acceptable Managed/Remediated`. A small portion of the site under the northern pylon remains classified as `Contamination Confirmed`. A Suitably Qualified Environmental Practitioner was consulted prior to the reclassification of the site.

Stormwater discharges are via the water re-use tank(s) installed in accordance with the Council District Plan Water Demand Management Solution. Overflow from water re-use tank(s) is confined to site in soak pit. There is no record of any Council services running through the property.

Aerial Photograph

A birds-eye view in colour of the property and its surrounds.

Deposited Plan

Sometimes referred to as a 'Flats Plan' or 'Title Plan'. A Deposited Plan covers more than one lot (or property) and has a diagram showing the boundary distances and the land area. A Record of Title relates to a specific property and shows current owner and interests (such as mortgages, encumbrances and easements).

Building Information (if requested)

This includes any information Council holds about any structure that is on the lot (property), e.g. plumbing, drainage and floor plans and elevation drawings of the building and any alterations or additions to it, together with any code compliance certificates.

Services Network Map

Information on private and public stormwater and sewerage drains on the property as shown in Council's records.

Location of Health and Alcohol Licenses

This map shows the location of registered businesses in the neighbourhood that hold health and alcohol licenses.

Resource Consents

Included with this LIM are Reports and Maps of resource consents (if applicable that relate to the property) and a list of resource consents in the neighbourhood of the property that have been notified. The District Plan contains rules about different types of activities in different parts of the district. Anything not permitted by the Plan requires a resource consent. When a resource consent application is received the Council determines whether or not to notify it on the basis of the environmental effects under Section 95A-F of the Resource Management Act 1991.

Designation(s) (if applicable)

A designation is a planning technique used by Ministers of the Crown, councils and network utility operators approved as requiring authorities under section 167 of the Resource Management Act 1991. It provides for 'spot zoning' over a site, area or route in a district plan which authorises the requiring authority's work and activity on the site, area or route without the need for a land use resource consent.

District Plan

Every city and district council is required to have a District Plan under the [Resource Management Act 1991](#). The District Plan plays a big part in how Kapiti develops. The rules in the Plan determine what you can and can't do on your property without permission from Council - whether it be subdividing, renovating, building a new garage or deck, or starting a home business. This LIM includes maps which show the Zone, Precinct, or Development Area (if relevant), the Features, Overlays and the Natural Hazards that relate to the rules in the District Plan.

Latest Flood Hazards

To better understand the extent of the flood hazard risk in the District and to assist in the potential mitigation of this risk, Council has over the years undertaken a number of floodplain management investigations. This map shows the latest flood hazard information; these are not necessarily included in the Operative District Plan (2021). This information is particularly relevant if you are considering subdividing the land or constructing a building.

Prior to the issue of a certificate pursuant to section 224(c) of the Resource Management Act 1991, the consent holder shall pay Council Engineering Fees of \$628.00 plus \$314.00 per lot [total \$5,966.00 GST inclusive] for work that may be required for plan approvals, site inspections and consent compliance monitoring, plus any further monitoring charge or changes to recover the actual and reasonable costs that have been incurred to ensure compliance with the conditions attached to this consent.

Note One: Prior to the issue of any certificate pursuant to section 224(c) of the Resource Management Act 1991, the engineering fee shall be paid and the consent holder will be advised of further monitoring charge or charges as they fall due. Such further changes are to be paid prior to the issue of any certificate pursuant to section 224(c) of the Resource Management Act 1991.

Note Two: With respect to Stage 1A, only the per lot amount of \$314.00 is payable at the time 224(c) certification is applied for.

Engineering

Prior to works commencing:

13. Prior to works commencing, the consent holder shall submit copies of the plans and specifications for the engineering development for approval to the satisfaction of the Council's Development Engineer. The engineering development must be in accordance with Paragraphs 1 to 5 of Schedule 1 contained in Part 4 of the Kapiti Coast District Council's (KCDC's) Subdivision and Development Principles and Requirements: 2012 (SDPR: 2012). No works shall commence until the plans are approved by KCDC's Development Engineer.

Note: Engineering drawings shall contain sufficient detail to clearly illustrate the proposal to enable assessment of compliance with the KCDC's SDPR: 2012 and to enable accurate construction.

14. The consent holder shall advise the names and professional qualifications of any Suitably Qualified Persons required in terms of Clause B(iii) of Part 3 of the KCDC's SDPR: 2012. Suitably Qualified Persons are required for, but not necessarily limited to, the following areas:

- Civil Engineering
- Geotechnical Engineering
- Foundation Design
- Street Lighting Design
- Road Safety Audits

Note: If the Council considers any of the nominated persons are not acceptable then the consent holder shall nominate alternative persons, or the Council may require the consent holder to employ a specified Suitably Qualified Person or Persons at the consent holders cost.

15. Prior to works commencing, the consent holder or their authorised representative, shall submit a Quality Assurance Plan (QA plan) to the Council's Development Engineer for approval.
16. The consent holder shall notify Council's Development Engineer prior to commencement of the following stages of work, so that the Council's Development Engineer, or their authorised representative, are present on site to inspect certain stages of the works. These stages are as follows:
 - Commencement of works or recommencement after a substantial lapse;
 - Water reticulation connections and services prior to back fill;

- Wastewater services and construction of new manholes prior to back fill;
 - Completed earthworks and prepared subgrade (roading and footpaths);
 - Finished base course before the commencement of road sealing;
 - Roads during Benkelman Beam testing (and NDM if required);
 - Road sealing – waterproof and final seal coat;
 - Final inspection.
17. Following engineering approval for the plans submitted under condition 13 above, and prior to applying for a certificate to be issued under Section 224(c) of the Resource Management Act 1991, the consent holder shall provide three proposed road names for each road in the proposed subdivision, based on a theme, to the Development Engineer for approval. The road names shall be chosen in accordance with the Kapiti Coast District Council's Road Naming and Street Numbering Policy 2011 and "The Rural and Urban Addressing Standard" (AS/NZS4819:2011).

The road names shall be approved by Council prior to a Section 224(c) certificate being issued under the Resource Management Act 1991.

Note: It is recommended that the preferred road names be supplied to the Development Engineer within 60 working days of engineering plans being approved under condition 13. This is due to a potential lengthy process of road naming.

Construction Environmental Management Plan

18. Prior to the commencement of subdivision site works (excavation, installation of reticulated service infrastructure, construction of roading and landscaping), the consent holder shall prepare and submit to the Council's Development Engineer for approval, a Construction Environmental Management Plan (CEMP) or a series of CEMPs; to ensure the mitigation of effects and protection of the National Grid transmission lines. The CEMP must be given to Transpower NZ Ltd (at transmission.corridor@transpower.co.nz) for its certification at least 10 working days prior to being submitted to the Council.
19. The CEMP must include the following (but is not limited to):
- i. The name, experience and qualifications of the person/s nominated by the consent holder to supervise the implementation of, and adherence to, the CEMP;
 - ii. Traffic entering and exiting the site during construction;
 - iii. Earthworked material tracking onto the road network;
 - iv. Dust;
 - v. Noise and hours of construction;
 - vi. Stormwater runoff;
 - vii. Details of the contractor's liability insurance held to cover any costs, direct or indirect, associated with any damage to the BPE-HAY-A National Grid transmission lines, directly or indirectly caused by works undertaken to give effect to this consent.

- viii. Construction drawings, plans, procedures, methods and measures to demonstrate that all construction activities undertaken on the site will meet the safe distances within the New Zealand Electrical Code of Practice for Electrical Safe Distances 2001 (NZECP 34: 2001) or any subsequent revision of the code; and the recommendations within the Electrical Clearance Report, from Groundline Engineering, dated 28 August 2019 and drawings number NZ-6367-SK-01, sheets 1 & 2, revision 2, undated but stamped as approved by Transpower New Zealand Limited 20 November 2019;
- ix. Details of any areas that are “out of bounds” during construction and/or areas within which additional management measures are required, such as fencing off, entry and exit hurdles, maximum height limits, or where a safety observer may be required (a safety observer will be at the consent holder’s cost);
- x. Demonstrate how the existing transmission lines and support structures will remain accessible during and after construction activities;
- xi. Demonstrate how the effects of dust (including any other material potentially resulting from construction activities able to cause material damage beyond normal wear and tear) on the transmission lines will be managed;
- xii. Demonstrate how changes to the drainage patterns, runoff characteristics and stormwater will avoid adverse effects on the foundations of any support structure;
- xiii. Demonstrate how construction activities that could result in ground vibrations and/or ground instability will be managed to avoid causing damage to the transmission lines, including support structures;
- xiv. Details of proposed contractor training for those working near the transmission lines;
- xv. All works/activities shall be undertaken in accordance with the approved CEMP.

Contaminated Soil

20. Within 10 working days of the completion of the remedial work, a Site Validation Report (SVR) prepared by a suitably qualified person shall be submitted to Council for acceptance. The Site Validation Report shall include the following information:
 - Details how the Remedial Action Plan was implemented;
 - Indications that remedial goal were met supported by proof e.g. test results;
 - Plans showing areas of the site remediated;
 - Indications that soil was disposed of correctly; and
 - Certification that the site is suitable for the intended end use.
21. In the event that evidence is discovered of land contaminations having occurred at other locations of the site (aside from those areas identified in the Detailed Site Investigation Report of Geo & Hydro-K8 Ltd) that are a potential risk to human health, the consent holder shall undertake a detailed site investigation to further

identify the level of any potential contamination. A report detailing the findings of this investigation and the proposed remedial measures shall be submitted as an amendment to the RAP at least 15 working days prior to work commencing in any of these areas. Once accepted, work shall be carried out in accordance with the amended RAP.

Earthworks & Foundation Design

22. The consent holder shall undertake earthworks in accordance with Part 3C & Part 4 Schedule 2 of the SDPR:2012 and the requirements & intents of the report titled "Geotechnical Assessment for Proposed Multi-Lot Subdivision Stage 1B, 104-110 Ngarara Road Waikanae Kapiti Coast. Ref. 12016" by ABuild Consulting Engineers Ltd dated September 2019. Upon completion of the earthworks the consent holder shall provide geotechnical completion report and a certificate in the form of Schedule 2A of NZS4404:2010 by the geo-professional and a certificate in the form of Appendix A of NZS4431:1989 by the inspecting engineer to the Council's Development Engineer.

Note: The Geotechnical completion report for each residential lot shall include:

- Identification of suitable building platforms (subject to defined conditions) for residential development;
- General ground stability and foundation conditions on the lot;
- Detail of geotechnical hazards that exist on the lot and which will require mitigation during site development;
- Recommendations for geotechnical conditions on site developments;
- Provision of general restrictions on site development such as maximum fill and cut heights, maximum batter slopes gradient, etc.

Note: A Consent Notice under Section 221 of the Resource Management Act will be issued to facilitate the recording of requirements recommended in geotechnical completion report, which is to be complied with on an on-going basis.

23. Any time the Project Archaeologist is to be present onsite, Ātiawa ki Whakarongotai is to be notified and afforded the opportunity to also be onsite. Any costs arising from having an iwi representative onsite shall be borne by the consent holder.
24. Any future structure requiring a Building Consent in terms of Building Act 2004 provisions, proposed on Lots 1 to 17 of Stage 1B shall have specific building location, building platform & foundation design by a suitably experienced Chartered Engineer or an appropriately qualified Geotechnical Engineer in regards to the potential differential settlement and/or potential for shallow land instability.

Note: Specifically designed building location, building platform and foundation design is required in accordance with the Building Act 2004 as recommended in the report titled "Geotechnical Assessment for Proposed Multi-Lot Subdivision Stage 1B, 104-110 Ngarara Road Waikanae Kapiti Coast. Ref. 12016" by ABuild Consulting Engineers Ltd dated September 2019, a Consent Notice under Section 221 of the Resource Management Act will be issued to facilitate the recording of this condition, which is to be complied with on an on-going basis.

Ecology

25. Secondary stage of pest control of rabbits shall be carried out effectively across the site and the grazed land adjacent to the ecological site from granting of consent until earthworks and road construction are completed.

Note: A combination of night shooting, burrow fumigation and strategic baiting with carrot laced with liquid Pindone poison is an effective means of rabbit control.

Parks and Open Space

26. Prior to works commencing, the consent holder shall submit a site specific safety plan (SSSP) for the earthworks behind the cricket club. The SSSP shall be prepared in consultation with the club. All construction is to be undertaken in a way that does not impact on club activities. Consultation records and the SSSP are to be provided to the Council's Park & Recreation Manager for approval.
27. Prior to the commencement of works and at least 20 days prior to purchasing of plants, the consent holder shall submit a Landscape Management Plan for all landscaped areas to be vested in Council for approval to the satisfaction of the Council's Park & Recreation Manager. The landscape plan shall contain the following:
- Existing vegetation to be retained;
 - Any vegetation to be removed;
 - The extent of planting, paved (impermeable) surfaces and other landscaping elements
 - Details of plant species;
 - Location of plants;
 - Number of plants;
 - Plant grade sizes;
 - An implementation plan describing the methods of soil preparation, details of drainage, fertilising, mulching, spraying, irrigation, staking tree pits, ongoing maintenance, replacing of dead/poorly performing plants and weed and pest management;
 - Scheduling of work, including maintenance to ensure successful establishment;
 - The location, height, and type of fencing; and
 - Maintenance manual for roading stormwater system.

Reserve Boundary Fencing

28. With respect to stage 1B, prior to works commencing, the consent holder shall submit a fencing plan for the common boundaries between any park/accessway reserve and allotments (Lots 12, 13, 14 as active reserve type; Lots 15, 16, 17 as passive reserve) for approval to the satisfaction of the Council's Development Engineer. Farm fencing shall be proposed for the common boundaries between Lot

101 or Lot 102 of stage 1B and Lot 2 of Stage 1A. Fencing shall be in accordance with SDPR:2012 and constructed prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991.

29. With respect to Lot 1 of Stage 1A and Lots 12-17 of Stage 1B, the consent holder shall enter into a fencing covenant to ensure that Council shall not be liable for, or called upon to erect or maintain or contribute towards the cost of erection or maintenance of any fence along any reserve boundary. The consent holder shall enter into a bond or cash deposit of \$500.00 per lot subject to the covenant on application for certification pursuant to Section 224(c) of the Resource Management Act 1991. The bond will be refunded once evidence is submitted that the covenants have been registered on the appropriate titles.

Access and Transport

30. With respect to stage 1B, prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the road must be constructed in accordance with Part 3 Section D & Part 4 Schedule 3 of SDPR: 2012 and Table 3.2 diagram E22 of NZS4404:2010.
31. With respect to stage 1B, the turning head within the road to vest (Lot 101) shall be capable of accommodating a 19 m diameter circle.
32. With respect to stage 1B, any vehicle crossing shall be formed, metalled and sealed between the carriageway edge and the road boundary. The crossing shall be formed in accordance with the KCDC standard drawing for a residential crossing KCDC-RD-005 Revision 5.
33. With respect to stage 1B, prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, pram crossings shall be provided in accordance with drawing KAP-0104-SCH Revision B.
34. With respect to stage 1B, any raised crossings are to be constructed in accordance with drawing KAP-0104-SCH Revision B and KCDC Roding Standard Drawing KCDC-RD-009 Revision 4.
35. Any batters required as part of the subdivision and any planting shall not impede sight visibility such that provisions rule 11E.1.3 cannot be complied with.
36. With respect to stage 1B, prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the footpaths and pedestrian ramps (including accessway to Waikanae Park) are shall be constructed in accordance with Roding Standard Drawings RD-002 Revision 3, Roding Standard Drawing RD-003 Revision 5 and Roding Standard Drawing RD-004 Revision 3.
37. With respect to stage 1B, prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, street lighting columns and lamps shall be provided to service the development. The street lighting layout shall comply with AS/NZS 1158.1:2005 including all referenced standards including NZTA M30 Specification and Guidelines 2014. Where required transformer or cell phone sites shall be specifically provided for by recessing the front boundary of lots and including the area within road reserve. Any street lights installed within the development shall be provided with a separate street lighting system.

Note: Council is converting the district's streetlights to LED lights and smart dimming control technology, and encourage its use in private development. If the roads within the development were to ever vest with Council, retrofit LED and smart dimming control technology would be required.

38. With respect to stage 1B, prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, all roads and rights of way shall be sealed using a minimum of three coat chip sealed surface, unless agreed otherwise with the Council's Development Engineer. Sealing must comply with NZTA specifications and standards.
39. With respect to stage 1B, prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the consent holder shall provide all signs and install all road markings in compliance with the legal requirements for traffic signs in New Zealand and MOTSAM Part 1, excluding Section 1.11.1, Construction - General Requirements 2010 unless otherwise approved by the Council's Development Engineer. The consent holder shall meet all associated costs of legalising any no stopping lines, give way and compulsory stops and regulatory general (speed restriction) signs that are required.
40. Prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, vegetation removal/trimming and earthworks along the frontage of Lots 1, 4, 5, 8-12 with Ngarara Road shall be designed and implemented to achieve adequate sightlines in accordance with rule 11E.1.3 of the Proposed District Plan. The trimming of this vegetation is to occur on an ongoing basis to ensure that adequate sightlines are maintained and provided at all times.

Note: A Consent Notice under Section 221 of the Resource Management Act will be issued to facilitate the recording of vegetation removal/trimming requirement, which is to be complied with on an on-going basis.

41. With respect to stage 1B, prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the vehicle crossing for Lots 1, 6 and 12 are to be constructed in the location shown on drawing KAP-0104-SCH Revision B unless otherwise agreed with the Council's Development Engineer, this is for ensuring sight distance and road safety.
42. With respect to stage 1B, the consent holder shall submit to Council's Development Engineer a road safety audit in accordance with the New Zealand Transport Agency's publication 'Road Safety Audit Procedures for Projects Guidelines' for the development during the following stages of construction:
 - a. Detailed design stage when engineering drawings are submitted for approval. The detailed design of the road and intersections shall take into account the findings of the road safety audit report;
 - b. Post construction stage. A post-construction road safety audit report shall be submitted for acceptance prior to the issue of the Section 224(c) certificate.

Stormwater

43. Prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the stormwater disposal system shall be designed and constructed in accordance with Part 3 Section E & Part 4 Schedule 4 of KCDC's SDPR:2012 and the requirements and intent of the report titled "Conceptual Stormwater Disposal

Design Report for Resource Consent Application – Proposed 17 lot subdivision at 104 - 110 Ngarara Road, Waikanae, Ref: 22162, Revision B” by Cuttriss Consultants Ltd dated 13 November 2019.

Note One: 1% AEP event runoff from individual allotment shall be collected and disposed within the lot, runoff of exceeding 1% AEP event could be overflowed by pipe to an approved stormwater outlet at kerb. In the event that the stormwater on-site disposal/attenuation system (designed with 1% AEP event) of individual allotment is not installed prior to the issue of the 224(c) certificate, a Consent Notice under Section 221 of the Resource Management Act will be issued to facilitate the recording of this condition, which is to be complied with on an on-going basis. The Consent Notice shall include reference to the following:

- The certified stormwater disposal design as an option for compliance;
- The owners’ responsibility to construct a system to meet the above performance standard;
- The owners’ responsibility to maintain the system on an on-going basis to meet the above performance standard as it applied at the time of approval.

Note Two: In the instance that the above condition is not complied with respect to Stage 1A, a consent notice pursuant to section 221 of the Resource Management Act 1991 will be imposed that draws the land owners’ attention to the fact that these services are not provided and are to be provided at the land owners expense.

Wastewater

44. Prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the consent holder shall, from Council’s wastewater reticulation within Ngarara Road, extend the gravity network and provide each individual allotment with a new gravity wastewater lateral which complies with the Council wastewater standard drawings and Part 3 Section F & Part 4 Schedule 5 of SDPR:2012 and the requirements and intent of the report titled “104-110 Ngarara Road, Waikanae Development Impact Assessment” by Hydraulic Analysis Limited Dated November 2019.

Note: In the instance that the above condition is not complied with respect to Stage 1A, a consent notice pursuant to section 221 of the Resource Management Act 1991 will be imposed that draws the land owners’ attention to the fact that these services are not provided and are to be provided at the land owners expense.

Water Supply

45. Prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the consent holder shall, from Council’s water reticulation within Ngarara Road, extend the network and provide individual allotment with a metered water supply which complies with the Part 3, section G & Part 4 Schedule 6 of SDPR: 2012 and the requirements and intent of the report titled “Kapiti Coast District Council (KCDC) - Ngarara Road Development Report. Project Number – 310101208” by Stantec Limited Dated November 2019.

Note: In the instance that the above condition is not complied with respect to Stage 1A, a consent notice pursuant to section 221 of the Resource Management Act 1991 will be imposed that draws the land owners' attention to the fact that these services are not provided and are to be provided at the land owners expense.

Power, Telecommunications, Gas

46. Prior to the issue of a Section 224(c) certificate under the Resource Management Act 1991, the subdivision shall be serviced with electric power & telecommunication to the boundary of each individual allotment complying with the Part 3 Section I & Part 4 Schedule 8 of SDPR: 2012.

Note One: For the avoidance of doubt, 'serviced to lot boundary' shall mean that the supply of electric power is available from an underground system, and for telecommunications, shall mean that the reticulation of telecommunications facilities is available, which can be satisfied by a direct installation, or a fibre ready network facility being available.

Note Two: In the instance that the above condition is not complied with respect to Stage 1A, a consent notice pursuant to section 221 of the Resource Management Act 1991 will be imposed that draws the land owners' attention to the fact that these services are not provided and are to be provided at the land owners expense.

Transpower

General

47. With respect to Lots 1-3, 6 & 17 of stage 1B (which are traversed by the BPE-HAY-A National Grid transmission lines: all land use activities, including the construction of new buildings/structures, earthworks, fences, any operation of mobile plant and/or persons working near exposed line parts shall comply with the New Zealand Electrical Code of Practice for Electrical Safe Distances (NZECP34:2001) or any subsequent revision of the code.

Note: A Consent Notice under Section 221 of the Resource Management Act will be issued to facilitate the recording of this condition which is to be complied with on an ongoing basis.

Buildings/structures

48. With respect to Lots 1-3, 6 & 17 of stage 1B (which are traversed by the BPE-HAY-A National Grid transmission lines: no buildings for sensitive activities shall be located within 12m of the centreline of the BPE-HAY-A National Grid Transmission Line.
49. With respect to Lots 1-3, 6 & 17 of stage 1B (which are traversed by the BPE-HAY-A National Grid transmission lines: buildings and structures on proposed Lots 1, 2, 3, 6, 17 of stage 1B will be established within the building envelopes identified in the Electrical Clearance Report, from Groundline Engineering, dated 28 August 2019 and Groundline Engineering drawings number NZ-6367-SK-01, sheets 1 & 2, revision 2.

Note: Buildings for Sensitive Activities include Dwellings, Childcare, Schools, Hospitals.

50. No buildings or structures shall be located within 12m of any outer visible edge of any National Grid support structure; except for non-conductive fencing, which can be located 6m from any outer visible edge of the support structure foundation.

Note: A consent notice pursuant to section 221 of the Resource Management Act 1991 will be imposed in respect to Lots 1, 2, 3, 6 and 17 to facilitate this condition which is to be complied with on an ongoing basis.

51. Lighting shall be designed to ensure compliance with NZECP 34: 2001, or any subsequent revision of the code, including (but not limited to) Section 9.2.1 relating to the ability to maintain safe approach separation distances for people maintaining the lighting, including changing light bulbs.

Earthworks

52. No excavation or disturbance of the land around the National Grid Tower BPE-HAY-A0256 shall:
- i. Exceed a depth greater than 300mm within 6 metres of the outer edge of the visible foundations of the tower; or
 - ii. Exceed a depth greater than 3 metres between 6 metres and 12 metres of the outer edge of the visible foundation of the tower; or
 - iii. Create an unstable batter.
53. No fill or material shall be stockpiled or deposited under the BPE-HAY-A National Grid transmission lines so that the conductor to ground clearance is reduced to less than 7.5m.
54. The consent holder must ensure that the discharge of dust and/or particulate matter from the activities authorised by this consent do not create any dust hazard or nuisance to the BPE-HAY-A National Grid transmission lines, including support structures. Dust hazard or nuisance will occur if:
- i. There is visible evidence of suspended solids in the air; and/or
 - ii. There is visible evidence of suspended solids traceable from a dust source (from the site works) settling on the transmission lines and/or support structures.

Mobile Plant

55. All machinery and mobile plant operated in association with the works shall maintain a minimum clearance distance of 4 metres from the BPE-HAY-A National Grid transmission lines at all times.
56. A warning sign must be clearly displayed at the operator position on any mobile plant stating - "WARNING, KEEP 4M MINIMUM CLEARANCE FROM TRANSMISSION LINES AT ALL TIMES".

People

57. All people working on site, must maintain a safe separation distance of at least 6 metres between themselves (including any tools they are carrying) and the conductors (wires) of any National Grid transmission lines at all times.

Stormwater

58. The consent holder must ensure that changes to the stormwater drainage patterns and runoff characteristics arising from the works do not result in adverse effects on the foundations of any National Grid support structure.

Vegetation

59. Any proposed new trees or vegetation within 12m either side of the centreline of the BPE-HAY-A National Grid transmission line, or within the no build/ max swing/blowout corridor as identified in the Electrical Clearance Report, from Groundline Engineering, dated 28 August 2019 and drawings number NZ-6367-SK-01, sheets 1 & 2, revision 2, undated but stamped as approved by Transpower New Zealand Limited 20 November 2019 must not exceed 2 metres in height at full maturity. Any proposed new trees or vegetation outside the above area must be setback sufficiently to ensure the tree cannot fall within 4 m of the BPE-HAY-A lines. All trees and vegetation must comply with the Electricity (Hazards from Trees) Regulations 2003, or any subsequent revision of the regulations.

Note: A consent notice pursuant to section 221 of the Resource Management Act 1991 will be imposed in respect to Lots 1, 2, 3, 6 and 17 to facilitate this condition which is to be complied with on an ongoing basis.

Miscellaneous

60. The consent holder must ensure that no nuisance effect, including dust, may be caused by discharge of material beyond the boundary of the subject site. For the avoidance of doubt material includes but is not limited to silt, sediment, vegetation and aggregate.
61. Should there be potential for wind-blown sand, soil or other material to be transported onto other properties the consent holder shall erect suitable fabric fencing (sarlou cloth or similar) or take other acceptable mitigation measures, to the satisfaction of Council's Enforcement Officer.

Easements

62. Easements are required over any rights-of-way and utility services serving an allotment within the subdivision, where contained within another allotment of this subdivision, must have appropriate easements duly granted or reserved. The easements, as necessary and subject to other conditions of this consent, are to ensure that the lots can be serviced for water supply, drainage, domestic energy supply, and telecommunications (including broadband) and that access is provided to lots. Any easement must be subject to Section 243 of the Resource Management Act 1991.

Completion Requirements

63. Completion documentation, including operation and maintenance manuals, shall be submitted in support of an application for Section 224(c) certification in accordance with Part 1 of NZS 4404:2010 and Part 4, Schedule 1 of KCDC's SDPR:2012. The consent holder shall provide Council with an itemised schedule of quantities and

costs, and the CCTV inspection reports, for those services and assets which are to vest in Council.

Note: An as-built of the accessway to vest is to be included in RAMM as part of roading as-built data transfer.

Plans and Meeting of Conditions

64. The consent holder shall supply a copy of the title sheets of the e-survey dataset and shall list and indicate how each condition has been met to the satisfaction of the Council.

Advice Notes:

- The consent holder shall notify the Council's RMA Compliance Officer of the start and completion dates of the works in writing 48 hours before the works are carried out. The consent holder shall fill out and return (by email to the duty compliance officer at compliance.dutyofficer@kapiticoast.govt.nz, or by fax to (04) 2964 830 or by post to Private Bag 60601, Paraparaumu) the form that is attached to the decision letter.
- The consent holder shall pay to the Kapiti Coast District Council the actual and reasonable costs associated with the monitoring of conditions (or review of consent conditions), or supervision of the resource consent as set in accordance with Section 36 of the Resource Management Act 1991. These costs* may include site visits, correspondence and the actual costs of materials or services which may have to be obtained.

*Please refer to Kapiti Coast District Council's current schedule of Resource Management fees for guidance on the current hourly rate chargeable for Council's staff.

- Under Section 125 of the Resource Management Act 1991, this resource consent will lapse in five years, unless it is given effect to within that time.
- It is the consent holder's responsibility to comply with any conditions imposed on this resource consent prior to and during (as applicable) exercising this resource consent.
- All costs arising from the above conditions shall be borne by the consent holder.
- The consent holder is required to comply with the Land Drainage Act 1908. Under this Act, all natural drainage patterns are to be preserved.

- It is the responsibility of every owner to provide vehicle crossing from the road carriageway to the property boundary for the purposes of off street parking or unloading.

- Additional fees will be required by the Council for the processing of the application(s) for the certification of the section 223 and 224 certificates. The section 224 certificate will be issued following compliance with all conditions of consent set out above, and payment of any applicable development contributions. .
- Works within the legal road will only be approved where they comply with Council procedures and processes which are set out below:
 - a. Before undertaking work in the legal road you must make a Corridor Access Request (CAR) and receive a Works Access Permit (WAP) from Kapiti Coast District Council. Some examples of activities requiring a permit are:
 - trenching works;
 - footpaths and entranceways;
 - work within the berm or shoulder of the road; and
 - tree work scaffolding and crane work.
 - b. Before any excavations are undertaken a "Before U Dig" inquiry must be made to check for locations of any underground services. This is a web based service that you or your contractor use to get plans and information emailed out to you. This also provides the mechanism for you to make a Corridor Access Request and provide us with a Traffic Management Plan to protect your site, contractors, and the public during operations. Corridor Access Requests require 5 working days' notice before work can commence and Traffic Management Plans for road closures and events must be received 42 working days in advance of the closure or event. Please note: The "Before U Dig" service has no information on council's buried water, wastewater or stormwater assets. Our mapping tools show the location of the buried council assets.
 - c. Work must be undertaken in accordance with Councils guides and standard drawings. Examples of forms, guides and standards drawings An information sheet, application form and standard drawings (engineering plans) are available for download or print from the Council website and examples include:
 - Vehicle Installation Information;
 - Vehicle Crossing Application Form;
 - Roding Standard Drawings; and
 - Vehicle Crossing Guidelines
- If you disagree with any of the above conditions, or disagree with the additional charges relating to the processing of the application, you have a right of objection pursuant to sections 357A or 357B of the Resource Management Act 1991. Any objection must be made in writing to the council within 15 working days of notification of the decision.
- Evidence of archaeological sites may include kōiwi (human skeletal remains), taonga Māori (Māori artefacts), oven stones, charcoal, shell middens, ditches, banks, pits and old building foundations. If any archaeological site(s) are uncovered during physical works, Ātiawa ki Whakarongotai Charitable Trust will require the contractor to adopt the following protocols:

- a. Work shall cease immediately within 100 metres of the site of discovery.
- b. The contractor and subcontractor(s) must shut down all machinery, isolate and secure the site, and advise the project manager.
- c. No materials relating to the artefacts or site shall be removed.
- d. The project manager shall promptly advise Ātiawa ki Whakarongotai Charitable Trust.
- e. If skeletal remains are uncovered, the project manager will also advise New Zealand Police.
- f. An archaeologist approved by Ātiawa ki Whakarongotai Charitable Trust shall be employed at the expense of the contractor to examine and record the site.
- g. Ātiawa ki Whakarongotai Charitable Trust will at their discretion contact other iwi groups and organise a site inspection by appropriate tangata whenua advisors and the archaeologist.
- h. If as a result of the site inspection and investigation there is a need for an appropriate ceremony, Ātiawa ki Whakarongotai Charitable Trust will arrange such at the contractor's expense.
- i. Materials discovered will be handled and removed by the Ātiawa ki Whakarongotai Charitable Trust representatives responsible for the tikanga appropriate to their removal and preservation, or re-interment.
- j. Works affecting the archaeological site shall not resume until Ātiawa ki Whakarongotai Charitable Trust, and the New Zealand Police in the case of skeletal remains, have given the appropriate consent, approval or authority for work to continue. The contractor and subcontractor(s) will allow representatives of Ātiawa ki Whakarongotai Charitable Trust and the archaeologist all reasonable access to the site to carry out their respective responsibilities or activities under this protocol.

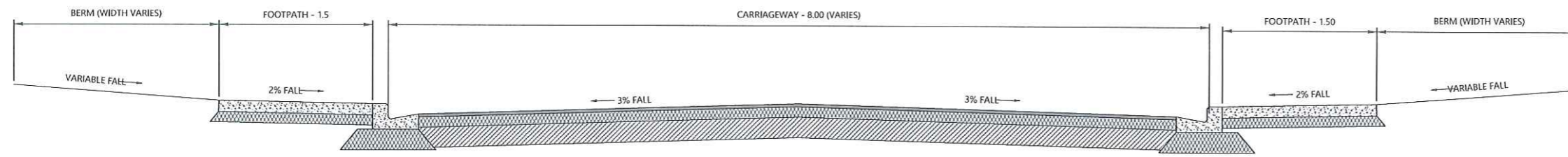

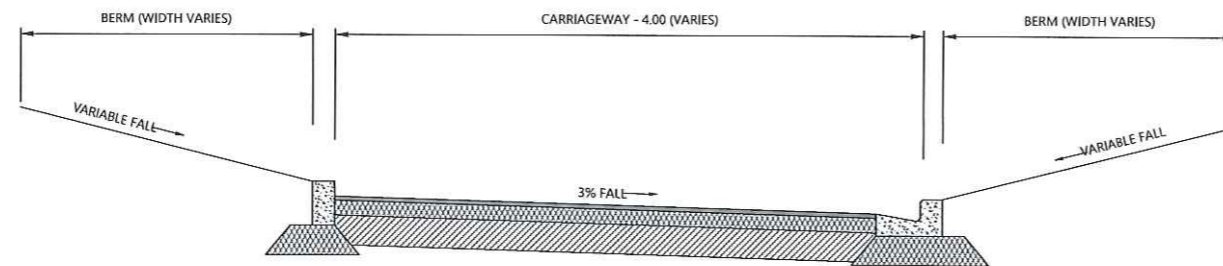
