

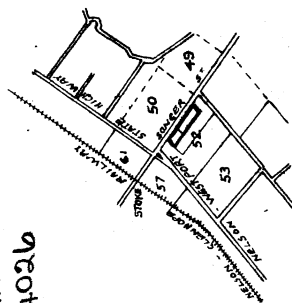

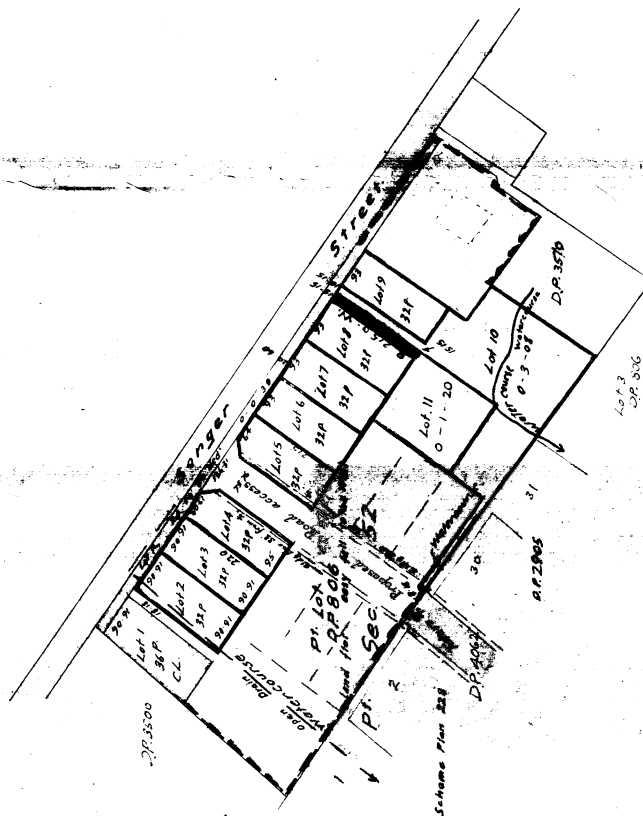

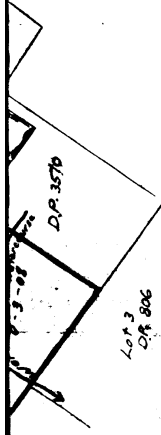

CONDITIONS OF BUILDING LINE

SECTION 5. LAND SUBDIVISION IN COUNTIES ACT, 1946.

Pursuant to the provisions of Section 5(4) Land Subdivision in Counties Act 1946, I, JOSEPH WILLIAM McINTYRE, Chief Surveyor, Nelson Land District, hereby give notice that Part Section 52 Suburban South District, contained in Certificate of Title, Volume 97 Folio 37, more particularly delineated on Scheme Plan No.466 Town of Stoke Extension No. 41 is subject to the condition that no buildings shall be erected within 33 feet of the centre line of the proposed road access leading from Totara Street to Songer Street.

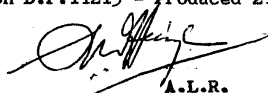

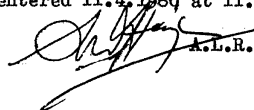
