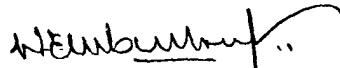

That in exercise of the powers conferred on it by Section 186 of the Municipal Corporations Act, 1954 the Nelson City Council hereby resolves, by way of Special Order, to permit the laying off of Devon Street at a width less than sixty - six (66) feet but not less than fifty (50) feet, subject to the condition that no building or parts of a building shall at any time be erected on the land having frontage to the said portion of Devon Street, as the same is more particularly described in the schedule hereunder written, within a distance of thirty-three (33) feet from the centre line of the said street.
