The fact that you are attending the GFWC Convention shows you are already in the process of developing your leadership skills. Consider these key steps as you seek to further develop your leadership skills:

- 2. Learn from successful leaders: Understand their leadership style and how they handle various situations.
- 3. Take leadership courses.
- 4. Improve communication skills: Learn to clearly express ideas and be a good listener.
- 5. Influence and motivate others: Understand what drives the people you are trying to motivate and work within their personalities.
- 6. Be a problem solver: Seek to think creatively and solve problems.
- 7. Continuous learning: Be a lifelong learner.
- 8. Find a mentor: Connect with someone experienced in leadership who can provide valuable guidance and honest feedback.
- 9. Practice discipline: Good discipline habits, such as punctuality and meeting deadlines, sets a positive example.

# MARY ANN—Question 2: How can I get the members to take a leadership position? Sheli Fehr, GFWC Great Lakes Region

- 1. There is an old adage about how long one should speak. "Don't speak longer than the rear can endure." This is also true when asking members to do things. Don't keep asking the same members, even though they are the ones who always volunteer. That leads to burn out.
- 2. Split up tasks. Maybe the project needs more than one chairman. If your club is having a rummage sale, you could have one chairman assigned to deal with vendors, one chairman to coordinate logistics and set up, and one chairman to handle public relations and advertising.
- 3. Evaluate the number of projects your club is doing. You may choose to eliminate some projects. Use the GFWC Top 10 Projects listing to find a project that fits with your club and community. As a club, you do not have to do it all. You can choose which CSP to emphasize. Choose the areas of interest to your club women.

- 4. Provide a range of volunteer opportunities to cater to different interests, skills and schedules. Offering flexibility allows individuals to find opportunities that align with their passions.
- 5. Assigning members in different positions creates new ideas and enthusiasm.

### THURSTON—Question 3: How can I overcome leadership challenges? Sandy Hauenstein GFWC Middle Atlantic

- 1. Stay humble. Recognize the value of your members. You may be the chairman or the president, but members are volunteers not employees.
- 2. Exude self-confidence. Self-confidence is essential to motivate others. Motivate but don't be a dictator.
- 3. Be clear of your role and understand your responsibilities.
- 4. Be authentic. There are many types of leaders and ways to lead. Find a style that aligns with your values and personality.
- 5. Find support. Seek advice and guidance from mentors, peers, or professional networks.

# PROFESSOR—Question 4: How do you handle an overbearing president/chairman? Suzanne Simons, GFWC South Central Region

- 1. Take a step back and analyze the situation before reacting. Seek to understand if this is an isolated incident or part of a pattern?
- 2. Understand the why. Are there some personal factors that need to be considered?
- 3. Check yourself. Evaluate your own behavior. Are you contributing to the situation in any way?
- 4. Build trust. Show that you are reliable. Meet deadlines and stay organized.
- 5. Communicate consistently.
- 6. Maintain professionalism. Regardless of another's behavior, maintain your cool.
- 7. Clarify expectations. Make sure you understand what is expected of you.
- 8. Provide frequent updates. Keep your chairman or president informed about your progress.

# GILLIGAN—Question 5: How can we address the issues of recruitment and retention? Anne Engelhardt, GFWC New England Region

- Leaders need to develop innovative strategies to attract new members and keep existing members engaged.
- 2. Make sure to offer a variety of diversified activities and volunteer opportunities.
- 3. Provide opportunities for skill development and training relevant to the club's activities. Encourage members to take advantage of workshops, seminars, and mentoring programs offered by GFWC. When members enhance their skills, they feel more confident in their roles.
- 4. Recognize and appreciate the efforts of volunteers. Acknowledge members publicly, celebrate milestones, and express gratitude for their dedication. Feeling appreciated encourages members to continue their involvement.

- 5. Use various communication channels (e.g., social media, email newsletters, meetings) to keep members informed about upcoming events, projects, and opportunities for involvement. Regular communication helps maintain engagement and fosters a sense of belonging.
- 6. Be flexible. Recognize that members have varying levels of availability and commitment. Offer flexible volunteering options, such as remote or short-term projects, to accommodate different schedules and preferences.

#### LOVEY—Question 6: A mentor is a valuable leadership tool. How do I select one? Carol Lopez Lucey, GFWC Western States Region

- 1. Selecting the right mentor is important. Here are things to consider. Do they understand your needs? Where do you want to grow? Decide if you want to focus on leadership skills, event planning, community outreach or some other area?
- 2. You can look for individuals in your current club or in a neighboring club. Compatibility in personality and communication style is also an important aspect to consider. Are they accessible? Are they willing to commit to mentoring you? Volunteers have busy schedules so it is essential to find someone who can dedicate the time and support you need.
- 3. Ask for help and advice in selecting a mentor. Others may be able to suggest individuals who have a reputation for providing excellent mentorship and support.
- 4. Always trust your instincts when selecting a mentor. Choose someone with whom you feel comfortable sharing your aspirations and challenges and who you believe can offer valuable advice and support.
- 5. Remember that mentorship is a reciprocal relationship. While your mentor can provide guidance and support, be proactive in seeking feedback, implementing advice and contributing to success.

- 1. We need to provide the necessary support, resources, and opportunities to develop skills and to expand knowledge needed to assume leadership roles effectively.

We can organize workshops, seminars and training sessions covering a variety of topics including communication skills, conflict resolution, strategic planning and team building. In essence, we can offer a club-based LEADS program.
- 3. We can create opportunities for women to network and collaborate with peers both within and outside our organization.
- 4. We can encourage and create an environment that promotes innovation and creativity among women's club leaders. We can support women and inspire them to explore new ideas, experiment with different approaches and take calculated risks.
- 5. We can offer continuous feedback and evaluation as we establish methods for collecting feedback from our leaders about their experiences, needs and areas for improvements.

# Cruise Director—Question 8: Succession planning is important? How do we prepare our upcoming leaders? Ann Landis, GFWC Southeastern Region

Succession planning in a woman's club is crucial to ensure the continuity of leadership and the long-term success. Here are several steps to prepare future leaders effectively:

- 1. Identify potential leaders using interest surveys and discussion groups in long range planning sessions.
- 2. Foster an environment where members are encouraged to participate.
- 3. Develop mentorship programs by paring potential leaders with current leaders.
- 4. Implement a system where members can rotate through various leadership roles to ensure an understanding of the big picture.
- 5. Consider co-chairman roles pairing a novice and an experienced member together.
- 6. Create a timeline to guide new leaders. Have a face-to-face meeting where the past chairman can share with the new chairman. Pass information along.
- 7. Promote inclusion and diversity. Create an environment where new ideas and perspectives are welcomed.
- 8. Acknowledge contributions. Use rewards, incentives and public acknowledgement.
