- Obituary -

Mr. John Andrew Harris, Sr., son of the late Mr. John Harris and Mrs. Trubie Martin Dowell, was born January 18, 1951 in Lee County, Alabama.

At an early age, he accepted Christ and united with the historic St. Luke A.M.E. Church in Opelika, Alabama where he served as a member of the Steward Board. He graduated from J.W. Darden High School Class of 1970. In the early 80's, John opened and operated JHJ Grocey Store in Opelika, Alabama.

Commissioner Harris has been a Public Servant/Official for the greater part of his life. His involvement with the community spans over thirty years. In 1986, he was elected City Councilman, the first of two African Americans to ever fulfill this position. Mr. Harris held this seat until 1994. City Councilman Harris was then elected to the public life position of County Commissioner - Lee County, Opelika, Alabama. Commissioner Harris has governed effectively in that capacity until present and the recipient of numerous distinguished commendations and awards honoring his impressive political career including the following:

1986, Community Service Award (Alpha Kappa Alpha Sorority, Inc); 1988, Certificate of Appreciation for Outstanding and Dedicated Service (Alpha Kappa Alpha Sorority, Inc.); 1990, served as Mayor Pro-Tem Opelika City Council; 1995, Outstanding and Dedicated Service 16 Years award; City Government of Alabama Lee County (Association County Commissions) Recognized Honorable John Andrew Harris; 2000, Appreciation for Leadership Service and Dedication to the Opelika Community (Zuber Federation Club); 2002, Outstanding Leadership and Service as a History Maker; a recognition as the First African American elected to Opelika City Council from Ferguson Chapel CME Church; 2004, a recognition from Alabama Council Partnership of Lee County; 2007, Distinguished Men Award/Concern Citizen for Children; Present Chairman of Lee & Russell Counties Planning Organization since 2007; 2008, an Excellence in Leadership and Dedication from the Lee County Democratic Party for the

Get Out and Vote; 2011, a Congratulations and Retirement Award from the Auburn City Schools Child Nutrition Program for 34 years of service; 2014, TOP County Performers Award, Voter Registration Drive from the Alabama Voter Registration Alliance; The Community Service Award from Bell Missionary Baptist Church Auburn, Alabama; 2016, Recipient of President Barack Obama Lifetime Achievement Award; current President Lee County Voters League since 2016; he served as campaign manager for Doug Jones for Lee & Russell Counties; 2018, Dr. Martin Luther King Jr. Community Service Award from the Dream Day Foundation; 2019, Recipient of Champion of Change Political Action Award; 2021, Appointed as the Alabama State NAACP Conference new Political Action.

John was an avid Auburn Football Fan "War Eagle" and he enjoyed playing cards (spades).

On Sunday, January 15, 2023, he departed this life at Piedmont Healthcare in Columbus, Georgia. He was preceded in death by: one daughter, Zanquetta Harris; three brothers, Jimmy Harris, James Harris and Dr. Jamarlo K. Gumbaytay.
