THE PURPOSE OF THE PROGRAM IS TO PROVIDE HOMELESS AND RUNAWAY YOUTH WITH SAFE, TEMPORARY SHELTER COUPLED WITH INTENSIVE SUPPORT SERVICES TO HELP THEM REGAIN STABILIZATION AND ULTIMATELY ACHIEVE SELF-SUFFICIENCY. COVENANT HOUSE MISSOURI BEGAN PROVIDING CRISIS SERVICES IN APRIL 2008 WITH THE OPENING OF THE CENTER FOR YOUTH. IN FISCAL YEAR 2015, 310 UNDUPLICATED YOUTH WERE SERVED THROUGH THE CRISIS PROGRAM.

THIRTY-TWO BEDS ARE AVAILABLE AND THE LENGTH OF STAY IS UP TO 24 MONTHS. YOUTH WHO ARE ENROLLED IN TLP ARE REQUIRED TO HAVE A JOB, BE WORKING TOWARD THEIR EDUCATIONAL GOALS AND SAVE 60% OF THEIR EARNED INCOME FOR FUTURE INDEPENDENT LIVING. IN FISCAL YEAR 2015, 55 UNDUPLICATED YOUTH WERE SERVED IN TLP.

SERVICES INCLUDE: MENTAL HEALTH SERVICES, LIFE SKILLS CLASSES, GED AND LITERACY/TUTORIAL SERVICES, JOB READINESS AND PLACEMENT SERVICES, VOLUNTEER OPPORTUNITIES AND RECREATIONAL ACTIVITIES. THESE SERVICES ARE DESIGNED TO HELP YOUTH ADDRESS THE OBSTACLES THAT OTHERWISE PREVENT THEM FROM LEADING SUCCESSFUL, INDEPENDENT LIVES.
