President elect – 1 post

Vice President- 2 posts

Honorary Secretary General elect– 1 post

Honorary treasurer elect – 1 post

Honorary Joint secretary – 2 posts

Executive Committee member – 10 posts.

ELIGIBILITY CRITERIA

PRESIDENT ELECT

President elect gets naturally promoted to the post of President at the end of completion of previous president's term of office.

PRESIDENT ELECT

Duration of post -1 year.

- 1) Should have held at least 10 years of continuous life membership of IADVL KN branch
- 2) Shall have a minimum experience of fifteen years in the specialty of Dermatology, Venereology and/or Leprology after having taken his/her postgraduate qualification in the specialty.
- 3) Shall be exclusively engaged in the practice, teaching and/ or research of these specialties of Dermatology, Venereology and/or Leprology.
- 4) Should be a resident of Karnataka and working in Karnataka for the previous ten years in continuum.
- 5) Must have held the following posts at least for one term in the past :
 - a) Vice president of IADVL Karnataka
 - b) Vice President of IADVL National
 - c) President of a National Sister Society of Dermatology or a sub specialty, eg: ACSI

VICE PRESIDENT

Duration of post -1 year.

Should have held at least 10 years of continuous life membership of IADVL KN branch

- 1) Shall have a minimum experience of ten years in the specialty of Dermatology, Venereology and/or Leprology after having taken his/her postgraduate qualification in the specialty.
- 2) Shall be exclusively engaged in the practice, teaching and/ or research of these specialties of Dermatology, Venereology and/or Leprology.
- 3) Should be a resident of Karnataka and working in Karnataka for the previous ten years in continuum.
- 4) Must have held the following or higher posts at least for one term in the past :
 - Hon Secretary Gen of IADVL Karnataka
 - Hon Secretary Gen of IADVL National
 - President of a sister society in the state of Karnataka
 - Organising Chairman of CUTICON with add on experience of having worked in KN EC
 - IADVL Karnataka or National academy Chairman

Hon secretary General

Duration of post -2 years.

Hon Secretary general elect gets naturally promoted to Hon Secretary General post after one year

- 1) Should have held at least 7 years of continuous life membership of IADVL KN branch
- 2) Shall have a minimum experience of 7 years in the specialty of Dermatology, Venereology and/or Leprology after having taken his/her postgraduate qualification in the specialty.
- 3) Shall be exclusively engaged in the practice, teaching and/ or research of these specialties of Dermatology, Venereology and/or Leprology.
- 4) Should be a resident of Karnataka and working in Karnataka for the previous 7 years in continuum
- 5) Must have held the following or higher posts at least for one term in the past :
 - a) Hon Treasurer of IADVL Karnataka
 - b) Joint secretary of IADVL Karnataka
 - c) Hon Treasurer of IADVL National
 - d) Hon Secretary of a National Sister society
 - e) Vice president/General secretary of a Sister society in the state of Karnataka with add on experience of having worked in KN EC.
 - f) Organising secretary of DERMADVANCE/DERMABASICS/CUTICON with add on experience of having worked in KN EC.

Hon Treasurer

Duration of post -2 years.

Hon Treasurer elect gets naturally promoted to Hon Treasurer post after one year

- 1) Should have held at least 7 years of continuous life membership of IADVL KN branch
- 2) Shall have a minimum experience of 7 years in the specialty of Dermatology, Venereology and/or Leprology after having taken his/her postgraduate qualification in the specialty.
- 3) Shall be exclusively engaged in the practice, teaching and/ or research of these specialties of Dermatology, Venereology and/or Leprology.
- 4) Should be a resident of Karnataka and working in Karnataka for the previous 7 years in continuumd.
- 5) Must have held the following or higher posts at least for one term in the past :
 - Joint secretary of IADVL Karnataka
 - Joint secretary of IADVL National
 - Hon Treasurer of a National Sister society
 - Hon Secretary general of a Sister society in the state of Karnataka with add on experience of having worked in KN EC.
 - Hon treasurer of DERMADVANCE/DERMABASICS/CUTICON with add on experience of having worked in KN EC.

Joint Secretary

Duration of post – 1 year, Candidate with higher vote numbers becomes Sr. Jt Secretary.

- 1) Should have held at least 3 years of continuous life membership of IADVL KN branch
- 2) Shall have a minimum experience of 3 years in the specialty of Dermatology, Venereology and/or Leprology after having taken his/her postgraduate qualification in the specialty.
- 3) Shall be exclusively engaged in the practice, teaching and/ or research of these specialties of Dermatology, Venereology and/or Leprology.
- 4) Should be a resident of Karnataka and working in Karnataka for the previous 3 years in continuum.
- 5) Must have held the following or higher posts at least for one term in the past :
 - a) EC member of IADVL Karnataka
 - b) EC Member of IADVL National
 - c) Treasurer of a sister society in the state of Karnataka
 - d) Website editor, Dermapen editor or Zonal coordinator for IADVL Karnataka / IADVL national activities.

Executive Committee Member

Duration of post – 2years.

- 1) Should be a life member of IADVL KN
- 2) Shall be exclusively engaged in the practice, teaching and/ or research of these specialties of Dermatology, Venereology and/or Leprology.

Non eligibility criteria

A member, while holding an elected post in IADVL State or National, ACSI or other professional NATIONAL bodies in the field of Dermatology , Venereology and Leprology cannot contest for any posts, other than Executive Committee Membership.

Member on deputation/ Overseas job cannot apply through a proxy. The same member should not apply if there is a probability of a distant posting leading to a prolonged absence.

Organizing committee (Core Committee members) members of the CUTICON in the election year cannot contest that year's elections.

- Persons not residing and working in the state of Karnataka
- Members with financial/ criminal/ Sexual offences cannot contest for any posts.
- The Election Officer, his / her spouse, son / daughter, son-in-law / daughter-in-law shall not be eligible to contest for any post in the election being held during that year.

Code Of Conduct

Code of conduct will be strictly followed, and may lead to refusal of candidature or disqualification of a candidate during election/ after election.

EC may call an emergency meeting, and in unusual situations, an emergency Extraordinary GBM may be called to deliberate and take necessary action. Legal Committee and Disciplinary Committee need to be involved too. In cases, before/during election the Election Officer too should be involved in the discussions and action plan.

Direct contest - Dismissal of a candidate may lead to unanimous election of the other candidate.

Legal opinion may be taken in case of a court contest by a deprived candidate. Refusal of application may be explained in detail by the Election Officer and EC combined to the disqualified candidate.

Rules for advertising & canvassing

Canvassing will be permitted 25th July → 9th August midnight. **Strictly no canvassing during e voting period.**

Only KN EC may send reminders to vote through its platforms during e voting period
