

ASSEMBLY INSTRUCTIONS
MODEL 301 - NARROW BENCH

1. SLIDE HINGE (ITEM 12) OVER SUPPORT BAR (ITEM 2) AS SHOWN.
2. INSERT ADJUSTING T (ITEM 29) INTO BENCH SUPPORT FRAME (ITEM 2) AND INSTALL (ITEM 9) IN LOWEST HOLE.
3. STAND UPRIGHT (ITEM 1) ON ITS BASE. ATTACH BENCH SUPPORT FRAME (ITEM 2) TO UPPER AND LOWER BRACKETS ON THE UPRIGHT USING THREE (3) 2.75" BOLTS (ITEM 24), WITH LOCK WASHERS (ITEM 25) AND NUTS (ITEM 26).
4. INSERT LEG CURL NECK (ITEM 5) INTO BENCH SUPPORT (ITEM 2) AS SHOWN. LET IT SETTLE TO LOWEST LEVEL. INSTALL (ITEM 9). (THIS IS ADJUSTABLE AND IS COVERED IN THE OPERATING INSTRUCTION.) THE LEG CURT SUPPORT (ITEM 4) SLIPS BETWEEN THE BARS OF THE NECK (ITEM 5). ATTACH THIS WITH THE 2.25 SHOULDER BOLT (ITEM 23) WITH LOCK WASHER (ITEM 28) AND NUT (ITEM 13). NEXT SLIDE THE LEG CURL TUBES (ITEM 8) THROUGH THE END HOLES OF THE LEG CURL SUPPORT (ITEM 4) ALLOWING 8.25" ON EITHER SIDE OF THE TUBE. NEXT, SLIDE THE WASHERS (ITEM 18) AND THE ROLLER PADS (ITEM 14) ON THE TUBES. THEN (ITEM 18) WASHER ON OUTSIDE OF ROLLER PADS. LOCK IN PLACE WITH THE PUSH NUTS (ITEM 19). ATTACH ADHESIVE BACKED RUBBER BUMPER (ITEM 20) TO BOTTOM OF THE LEG SUPPORT (ITEM 4) WHERE IT MAKES CONTACT WITH THE BENCH SUPPORT (ITEM 2).
5. ATTACH BACK PAD (ITEM 11) AND SEAT PAD (ITEM 10) TO HINGE (ITEM 12) USING FOUR .375 X 1.25 (ITEM 27) WITH LOCK WASHERS (ITEM 28) AND THE FLAT WASHERS (ITEM 17). NOTE: FLAT WASHERS ARE TO BE AGAINST THE PLATE.
6. INSERT SADDLE POSTS (ITEM 3) INTO VERTICAL TUBES OF THE UPRIGHT. NOTE: THE HANDLES ARE TO BE TO THE REAR. ADD SPONGE GRIPS (ITEM 21) TO THE HANDLES. USE LOCKING PINS (ITEM 6).
7. DROP HEIGHT ADJUSTMENT BAR (ITEM 7) INTO BRACKETS ON THE VERTICAL TUBES OF THE UPRIGHT (ITEM 1).
8. SNAP FOUR 2" PLASTIC CAPS (ITEM 15) INTO ENDS OF TUBES AT BOTTOM OF (ITEM 1) ENDS AND TWO OF ADJUSTING TEE (ITEM 29). THE 1.75 CAPS (ITEM 16) SNAP INTO THE ENDS OF THE LEG CURL SUPPORT AND THE TOP OF THE LEG CURL NECK, SCREW IN THE ADJUSTMENT KNOB (ITEM 22) AS SHOWN.
