



Golf Ball Drop Contest Rules

1. PURPOSE. The "Golf Ball Drop" at this year's Pay It Forward Golf Tournament is presented to raise support, through a suggested \$100 donation with each entry, for the Child Cancer Fund's mission to provide caring support to families fighting childhood cancer. 2. CONTEST SCHEDULE AND PLANNED DRAWING. The "Golf Ball Drop" Contest (the "Contest") is scheduled to take place January 1, 2019 at Jacksonville Golf & Country Club in Jacksonville, Florida, at approximately 4:00 pm, Eastern Standard Time. The planned Contest drawing will be accomplished by dropping consecutively numbered golf balls from a helicopter over Jacksonville Golf & Country Club's 14th fairway, with a target defined on the ground at that location. Nevertheless, in the event of inclement weather or other unexpected contingency, as determined in the sole discretion of the Child Cancer Fund, the method and/or timing of the planned drawing may be modified and be accomplished at a later time and/or by another means of random selection, such as a random number generator.

3. ENTRY. In order to accomplish the Purpose noted above, the Child Cancer Fund suggests a donation of \$100 for each entry into the Contest, though no purchase or contribution is necessary to enter or win.

Each entry into the Contest will be represented by a number assigned to the entrant for purposes of the Contest. The numbers will be assigned in consecutive order and will be placed on the golf balls that are planned to be dropped. Golf balls used in the Contest are not purchased by Participants and do not become the property of Participants.

In order to be valid, a Golf Ball Drop entry form must be filled out completely and your entry made online at golfballdroppers.webconnex.com/PayitForwardBallDrop18 or in person prior to tee off at the Pay It Forward Golf Tournament on January 1, 2019. Each entry is deemed received in the state of Florida and must be accepted by the Child Cancer Fund to be considered valid.

No purchase or contribution is necessary to enter or win. No Purchase Contributions, which must be received by close of business December 28th, can be mailed to:

Each entry form requires the Participant's name, address, phone, and e-mail address. Only one individual may be named on any entry, and an entry may not be assigned to another person. A Participant must be at least 18 years of age on the date of the Contest, but need not be a resident of the

state of Florida. Each Participant is limited to ten entries. An entry form that is later determined to contain misstatements or to identify an individual who is otherwise disqualified to enter the Contest will be eliminated from the Contest, even if the determination of the winning numbers has already been made.

A Participant may make more than one entry into the Contest, but the Foundation requests that each entry be accompanied by the suggested donation of \$100.

4. **WINNING.** An eligible entrant whose assigned number corresponds to a winning number will be a Contest Winner. Under the planned golf ball drop, the winning numbers will be determined based on the numbered golf balls that come to rest closest to the target after being dropped. Measurement will be from the center of the target to the closest edge of the golf ball. If more than one golf ball measures identically closest to the target, then the ball with the lowest ball number will be deemed closer to the target.

If a golf ball landing in a prize-winning location is determined to correspond with an ineligible or disqualified entry, then the assignment of prizes will be made based on all those balls corresponding to eligible entries. If, for some reason, identification of those balls is no longer possible, the Child Cancer Fund reserves the right to determine additional winners by an additional means of random selection, such as a random number generator.

The odds of winning depend on the number of valid entries received.

The Contest Winners will be announced shortly following the golf ball drop and need not be present to win. Winners will receive a prize certificate on the day of the event and will receive the prize money within 2 weeks after the event. Receipt of prizes, even after such announcement or posting, is subject to eligibility review of the entry and of compliance with requirements noted below.

5. **PRIZES.** The First Place Winner will receive \$10,000. The Second Place Winner will receive \$3,000. Prize money is based upon the purchase of a minimum of 225 golf balls. If the minimum is not met, the First Place Prize will be a 50/50 split with the Child Cancer Fund of net proceeds, the Second Place Prize will be \$1,000.

6. **CONSENT AND RELEASE.** By entering the Contest, each Participant consents, without limitation or additional compensation, to the use of his or her name, voice, photograph, likeness and /or biographical information for advertising and/or trade purposes, except where prohibited by law.

By entering the Contest, each Participant releases, discharges, indemnifies, holds harmless, and covenants never to sue any of Jacksonville Golf & Country Club, the Child Cancer Fund, or sponsors and affiliated companies, along with the respective officers, directors, employees, agents, and representatives of each of those, from any and all claims, liability, loss, harm, injury, damage, cost and expense whatsoever arising directly or indirectly from the participation in the Contest, the Participant's presence at the Contest, or the Participant's receipt of a prize from the Contest.

All federal, state, and local laws and regulations apply. Participation is void where prohibited by law.

7. **TAXES AND WINNER RESPONSIBILITIES.** Receipt of prizes may be subject to federal, state, and local taxes; and all such federal, state and local taxes are the sole responsibility of an individual Contest Winner. In order to maintain eligibility for a prize, each Contest Winner will be required to furnish his or her tax identification number. If withholding is required, each winning Participant agrees to cooperate

with the Child Cancer Fund, as reasonably requested, in complying with such requirements. In addition, a Winner may be required to execute an Affidavit of Eligibility and/or further documentation to affirm the consents and releases agreed to by entering the Contest. In the event of noncompliance with any of the above conditions, the winning proceeds will be forfeited and an alternate winner will be selected.
