Nebraska taxpayers can now claim a **dollar-for-dollar tax credit** for contributions made to Opportunity Scholarships of Nebraska.

- Available to individuals, corporations, LLCs, S corps, estates and trusts.
- Dollar-for-dollar state income tax credit.
- Up to 50% or \$100k of your 2024 state income tax liability.
- Contributions fund scholarships for kids in need in your community.
- Contributors can designate funds to help kids who choose a specific school (up to two).
- Credits run out on or before **October 31, 2024**.

TAX CREDIT CONTRIBUTION FORM

Nebraska taxpayers who want to support students in need of financial assistance to attend a school that works best for them are now offered a tax credit for contributions to Opportunity Scholarships of Nebraska (OSN)! Contributions made in 2024 can be claimed on your 2024 state income taxes.

Nebraska taxpayers with state income tax liability can claim up to 50% of their liability or \$100K (or \$1M for estates and trusts). These entities with state income tax liability can claim a nonrefundable tax credit for a contribution made to Opportunity Scholarships of Nebraska (OSN): Individuals, Corporations, S corps, LLCs, Estates and trusts.
