## Assumption of the Risk and Waiver of Liability Relating to Minors Coronavirus/COVID-19

Coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Church of St. Michael, Farmington (the "Parish") has put in place measures to reduce the spread of COVID-19. However, the Parish cannot guarantee that your child(ren) or other volunteers or staff will not become infected with COVID-19. Further, attending an event at the Parish could **increase** the risk of contracting COVID-19 for you and your child(ren).

By signing this Assumption of Risk and Wavier of Liability document, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) listed below ("Child(ren)") may be exposed to or infected by COVID-19 by attending or participating in events or programs at the Parish and that such exposure or infection may result in personal injury, illness, permanent disability or death. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself and my child(ren) including, but not limited to, personal injury, disability or death, damage, liability, or expense of any kind, that I or my Child(ren) may experience or incur in connection with their attendance at events or programs at the Parish ("Claims"). I hereby release, covenant not to sue, discharge, and hold harmless the Parish, its directors, officers, employees, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, or costs of any kind arising out of or relating thereto that me or my child(ren) may suffer. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Parish, its directors, officers, employees, and representatives, whether a COVID-19 infection occurs before, during, or after my child(ren)'s attendance of events or program at the Parish.
