I. JOB SUMMARY

Responsible for all administrative duties that are not directly related to instruction and student achievement including assisting the principal, dean of students, and preschool director in managing school and preschool activities, supervising of school office volunteers, and marketing and promotional activities.

II. ESSENTIAL JOB RESPONSIBILITIES

I. ADMINISTRATIVE SUPPORT

- Manage all school scheduling, special events, field trips, cafeteria, transportation, playgrounds and cleaning
- Assist in managing community use of school site
- Monitor school and preschool budget and purchasing
- Responsible for whole School Safety Plan: disaster preparation, fire drills, student, staff and public safety, and student health
- Maintain equipment, textbook and supply inventories for both school and preschool
- Coordinate with the principal and dean of students to maintain a positive, safe learning environment for students by enforcing school discipline plan
- Monitor student attendance and coordinate efforts to improve student attendance
- Responsible for school and preschool public relations, marketing and communications plan: promote the school through positive relations with the community, businesses, students and parents
- Coordinate and communicate activities schedules between the school and preschool
- Update and maintain website and social media forums
- Supervise, schedule and evaluate volunteer and non-instructional classified staff on site
- Schedule substitute teaching staff as necessary
- Process registrations, grant and tuition assistance applications for both the preschool and elementary school
- Maintain student files, keeping sensitive information confidential
- Update processes to increase efficiency and transition to digital mediums
- Research and apply for grants available to the school through the Catholic Foundation and other resources
- Primary communicator for the school and preschool (Flocknotes, Facebook, emails, letters, etc.)
- Assist principal with speech writing, presentations, and meetings
- Log and deposit school cash receipts
- Follow-up with delinquent school tuition accounts
- Other duties as assigned
