ZERO TOLERANCE AGREEMENT

There is a Zero Tolerance Rule in effect – This rule states that any parent, child, fan or coach behaving in an unsportsmanlike fashion will be punished by a suspension. For any additional infractions, it would mean a possible suspension of the child and siblings from the program. There is no Tribunal or Judgment made, if there is involvement there will be Mandatory suspensions and actions taken against all parties. There will be an interview regarding the facts of the incident, but regardless all parties involved will suffer some punishment. Self-Control during these incidents is everyone's responsibility.

Code of Conduct for Parents/Spectators:

- I will encourage good sportsmanship by demonstrating positive support for athletes, coaches, game officials, volunteers and administrators at all times.
- I will place the emotional and physical well-being of all athletes ahead of any personal desire to win.
- I will support the coaches, officials, volunteers and administrators working with my child in order to encourage a positive and enjoyable experience for all.
- I will remember that the game is for the athletes, not for the adults.
- I will ask my child to treat other athletes, coaches, game officials, volunteers, administrators and fans with respect. I will always be positive.
- I will always allow the coach to be the only coach.
- I will not get into arguments with the opposing team's parents, athletes or coaches. I will not come onto the field for any reason during the game.
- I will not criticize coaches, officials or volunteers.
- I must be authorized by the St. Charles Parish to be a parent volunteer when working on the field with the children. Failure to comply with this rule can mean possible suspension.
