Good Shepherd Scholarship covers 75% of tuition.

For families over 250% of poverty level, the Good Shepherd **Family Tuition Cap** will cover over three children who attend Catholic schools. The K-8 school will receive \$1,800 per student.

So the Good Shepherd covers \$1,800 and St. Teresa's will cover the remainder of tuition. The technology fee will still need to be paid by the family.

St. Teresa's will work to make sure that no child is turned away due to financial need.

Participation in FACTS is required for any financial assistance. We ask that everyone fill out the FACTS application by March 31, 2024. FACTS is a third party firm used to assess financial information. All information will be confidential. If a household doesn't fill out FACTS, they will not be eligible for a scholarship from the Good Shepherd Scholarship Fund nor St. Teresa's.

The tuition for out of parish students with Parish Verification form is the same as above.

St. Teresa parish scholarship is not offered to Out-of-parish students unless prior agreement with Pastor is made to fund scholarships.

Catholic Students without a signed Parish Verification form will be charged double in-parish tuition per student and are not eligible for the St. Teresa parish scholarship.

Non-Catholic students will be charged double in-parish tuition per student, and are not eligible for the St. Teresa parish scholarship.
