We have performed the procedures agreed to with the management of Follow Me Trades, LLC (the Company) as enumerated below, with respect to information provided by management of the Company regarding equity trades listed on the Company's website, *followmetrades.com*, during the period from July 1, 2017 through September 30, 2017. These procedures were performed solely for the purpose of providing information regarding the consistency of equity trade information listed on the Company's website with brokerage statements provided to us by management of the Company.

Our engagement to apply agreed-upon procedures was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of the procedures is solely the responsibility of those parties utilizing the report. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below for the purpose for which this report has been requested or for any other purpose.

Because the agreed-upon procedures enumerated below do not constitute an examination, we will not express an opinion on the agreed-upon procedures. In addition, we did not perform any procedures beyond those enumerated below.

Enumerated Procedures:

1. Obtain from management of the Company a listing of equity trades listed on the Company's website, *followmetrades.com*, for the period from July 1, 2017 through September 30, 2017.
2. Obtain from management of the Company the monthly brokerage statements for persons identified by management as being related to Dean E. Jenkins, the founder and sole member of the Company, for the period from July 1, 2017 through September 30, 2017

3. Determine that the equity trades on the listing provided were shown under the “2017 Trade Details” tab on the Company’s website.
4. Determine that transactions appear on the brokerage statements that are consistent with the listing of equity trades provided. Document any discrepancies.
5. Prepare a report on the results of the procedures performed. **Results from Applying Agreed Upon Procedures:**
