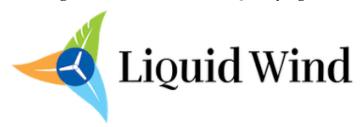

Glossary of Terms

The following is a glossary of certain terms used in this offering memorandum including the summary hereof. Terms and abbreviations used in the financial statements of the Company and in the appendices to this Offering Memorandum are defined separately, and the terms and abbreviations defined below are not used therein, except where otherwise indicated.

Words importing the singular, where the context requires, include the plural and vice versa and words importing any gender include all genders.

All dollar amounts herein are in Canadian dollars, unless otherwise stated.

"Accredited Investor" as defined in National Instrument 45-106 – Prospectus Exemptions;

"Associate" when used to indicate a relationship with a Person, means:

- (a) an Issuer of which the Person beneficially owns or controls, directly or indirectly, voting securities entitling the Person to more than 10% of the voting rights attached to all outstanding voting securities of the Issuer;
- (b) any partner of the Person;
- (c) any trust or estate in which the Person has a substantial beneficial interest or in respect of which the Person serves as trustee or in a similar capacity; and
- (d) in the case of a Person who is an individual
- (i) that Person's spouse or child, or
- (ii) any relative of that Person or of his spouse who has the same residence as that Person;

- 2. The amounts to be raised by this offer are part of Liquid Wind AB's Series A round and are being raised through the LW CommunityTWO AB entity acting as Issuer for this offering. Liquid Wind AB will cover all expenses noted in Table 1 enabling LW CommunityTWO AB to allocate the maximum offering amount to the use of funds objective in Table 2.
- 3. Note that the maximum raise amount of \$2,250,180 is for the LW CommunityTWO AB entity and does not apply to the overall Liquid Wind AB Series A round. As at the date of this offering Liquid Wind AB has raised ~\$1,000,000 for their Series A round. These amounts have been raised directly through Liquid Wind AB and LW Community AB.

1. The Issuer will use the funds to purchase Common Shares in Liquid Wind AB, a related party to the issuer. The Issuer's shares will be invested into Liquid Wind AB on a 1-1 ratio. 1.3 *Reallocation* - We intend to spend the available funds as stated. We will reallocate funds only for sound business reasons.

Until the use of proceeds are deployed as outlined above, the Company intends to invest the net proceeds of the Offering in short-term, interest bearing deposits. The Management of the Company is responsible for executing the investment policies of the Company.

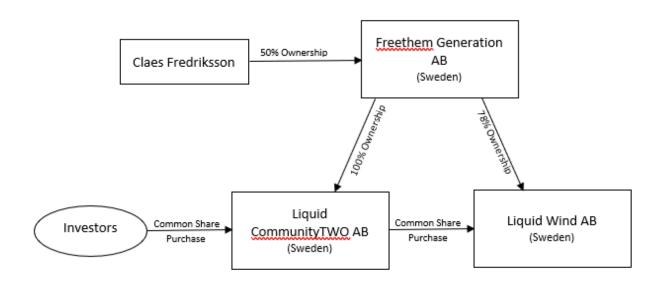
Item 2: Business of Issuer

2.1 *Structure* - LW CommunityTWO AB (referred to as the "Issuer", "Company", "us", or "we" in this Offering Memorandum) was incorporated on October 22, 2020 with the corporate number 559278-3228 pursuant to Swedish Corporate Law. The head office of the Issuer is located at Sven Hultins Plats 2 Göteborg 412 58, Sweden.

As described in Item 2.2 *Our Business* the Issuer will purchase Liquid Wind AB Common Shares with the funds raised through this offering on a 1 to 1 basis. Liquid Wind AB (referred to as the "**LWAB**" or "**Liquid Wind**" in this Offering Memorandum) was incorporated on May 30, 2017 with the corporate number 559113-8267 pursuant to Swedish Corporate Law. The head office of

the Issuer is located at Sven Hultins Plats 2 Göteborg 412 58, Sweden. Liquid Wind AB is a related party to the Issuer. Claes Fredriksson is the CEO of both Liquid Wind AB and the Issuer.

2.2 *Our Business* – The Issuer will use funds raised in this offering to purchase Common Shares in Liquid Wind AB. The Issuer is not a subsidiary of Liquid Wind AB but does share the same CEO as Liquid Wind as noted in Item 2.1. Liquid Wind AB will use the funds from the share purchase for basic engineering, securing off-take agreements, salary, and office overhead costs. Liquid Wind AB is a pre-revenue company in the start-up phase.



Liquid Wind AB's business focus is to develop eMethanol production facilities in Sweden, Scandinavia, and worldwide. We will focus initially on Sweden - one of the leading countries in the world for renewable energy investments with the lowest cost of renewable electricity¹ in Europe. Canada also offers an ideal location, with strong conditions to convert low cost renewable electricity into carbon neutral fuel, and Liquid Wind is already in discussions with potential Co-developers for Canada.

The business model is to structure special purpose vehicles (SPVs), these entities will build, own, and operate the eMethanol production facility. The revenue stream for each SPV will be generated from an off-taker of the eMethanol produced, based on long-term purchase agreements, eMPAs, for periods of up to 10 years. All relevant costs, including renewable electricity, will be fixed under long-term contracts to create a stable long-term revenue stream. Based on such long-term contractual structures for costs and revenues, equity investors in SPVs will have a stable

revenue stream, ultimately giving investor access to a predetermined revenue for the projects. Liquid Wind AB will primarily generate revenue from the sale of ready-to-invest eMethanol SPVs to equity investors, like pension funds or infrastructure funds.

The Business Model



The business model of Liquid Wind AB is to develop and structure Special Purpose Vehicles (SPVs) that will build, own and operate eMethanol facilities. Revenue streams for these SPVs will be generated from long-term purchase agreements (eMPAs) with a bankable off-taker for periods of 10-20 years, intend to provide long term fixed revenues. The SPV will also carry all relevant contracts, land rights and permits. LWAB main revenue stream summary:

- a) Development Revenue at each financial close. LWAB will primarily create revenues from the sale of ready-to-invest eMethanol SPVs to equity investors. As an alternative, LWAB may keep a minority ownership in SPVs, providing a revenue stream for SPV operation and the possibility to sell out once operation is proven and value has increased.
- **b)** Energy optimization and ancillary services for the SPV. LWAB will offer equity investors (SPV owners) a long-term partnership, including energy optimization to capture value from the inherent facility flexibility in the electricity market.
- c) Co-development packages sold to local developers around the world.

a. Development revenue at each financial close

To reach Financial Close for an SPV, LWAB need to secure a long-term fix-priced eMPA purchase agreement, with favourable terms. Here LWAB is targeting the Marine sector as potential first-mover buyers, with an interest to profit on improved value proposition of carbon neutral fuel. The target is to sell 100% of the eMethanol production through such eMPA.

Liquid Wind intends to enter into a long-term Power Purchase Agreement, providing investors in wind power with a new route for the off-take necessary for realising new wind projects. By providing a power purchase agreement (PPA) for a new wind farm, Liquid Wind will achieve "Additionality" in addition to Guarantees of Origin, further enhancing the sustainability profile of

eMethanol. For access to CO₂, as well as for sites and permits, LWAB need to enter into similar long-term agreements. For CO₂ access, LWAB target the Pulp & Paper industry, an industry based on long-term investments and commitments. LWAB aim to acquire separate real estate for each eMethanol facility near the pulp mill. Permits will be a prerequisite and an eMethanol facility falls under the normal industrial permitting process as an "A-class" permitting process, handled by the Land and Environment Court.

For the construction of the eMethanol facility, Liquid Wind has engaged a bankable EPC company which will help with the construction of a turn-key facility, in a timely and efficient manner. To capitalize on the experience learned in the Nordic wind industry, Liquid Wind will engage relevant Legal and M&A expertise.

b. Energy optimization and ancillary services for the SPV

LWAB will offer equity investors long-term cooperation for operation and maintenance (O&M) of eMethanol facilities. This includes 24/7 operations, technical revisions, operational improvements and SPV administration. Such O&M cooperation will provide LWAB with a stable base revenue stream.

LWAB intends to also offer the SPV investors an alternative source of revenue, a service to optimize the operation to utilise the flexibility of the facility. The facility flexibility opens the possibility to trade based on the long-term PPA price/volumes. In periods where the market price is below the PPA price, production will be ramped up, and vice versa in periods where market prices are above the PPA price. Given the high price volatility, the value to be captured is substantial. Such operation is included in the facility specification and can be implemented without jeopardising the operational reliability. A simulation for a standard facility (70 MW/495 GWh/y) based on spot prices the last 4 years (2016 – 2019) indicate a value of more than 1 MEUR/y in average. With future increased penetration of wind power and increasing price volatility, the possibility to capture value will most likely increase.

In addition, the short-term flexibility of the facility opens for offering ancillary services (frequency control) to the transmission system operator.

c. Co-development packages sold to local developers around the world

To facilitate the transition to fossil free transport sector, scaling and accelerating fossil free fuel production is going to be crucial in the next 20-30 years. Therefore, Liquid Wind will standardize facilities and work to improve the technology and cost efficiency with each subsequent facility. Knowledge gained in the previous projects would be analysed and simulated for future projects,

using a "digital twin" concept would enable the reduction of time and cost for developing further projects. This knowledge generated in Liquid Wind development phase would be valuable assets to local developers who are interested in implementing eMethanol projects in their home countries. LWAB will lay the groundwork for licensing during first few projects with an ambition of licensing for future projects. LWAB has already received several letters of interest for such cooperation.

Why focus on the Nordics

Access to renewable electricity at low prices is important for the production of cost-competitive eMethanol. Equally important is access to capital - equity and debt. This context supported the successful expansion of wind power in the Nordic market. This development will both give Liquid Wind access to low cost renewable electricity and serve as a template for the financing structure of our project portfolio. The Nordic power market has seen a strong buildout of renewable onshore wind power. As of today, we have seen investment in a total capacity of around 12 GW / 40 TWh since 1995, of which most investments have been done during the last 5 years. Further investments are likely in the coming years, with another 8 GW / 30 TWh of permitted and well-developed projects close to Final Investment Decision (FID). In the Swedish market, wind energy currently has a share of 28%, expected to rise to above 40% by 2025.

One major reason for the strong development during the last few years is the way wind projects are structured. Today's projects are large (typically > 200 MW) and structured for project financing as Special Purpose Vehicles (SPVs). In these structures, off-take agreements provide the necessary revenue security and all major contracts for capital expenditures and operational expenses are equally secured long-term. This structure has proven bankable and has been the most important factor in attracting close to 9 Billion EUR of equity into Nordic wind investments over the last 5 years. Given the general low returns in conventional long-term investments, it is expected that the Nordic wind market will continue to attract long-term capital.

Why Sweden: Feasibility and Milestones

In producing carbon neutral eMethanol there are two extremely important components to consider: electricity price and CO₂ supply. Electricity price constitutes two thirds of the total production cost and low prices are important to ensure a viable business case for eMethanol.

LWAB have undertaken a study to assess the most favourable location for the first eMethanol facilities and decided to focus on northern Sweden. Here we see the possibility to source renewable electricity from wind and access biogenic CO₂ from the Pulp & Paper industry at very favourable

conditions. This will allow LWAB to produce eMethanol at the lowest possible cost, compared to the global market.

The rapid increase in wind power in the Nordics has impacted the Nordic power market fundamentally. In Sweden we see that most of the new wind capacity in the northern price zones (SE1, SE2) with a clear transmission bottleneck down to the high-demand southern price zones (SE3, SE4), results in a systematic lower long-term price (3 - 5 EUR/MWh) in SE1/SE2 compared to southern Sweden. In the northern regions we see well-developed large new wind projects with favourable wind conditions reaching low Levelized Cost of Energy (LCoE). Information from leading developers and the Financial Advisor Newsec, indicate LCoE of around 25 EUR/MWh for the best projects. Several of these projects have permits and investment decision as depending on securing a long-term power purchase agreement. Historically such PPAs have been offered by power traders but given the low liquidity in the long-term forward market, developers and equity investors are increasingly seeking corporate buyers for PPAs. This opens a good opportunity for LWAB to secure long-term fixed-price Power Purchase Agreements at potentially favorable price (below 30 EUR/MWh).

To facilitate cost-efficient carbon capture, the project facility will be located close to a large emitter of CO₂. LWAB have identified the Pulp & Paper industry as a potential suitable partner as the CO₂ is of biogenic origin, at sufficient volumes/concentration and with excellent opportunity for process integration which will enable cost reductions. LWAB has secured initial interest from multiple potential partners in the Pulp &Paper industry in Sweden for access to biogenic CO₂ as a feedstock for our projects. These include Södra Cell, Billerud Korsnäs, Smurfit Kappa, Holmen, SCA, and Stora Enso. Through these discussions, we have identified 12 potential sites in northern Sweden for establishing eMethanol facilities.

Why Canada

Canada has a strong and pioneering cleantech industry, including both hydrogen and carbon capture. Liquid Wind provides can potentially compliment both industries. Similar to Sweden, Canada also offers low cost renewable electricity and sources of biogenic CO₂. Canada has the right conditions to convert low cost renewable electricity into cost-effective carbon neutral fuel, and Liquid Wind is in discussions with potential Co-developers for Canada

Market Analysis & Target segments for eMethanol

For Liquid Wind, it is essential to focus on the market segments where sustainability and carbon neutrality have a corporate or regulatory value to justify the initially higher cost related to a carbon

neutral fuel. In addition, an off-taker will need to be bankable and able to purchase most, if not all of the production capacity from a standard facility.

Based on these criteria Liquid Wind has focused on the marine sector where leading players have committed to reducing their carbon footprint. In addition, the Obligatory Blending Schemes for petrol/gasoline introduced in many EU member states represent growing demand for carbon neutral fuel alternatives.

The Marine sector

While mandatory CO₂ reduction schemes are not yet imposed in the marine sector, many initiatives have been taken by the industry, driven by public and customer demand for climate action. The IMO (International Maritime Organization) has adopted a strategy to reach a 50% reduction of GHG by 2050². The CLIA (Cruise Lines International Association), has committed to even higher ambitions; a 40% reduction by 2030. A strong sign of the direction the shipping industry is taking is seen in a statement by the Danish shipping company Maersk in late October 2019, where they identified alcohols (methanol, ethanol) as one of three renewable fuels that they will focus on to reach a carbon neutral shipping fleet by 2050. Since methanol is a classified and ready-to-use marine fuel, eMethanol provides a carbon neutral alternative that can be implemented near-time. Another advantage is that the conversion of vessels to methanol can be made at a considerably lower cost compared to LNG or other renewable gaseous fuels such as hydrogen.

An important development is the introduction of low-carbon freight products from some of the leading players. One example is Maersk who have introduced their 'Eco Delivery' product³. A freight buyer can choose zero-carbon freight at a premium price. This product is based on biodiesel type fuel operation of a container vessel and a virtual transfer of the zero-carbon element to the appropriate freight route under a certified procedure. A similar low-carbon shipping product was introduced by Stena Bulk during 2020 with positive market reactions and high media attention. The emergence of such shipping products illustrates how market demand is driving the switch to low-carbon business models. It also illustrates the marketing possibilities for the players that take the lead and drive the transition to carbon neutral business operations.

Under current circumstances it is our opinion that the marine sector will be the market segment most interested in converting to eMethanol at scale. We also see the marine sector as the primary

potential buyer of long-term eMPA off-take agreements necessary to reach financing of the eMethanol facilities.

Obligatory Blending Scheme

To speed-up the clean transition in road transport, in addition to EVs (electric vehicles), Sweden has introduced an Obligatory Blending Scheme "Reduktionsplikten" (Reduction quotas), requiring a minimum renewable fuels component in petrol and diesel. Similar systems have been introduced in line with the Renewable Energy Directive II (RED II), requiring EU member states to reach a minimum of 14% renewable content for the energy consumed by road and rail transport by 2030⁴. Such schemes are based on a quota obligation to blend-in eligible renewable fuels, based on an approved calculation of GHG emissions.

As of today, renewable fuels for blending are mainly of biological origin (biofuel). With an expected sharp rise in demand, the supply of biofuels will not be able to meet demand. Access to e-fuels (renewable fuels of non-biological origin (RFNBO)) is expected to play an important role in meeting these quotas. Under RED II, e-fuels must be based on renewable and additional electricity.

For LWAB and investors in eMethanol facilities, such Obligatory Blending Schemes will deliver increasing demand for carbon neutral fuels driven by legislation, supporting the market price for eMethanol.

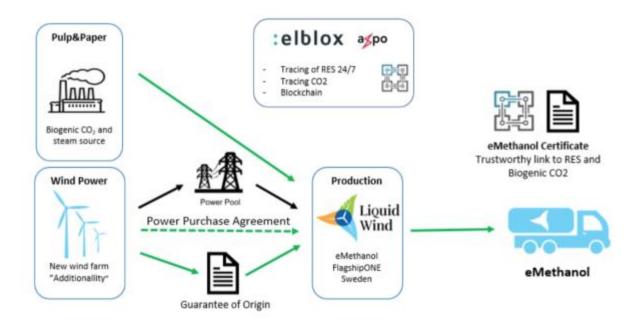
GHG Tracking

Production of eMethanol based on new (additional) renewable electricity intend to have close to zero up-stream (Scope 1 and 2) GHG emissions. To ensure trustworthy tracking of the renewable electricity and biogenic CO₂, LWAB intend to implement a Blockchain-based tracking system called Elblox, developed by Axpo. By using Elblox, LWAB will be able to link each MWh of renewable electricity and ton of biogenic CO₂ to a unit of eMethanol to create an eMethanol Certificate that will prove upstream GHG emissions.

By using Blockchain technology, Liquid Wind will create the necessary trustworthiness for the eMethanol Certificate to be used in GHG accounting. The Blockchain technology also allows for

down-stream integration of GHG emission tracking through the value chain, enhancing the sustainability value of the eMethanol. The figure below illustrates the principle.



Competitive Advantage

Most of today's fossil fuel will need to be replaced during the coming 50 years to reach the targets in the Paris Agreement⁵. The size of this market is enormous, and the production facilities needed for e-fuel, biofuel and electrification will all have to be developed, from renewable electricity generation to energy storage/distribution infrastructure. This is a large undertaking and will require the efforts and collaboration of thousands of companies globally for the next 30 years.

Within electro-fuel development, we believe location is a key factor and identifying the locations with access to low-cost renewable electricity, CO₂ and suitable logistics in combination with the ability to acquire permits is crucial.

LWAB has developed a potentially high-growth business model for developing and financing large numbers of standardised facilities that has several potentially competitive advantages compared to other competing renewable fuel providers:

- 1. Site locations at Pulp & Paper mills in the north of Sweden, where low-cost wind power is available:
- 2. A standard and modular plant design, based on the Digital Twin concept that can be quickly and cost effectively replicated;
- 3. Facility equipment provided by leading technology suppliers, which will cover all technical solutions from feedstock to end-product, including support with development and construction, as well as operation of the eMethanol facilities;
- 4. An operational platform that allows for centralised facility management, where multiple facilities can be managed simultaneously and, via machine learning also, learn from each other:
- 5. Sustainability tracking based on Blockchain technology that enables GHG tracking for the end customer and justifies added value of eMethanol; and
- 6. Possible revenue increase by utilizing the facility flexibility for energy optimization and ancillary services based on the operational platform.

Project facility design philosophy

The standard and modular Liquid Wind production facility design will have an annual capacity of 50,000 tons of eMethanol utilizing 70,000 tons of upcycled CO₂. Developing a standardized and modular facility design will facilitate cost-efficient expansion.

Liquid Wind will implement a so called "Digital Twin" concept for the design, engineering, and integration of technology into a coordinated and efficient eMethanol facility concept. By using the Digital Twin, LWAB will secure the Intellectual Property (IP) developed during the facility design. This IP will be important for LWABs expansion.

The Digital Twin is a virtual model of the process, which allows the pairing of the virtual and physical worlds to support the analysis of data and monitoring of systems to avoid problems, prevent downtime and plan for the future through simulations. The ultimate vision for the Digital Twin is to create, test and build our facilities in a virtual environment. Once in operation, the facility links back to its digital twin through sensors, so that the digital twin contains all the information, including maintenance monitoring, that is otherwise only available by inspecting the physical build.

To facilitate cost-efficient carbon capture, Liquid Wind aim to locate each eMethanol facility near the emitting industry where the CO₂ is captured. We see beneficial process integration between the eMethanol facility and a paper mill, creating value by utilizing waste resources. A cooperation

with a Pulp & Paper company with internal biomass-based CHP (Combined Heat and Power) production, also opens the possibility for Liquid Wind to benefit from existing grid connection agreements.

2.3 Development of Business

LW CommunityTWO AB is a newly formed entity with an incorporation date at October 22, 2020 with no business operations. Liquid Wind AB is the entity which LW CommunityTWO AB will be purchasing Common Shares in during the start-up phase.

During 2016-17, Liquid Wind AB performed a feasibility study to evaluate technical, safety and commercial viability of an eMethanol facility. The study involved 9 organisations for a period of 5 months. Following the conclusion of the study, our expert engineers developed a standardised and modular facility design to support a profitable business case. In 2018, LWAB ran a bidding process to select the technology supply partners to form a consortium to develop multiple eMethanol facilities. In 2019, LWAB raised capital in the seed round and expanded the team to kick start the operation. Further, the selection of strategic partners was completed with agreements signed confirming the participation of all technology partners to supply the components of the LWAB project facility: Carbon capture, Electrolysis, and Methanol synthesis.

2.4 Long Term Objectives

Development targets are:

- to establish a strong, leading, and profitable company, well positioned in the renewable market, a position that makes Liquid Wind AB a preferred partner for future clients.
- to establish close-working, long term relationships with world class equipment vendors as well as with reputable construction companies.
- to engineer a standard, modular & replicable facility design.
- to structure eMethanol facilities as attractive bankable investment opportunities (SPVs).

Operational targets for the first five years of operation are:

- to reach financial close for the first project in early 2022 and additional 2 projects by EOY 2023.
- to reach completion and operation for the first facility by EOY 2023 and additional 2 facilities by EOY 2025.
- to commission at least one project per year for subsequent years (10 facilities in total by 2030).
- Deploy co-development concept to support rapid scaling.

LWAB potential targets for Investor are:

- to generate development revenue from the projects (SPV) developed and sold to equity investors and financial close in line with budget;
- to offer a buy back option for early investors during the period 2025 2026;
- to list Liquid Wind AB at a stock exchange after 2030.

Actions to reach these overall targets comprise of – but are not limited to – the following:

- Develop and secure a portfolio of sites with access to biogenic CO₂ and land/permits, utilising our strong network to identify and develop promising projects in Scandinavia.
- Position eMethanol as a carbon neutral fuel and market eMPA as a business practice for sustainable Corporate fuel purchase.
- Drive down facility investment costs by collaborating with state-of-the-art technology suppliers.
- Position LWAB's SPVs as a preferred and bankable buyer of PPAs to secure lowest price for renewable electricity.
- Develop the LWAB Co-Development Package to facilitate licensing.
- Safeguard that LWAB attracts quality personnel with relevant competence and experience, both for the daily activities as well as for the operation of SPVs.
- Continuous market analysis for development of new projects, new collaboration partners and clients as well as the latest technical innovations.
- Maintain financial strength to secure efficient and successful project development with high level of quality.
- Implementation of the LWAB's code of conduct in all LWAB's projects.

2.5 Short Term Objectives

In 2020 and 2021, LWAB will work to secure exclusive rights to CO₂ and sites for minimum 3 facilities. LWAB has signed LOIs with 2 Pulp & Paper companies and 1 municipal CHP plant, with the target to sign Term Sheets with exclusivity. In addition, a strong focus is to reach binding eMPA off-take agreements to potentially secure the revenue stream. As of today, LWAB has obtained multiple LOIs from marine players such as Maersk, Stena and Marinvest. LWAB is in dialogue with several infrastructure funds potentially interested to be equity investors in eMethanol facility SPVs.

The next stage for the project is basic engineering for the first facility, leading to financial close in early 2022. LWAB is working with the development of several projects in parallel, with the ambition to reach financial close for 3 facilities by EOY 2023.

Liquid Wind AB's management anticipates that revenue received from sales and funds from additional financings will be sufficient for it to meet its objectives, however there is no assurance that such revenue will result or that additional financing will be available. The Issuer and Liquid Wind AB may have to curtail its operations if revenue does not increase as expected or additional financing is not available.

Item 5: Securities Offered

5.1 Terms of Securities- Material terms of the securities being offered, including:

- a) *Dividends*: Subject to the provisions of the issuer's articles of incorporation the Board of Directors may declare a dividend in such amounts and payable in such manner as the Board of Directors may from time to time determine.
- **5.2** The Issuer will be using funds from this offering to purchase Common Shares in Liquid Wind AB. The Liquid Wind AB Common Shares have the following terms, as of the date of this Offering Memorandum ¹:
 - a) Each Common Share confers the right to one vote and the right to dividends, when declared.
 - b) Right of first refusal. The Shares shall be subject to rights of first refusal and in the case of a sale of Shares to a third party which may trigger the drag-along provisions set below, the rights of first refusal shall apply on a "first look" basis where the existing shareholders shall be offered Shares for sale first, but if not taken up, these Shares shall be available (on those same terms and at same price offered to existing Shareholders) to a third party. These are set out in the rights of first refusal clause in the Company's Articles of Association. In conjunction with transfer and buy-out of Shares pursuant to the provisions set forth below, the rights of first refusal rights clause in the LWAB's Articles of Association shall not apply.
 - c) Tag-Along. In the event the Majority Shareholder or Parties holding at least 66% of the Shares in the LWAB wish to transfer their holding of Shares to one or more third parties acting in cooperation (for the avoidance of doubt, a third party in this provision also includes another Party), and the Shares are not transferred according to the provisions in clause (b) above (right of first refusal), all the other Parties shall be given the opportunity to transfer their Shares to the transferee on the same terms and conditions as the transferring Party has been offered (so-called Tag-Along). However, the purchase price shall always be payable in cash if required by the Parties exercising their tag-along right. In the event the transferee does not want to buy all Shares, each Party are afforded the opportunity to sell their shares in proportion to the Parties' holding of Shares. The time stipulated for the other Parties' acceptance may not be less than 20 (twenty) Business Days from the Parties' receipt of the offer.
 - d) Drag Along. In the event one or more third parties acting in cooperation makes an offer for all Shares and the offer is accepted by the Majority Shareholder and at least one of the other Shareholders, holding a total of at least 75 (seventy-five) percent of the Shares in the LWAB, the other Parties undertake to transfer their

Shares at the price per Share and on the terms and conditions set forth in the offer. The other Parties shall not be obligated to transfer their Shares pursuant to this section unless the transfer takes place on no less than market rate terms and the Parties are treated equally in respect of the price per Share and other terms and conditions for the transfer. Item 8: Risk Factors

The risk factors outlined below are not a definitive list of all risks associated with an investment in the Shares offered hereunder but are limited to those risks the Company considers material. Additional risks that the Company does not currently know about or that it currently believes to be immaterial may also impair its business operations. Solely for this section (Item 8) the Company shall be defined as both "LW CommunityTWO AB" and "Liquid Wind AB".

8.1 Investment Risk

Securities are Speculative

The securities offered hereunder must be considered highly speculative and an investment in such securities involves a high degree of risk. Due to the nature of the Company's business and the present stage of development of its business, the Company may be subject to significant risks. The Company's actual operating results may be very different from those expected as at the date of this Offering Memorandum in which event the trading price of the Shares could decline, and a subscriber may lose all or part of his or her investment.

Restrictions on Transfers and No Public Market

There is presently no public market for the Shares and none is expected to develop in the foreseeable future. The Shares are also subject to substantial restrictions on transfer under securities laws, and the Articles of the Company. Accordingly, the Shares may not be resold or otherwise transferred, except in accordance with the Articles of the Company or in accordance with such applicable Canadian securities laws. There can be no assurance that the tax laws will not be changed in a manner which will fundamentally alter the tax consequences to investors of holding or disposing of the Shares.

Dilution

After completion of the Offering, then existing Shareholders may have their interests diluted. The exercising of outstanding stock options or warrants will also have a dilutive effect on the interests

of the purchasers of the Shares. Moreover, in the event the Company requires additional equity financing pursuant to the Shares offered under the Offering, purchasers of the additional Shares may experience further dilution to the extent that such Shares may be issued for a value less than the price paid for conversion of Shares acquired hereunder. 8.2 Issuer Risk

Limited Operating History

The Company is in the start up stage with limited operating history. As a result, there is no guarantee that the Company will achieve its investment objectives or earn a positive return, nor is there any assurance that the Company will achieve any or all of its short- and long-term business objectives detailed above.

Foreign Exchange

The Company is incorporated and based in Gothenburg, Sweden. This offering is being conducted in Canadian Dollars and fluctuations in the exchange rate between the Canadian Dollar and the Swedish Krona may impact the value of your investment.

Management and Personnel Risks

The Company's business will be significantly dependent on Liquid Wind AB's management team including outside management advisors and consultants. The loss of the Company's officers, other employees, advisors or consultants could have a material adverse effect on the Corporation. The Company's success depends, in part, on its ability to attract and retain key, technical, management and operating personnel, including consultants and members of the Company's Board. The Company needs to develop sufficient expertise and add skilled employees or retain consultants in areas such as research and development, business management, editorial staff and marketing in order to successfully execute its business plan. The Company may be unable to attract and retain qualified personnel or develop the expertise needed in these areas. If the Company fails to attract and retain key personnel it may be unable to execute its business plan, or its business could be adversely affected. The Company does not maintain key man insurance on any member of its management.

Inability to Manage the Potential Growth of the Business

The Company may be subject to growth-related risks including capacity constraints and pressure on its internal systems and controls. The ability of the Company to manage growth effectively will

require it to continue to implement and improve its operations and financial systems and to expand, train, and manage its employee base. The inability of the Company to deal with potential growth could have a material adverse impact on its business, operating results, financial condition or profitability. Any expansion of operations the Company may undertake will entail risks; such actions may involve specific operational activities, which may negatively impact the profitability of the Company. Consequently, Shareholders must assume the risk that (i) such expansion may ultimately involve expenditures of funds beyond the resources available to the Company at that time, and (ii) management of such expanded operations may divert management's attention and resources away from any other operations, all of which factors may have a material adverse effect on the Company's present and prospective business activities.

Further Need for Debt or Equity Financing

The Company may have to sell additional securities including, but not limited to, Shares or some form of convertible security, the effect of which will result in a dilution of the equity interests of any existing Shareholders. The Company may also need to raise capital by incurring long term or short-term indebtedness in order to fund its business objectives. This could result in increased interest expense or decreased net income. Security holders are cautioned that there can be no assurance as to the terms of such financing and whether such financing will be available. Moreover, neither the Company's Articles nor its By-laws limit the amount of indebtedness that the Company may incur. The level of the Company's indebtedness could impair its ability to obtain additional financing in the future on a timely basis to take advantage of business opportunities that may arise.

Development Stage of Business Risks

The Company has only a limited history upon which an evaluation of its prospects and future performance can be made. The Company's proposed operations are subject to all business risks associated with new enterprises. The likelihood of the Company's success must be considered in light of the problems, expenses, difficulties, complications and delays frequently encountered in connection with the expansion of a business, operation in a competitive industry and the development of a customer base. There is a possibility that the Company could sustain losses in the future. If the Company is unable to generate revenues or profits, investors might not be able to realize returns on their investment or prevent the loss of their investment.

Forward-Looking Statements and Information May Prove Inaccurate

Investors are cautioned not to place undue reliance on forward-looking statements and information. By its nature, forward-looking statements and information involves numerous assumptions, known and unknown risks and uncertainties, of both a general and specific nature, that could cause actual

results to differ materially from those suggested by the forward-looking statements and information or contribute to the possibility that predictions, forecasts, or projections will prove to be materially inaccurate. Additional information on the risks, assumptions, and uncertainties are found in this Memorandum under the heading "Forward-Looking Statements & Forward-Looking Information".

Litigation Risk

The Company may be subject to litigation arising out of its operations generally. Damages claimed under such litigation may be material, and the outcome of such litigation may materially impact the Company's operations, and the value of the Shares. In addition to general litigation risk, our editorial content may be controversial and may result in litigation. In the ordinary course of our business, litigation claims may be filed against us, most of which are claims for defamation arising from the publication of our editorial content. While we maintain insurance in respect of claims for defamation, some claims made against us may not be insured or may result in costs above our coverage limits. In the event that a judgement is rendered against us, there can be no assurance that our insurance coverage will cover that particular loss.

While the Company will assess the merits of any lawsuits and defend such lawsuits accordingly, it may be required to incur significant expense or devote significant financial resources to such defenses. In addition, the adverse publicity surrounding such claims may have a material adverse effect on the Company's operations.

Inability to License Other Intellectual Property Rights

If the Company is unable to obtain licenses, on reasonable commercial terms, from the holders of such other intellectual property rights, it could be required to halt development or redesign its technology, failing which it could bear a substantial risk of litigation for misuse of the other technologies. In any such event, the business and operations of the Company could be materially adversely affected.

Management Discretion as to Application of Proceeds

The net proceeds from this Offering will be used for the purposes described under Item 1.2 – Use of Available Funds. The Company reserves the right to use the funds obtained from this Offering for any general business purposes and such other purposes not presently contemplated which it deems to be in the best interests of the Company and its Shareholders. As a result of the foregoing, the success of the Company may be substantially dependent upon the discretion and judgment of the Company's Board with respect to application and allocation of the net proceeds of the Offering.

Investors will be entrusting their funds to the Company's management; upon whose judgment and discretion the investors must depend.

Operational Risks

Purchasers must take into account the lack of operating history of the Company and rely on the Company's stated ability to develop its products and services and manage and develop relationships with key strategic partners, instead of a demonstrated track record. The Company depends on partnerships with third parties that are critical to its operations and future growth. If the Company is unable to develop and maintain these critical relationships, its ability to offer its products and services and roll out advanced services may be delayed, and its business, financial condition and results of operations could be materially adversely affected.

Long-term Off-take – eMPA

Securing long-term sales agreements for eMethanol (eMPA) is essential for the Liquid Wind AB business model. There is no guarantee that long-term off-take agreements will be secured. There is a risk that this market will take time to materialize and the sustainability focused marine industry will still choose price over sustainability in a tough economic climate. To bridge such gaps, and to incentivise early investments, through the EU ETS Innovation Fund the EU will fund up to 60% of the price gap compared to fossil fuel. LWAB will, in parallel with the dialogue with potential eMPA buyers, apply for this EU funding.

Licenses and permits

The operation of a Flagship Facility in Sweden is subject to an environmental permit. The Liquid Wind AB standard facility falls under a so-called A-class permit, handled and decided by the Land and Environmental Court. The estimated time from application to approved permit is 12-15 months, depending on complexity. Initial evaluation of the permitting process shows a clear and well-defined process applicable for any industrial process. Liquid Wind AB will engage established legal expertise for the application process. LWAB will also work closely with the CO_2 Host, to take advantage of their experience and established contacts.

There is no guarantee that LWAB will be granted a permit. LWAB estimates that the probability to reach a permit is high, given the industrial zoning in the area and that our Host is considerably bigger and has a bigger impact on the environment. Timing is often an issue with permit's and there is a risk that the permit decision could be delayed leading to delays in reaching Financial Close.

8.3 Industry Risk

Access to CO2 sources

Liquid Wind AB relies on long-term access to point-sources of CO₂, where the focus is to enter into cooperation with Pulp & Paper (P&P) companies. Historically, the interest in CCU (Carbon Capture and Utilisation) has been low in the P&P industry but given the increased focus on CO₂ emission reductions and the need to take preventive action, we see strong interest in a cooperation with Liquid Wind AB. Liquid Wind AB has ongoing dialogues with leading Nordic P&P companies and has entered into 2 LOIs during 2020. In addition, LWAB has also entered into an LOI with a biomass powered CHP plant. Liquid Wind AB sees high probability that during 2020 and 2021 the company can reach agreements for co-location and access to CO₂ for a a total of 6 facilities.

The methanol industry is subject to commodity price volatility and supply and demand uncertainty. The methanol business is a highly competitive commodity industry and prices are affected by supply and demand fundamentals. Methanol prices have historically been, and are expected to continue to be, characterized by cyclicality. Factors influencing supply and demand for methanol and related risks are found below. We are not able to predict future methanol supply and demand balances, global economic activity, methanol prices or energy prices, all of which are affected by numerous factors beyond our control. Since methanol is the only product we produce and market, a decline in the price of methanol has a significant negative effect on our results of operations and financial condition.

Power Purchase

The Liquid Wind AB business case is based on sourcing renewable power from new wind power generating facilities in the Nordic market. This will depend on the overall bankability of the SPV financing structure, and ultimately the creditworthiness of the buyer of eMethanol. It is the ambition of Liquid Wind AB to contract a long-term (min 10 year) off-take agreement (eMethanol Purchase Agreement, eMPA) with an investment-grade buyer.

Industry Relationship Risks

If the Company fails to develop and maintain relationships with industry participants, its business could suffer. The business operations of the Company will depend, in part, on agreements with industry partners for the sale of its products and services.

Technological Changes

The long-term success of the Company's operations may be limited by its ability to adapt to significant advancements in both the equipment and the technology used in its operations. The

rapid pace of development in this industry has been evident over the last few years and is likely to continue into the future. The Company can provide no assurances that it will stay abreast of technology trends and if it fails to do so, it may not be able to adapt its products and services to new technologies in a timely manner, the Company may lose customers and its revenues will suffer.

Regulatory Risks

The direct regulations for e-Fuels falls under the RED II directive. Currently there is on-going work with two Delegated Acts covering the requirements for power sourcing for production of e-fuels. Information from the on-going work indicates that the LWAB structure, based on long-term PPA with new wind resources combined with blockchain-based temporal end geographical tracking, will be eligible for accounting the electricity as additional (close to zero GHG emission).

General Economic Conditions

The financial success of the Company may be sensitive to adverse changes in general economic conditions in Canada such as war, terrorist attacks, recession, inflation, labour disputes, demographic changes, weather or climate changes, unemployment and interest rates. There is no assurance that the Company will be successful in marketing any of its products and services, or that the revenues from the sale of such products and services will be significant. Consequently, the Company's revenues may vary by quarter, and the Company's operating results may experience fluctuations. Unanticipated obstacles to execution of the Company's business plans may change significantly as execution is capital intensive and may become subject to statutory or regulatory requirements. The Company reserves the right to make significant modifications to any of the Company's stated strategies depending on future events.

8.4 Other Risk

COVID-19

In addition to the risk factors described throughout Item 10, in January 2020, the World Health Organization ("WHO") declared a Public Health Emergency of International Concern due to a novel virus ("COVID-19") and in March 2020, declared it a pandemic. The global spread of COVID-19 has created significant worldwide operational and economic volatility, uncertainty, and disruption. The extent to which COVID-19 will impact the Company's ability to raise the required capital to implement its proposed building plans, as well as continue with its sales and marketing efforts, depends on certain developments, including but not limited to the duration and spread of the outbreak, impact on the Company's customers and its sales cycles, and its ability to attract capital, all of which is highly uncertain, rapidly changing, and cannot be accurately predicted.

Item 9: Reporting Obligations

9.1 As at the date of this Offering Memorandum, the Company is not a "reporting issuer" as such term is defined in applicable securities legislation and accordingly is not subject to most of the continuous disclosure reporting obligations imposed on reporting issuers by such securities legislation. However, Shareholders will receive, upon request, a copy of the audited annual financial statements of the Company within 120 days of the end of each fiscal year, and any other information that may be required to be delivered to Shareholders under applicable securities legislation from time to time for each jurisdiction. You may request a copy of the financial statements by contacting us at the address, numbers or e-mail address set out on the front cover.

Item 10: Resale Restrictions

10.1 General Statement

These securities will be subject to a number of resale restrictions, including a restriction on trading. Until the restriction on trading expires, you will not be able to trade the securities unless you comply with an exemption from the prospectus and registration requirements under securities legislation.

10.2 Restricted Period

Except in Manitoba and subject to the resale restrictions described in Items 10.1, unless permitted under securities legislation, you cannot trade the securities before the date that is four months and a day after the date the Issuer becomes a reporting issuer in any province or territory of Canada. 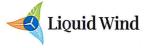

1. ORGANISATION

LW CommunityTWO AB (the "Company") is a company settled under and governed by the laws of Sweden. The registered office of the Company is located at Sven Hultins Plats 9c, Gothenburg, Sweden. The Company was established for the primary purpose of acquiring investments to develop carbon neutral fuel facilities. Liquid Wind AB ("Liquid Wind") will be the mother company that will issue shares to the company for its ownership and will also manage the day to day activities of the company. October 23, 2020, the initial capital contribution was SEK 25 000.

2. BASIS OF PRESENTATION

These financial statements of the Company have been prepared by management in accordance with International Financial Reporting Standards. These financial statements were authorized for issue by the director of the company on October 23, 2020. As there have been no operations during the period, a statement of income and comprehensive income has not been prepared. These financial statements are presented in Swedish kroner, which is the functional currency of the company.

3. SHAREHOLDERS' EQUITY

The Company has only common shares and no other types of shares. The company has authorized the issue of **8334** common shares. All Company shares issued and distributed will be directly invested into equity shares to Liquid Wind with same valuation as Liquid Wind's current round of investment. The Company elects its own board, and the Company representation will be invited to general meetings in Liquid Wind and each shareholder to the company has the same rights and obligations to request information from Liquid Wind and its shareholders.

4. COMMITMENTS

Liquid Wind is an innovative Cleantech Company, based in Scandinavia. Liquid Wind is committed in scaling access to carbon neutral fuel. 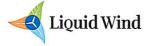
