



## FREQUENTLY ASKED QUESTIONS

### **WHAT IS PICK 'EM?**

Pick 'Em is a season-long contest in which participants pick the winners of the Sunday and early Monday night games each week, attempting to have the best record of each week and the entire season to win prizes—up to \$1,000,000 for a season-long record of 225 or more winning picks.

### **WHAT TIME DO *GAMING TODAY MILLION DOLLAR PRO FOOTBALL FRENZY* EARNING ACTIVITIES RESET AND BECOME AVAILABLE TO PLAY?**

*Gaming Today Million Dollar Pro Football Frenzy* earning activities are reset at 12:00 am.

### **CAN MY SPOUSE AND I BOTH PLAY EVEN THOUGH WE SHARE AN EMAIL ADDRESS?**

You can both play but you may not share an email address. Our system requires that every participant have a unique email address to qualify for individual rewards. To resolve this, we recommend opening a free Gmail account for one person to use throughout the program.

### **WHY DO I SEE MY SPOUSE'S ACCOUNT WHEN I LOG IN?**

When participants share a device, it is important that each completely logs out of the website using the LOGOUT link located in the top navigation bar. Closing a browser window is not the same as officially logging out and will yield different results.

### **WHY DO SOME OF THESE GAMES NOT WORK?**

Game functionality issues stem from an incompatibility with a device or browser. Most of the time, switching to Google Chrome as your browser will correct the problem. If the issue persists, please submit a ticket by using the HELP link located in the bottom navigation bar.

### **WHERE CAN I FIND MY DRAWING ENTRY BALANCE?**

You can view your current drawing entries at the top of any page, to the right of the *Gaming Today* logo on desktop and below the logo on mobile devices.

### **HOW CAN I FIND OUT WHICH OF MY EMAIL ADDRESSES IS BEING USED FOR THIS PROMOTION?**

Please click the "Need Help?" link (located on the login page) and submit a ticket to the Help Desk. The Help Desk will be able to identify the original email used to create your 2019 *Gaming Today Million Dollar Pro Football Frenzy* account and update it as necessary.



### **HOW DO I CHANGE MY EMAIL ADDRESS?**

You can submit a request to have your registered email address changed by clicking on HELP located at the bottom of any page and in the drop-down menu at the top of any page.

### **HOW DO I CHANGE MY PASSWORD?**

You can change your password by clicking on MY PROFILE, located at the top of any page in the drop-down menu, and entering your new password in the designated fields.

### **WHY HAVE I NOT RECEIVED A RESPONSE TO MY REQUEST TO CHANGE MY USERNAME OR PASSWORD?**

Password reset requests are emailed to the address that was used to register your account. Make sure you entered the correct address in the FORGOT PASSWORD window and check your spam folder. If you do not recall the email address associated with your *Gaming Today* subscription, please click the "Need Help?" link and submit a ticket to the Help Desk. They will resolve any password/email issues.

Additionally, you can add our domain name to your safe senders list to ensure you receive the email. It is also possible that your email provider has blocked the email. Some providers enforce strict blocking lists or delete emails they deem to be spam. You can check with your provider and ask them to add our domain name to their safe sender list to allow the email to come through.

### **HOW LONG DO PASSWORD RESET REQUESTS TAKE?**

Reset requests are emailed instantly to the email that was entered after clicking "Forgot Password?"

### **WHY AM I SEEING "YOUR SESSION HAS EXPIRED. PLEASE REFRESH YOUR PAGE AND TRY AGAIN"?**

In most cases, this is due to more than one gamingtoday.profootballfrenzy.com tab open at a time while logged into *Gaming Today Million Dollar Pro Football Frenzy*. Please close any duplicate tabs.

### PROMOTION SUMMARY

The program runs August 27 – December 29, 2019.

Everyone 21 years or older is welcome to play, and the promotion is free.

Each week, participants can play in the Pick 'Em season-long football contest. One participant will win \$100 cash for the most winning picks each week.

Five participants with the best season-long records of picking winners share \$2,000 cash.

If any participant achieves 225 or more winners, the player wins \$1,000,000 cash. In the case of multiple players with 225 or more winners, the \$1,000,000 is split equally among all.

In addition to the prizes for making picks, all players will be awarded drawing entries for an exciting end-of-season prize drawing held on December 30, 2019.

All participants can be awarded a maximum of 10,000 virtual drawing entries per day, excluding XP Point rewards of drawing entries.

## COMPLETE RULES

### WEEKLY LEADERBOARD PRIZES

The participant who selects the most winners each week wins \$100 cash and receives an email notifying them of their win and instructions on how to claim their prize.

In the event of a tie, the participant who submits a total score prediction tie breaker that comes closest to the total score of the Monday night game without going over is the winner. When there are two Monday night football games, the total score prediction is for the early game. If there is still a tie based on the total score prediction, the time the entry was submitted online is the tie breaker. The earliest submitted entry will be the winner. In the final week of the regular season games, when there is no Monday night game, the tie breaker will be the total score of the San Francisco vs. the Seattle game.

### END OF REGULAR SEASON PRIZES

In the event any participant picks 225 or more winners in the 17 weeks of the regular season, that participant will win a \$1,000,000 cash prize or it will be split equally amongst all participants who picked 225 or more winners.

Participants with the five (5) best season-long records will share in \$2,000 cash.

**1st Place Prize:** \$1,000

**2nd Place Prize:** \$500

**3rd Place Prize:** \$250

**4th Place Prize:** \$150

**5th Place Prize:** \$100

In the event of a tie for season-long prizes, the tie breaker depends on which participant submitted their first Pick 'Em card of the season earliest. The participant with the earliest submitted entry will be the winner. Winners will be notified by email and have 30 days to claim their prize.
