



## WIN HCI LIVE REFERRAL CONTEST

### Terms and Conditions

**NO PURCHASE OR REGISTRATION IS NECESSARY TO ENTER OR WIN. THIS IS A SKILL BASED CONTEST. PURCHASE OR REGISTRATION DOES NOT INCREASE THE CHANCES OF WINNING.**

**1. Eligibility.** The “WIN HCI LIVE REFERRAL CONTEST” (the “**Contest**”) is open only to the legal residents of the United States who are at least 18 years old at the time of entry. Employees of Health Coach Institute, LLC (the “**Sponsor**”) their respective affiliates, parent company, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state and local laws and regulations. The Contest is void where prohibited by law.

**2. **4. How to Enter.** You may enter the Contest during the Entry Period as follows:

- **Step 2: Refer Your Friends to HCI**



- You can refer as many friends during the Entry Period. =Referrals who are existing or former students and employees of the Sponsor do not count towards the Contest
- **Step 3: The #1 Referrer Wins An All-Expenses-Paid Trip to HCI Live**
  - At the end of the Entry Period, we'll announce 10 winners and the person who referred the most friends will win the grand prize—an all-expenses-paid trip to HCI Live, see Contest Prize section for more details.

**6. Odds.** The odds of winning depend on the number of eligible entries received.

**7. Winner selection and notification.** Ten (10) winners of the Contest will be selected by the Sponsor. The top 10 people who refer the most friends to HCI before October 7 when the contest closes win prizes listed above.



The winners will be notified at the email address used to submit the Submission, within one (1) business day following the winner selection. Sponsor shall have no liability for a winner's failure to receive notices due to winner's spam, junk e-mail or other security settings or for winner's provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 7 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected pursuant to the Sponsor's selection method. The receipt by the winner of the prize offered in this Contest is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE RULES BY WINNER (DETERMINED AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN THE WINNER'S DISQUALIFICATION AS WINNER OF THE CONTEST AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

Terms.** Sponsor reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Contest should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Contest. In such case, Sponsor may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Rules. Sponsor has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to; multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by the Rules; or the use of bots, macros or scripts or other technical means for entering. Any attempt by you to deliberately damage any web site or undermine the legitimate operation of the sweepstakes may be a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.



**9. Limitation of Liability.** By entering you agree to release and hold harmless Sponsor and its subsidiaries, parent, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in the Contest and/or your acceptance, possession, use, or misuse of any prize or any portion thereof, (ii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software; (iii) the unavailability or inaccessibility of any transmissions or telephone or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Contest; (v) electronic or human error which may occur in the administration of the Contest or the processing of entries.

**10. Disputes.** The Contest is governed by the laws of Idaho. As a condition of participating in this Contest, participant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Contest, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Idaho having jurisdiction. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Contest), and participant further waives all rights to have damages multiplied or increased.
