Completion of Foundations of Faith Community Nursing Course.

## Accountability

The Faith Community Nurse is accountable to the Pastor and Alaska Board of Nursing. Yearly evaluations completed with Leadership/Pastor. One FCN will be appointed as lead as agreed upon yearly. The Lead FCN will coordinate a yearly review of the effectiveness of the program with church leaders. All FCNs will work collaboratively with the FCN Coordinator at Alaska Faith Community Nurse Resource Center at Providence.

## **Time Required**

Varies depending on programs and assessed needs

## Liability

Covered by professional, volunteer, and church insurance.

- Criminal background check

### **Activities/Responsibilities**

#### **Health Counseling**

- Assesses congregational and community health needs.
- Provides information and support related to health maintenance, disease prevention or illness patters. Available to discuss questions and intimate concerns related to health care needs.
- Promotes stewardship of the body emphasizing self care of the whole person.
- Collaborates and communicates with pastoral staff and other health professionals to plan for health ministry programming.
- Examples include: Consultation at blood pressure screenings or other health ministry events / home, hospital and nursing home visitation / medication information / assistance in understanding medical jargon, treatment plans or State and social service programs, i.e.: Medicare.

#### **Health Education**

- Prepares, develops and/or coordinates educational programs based on identified needs for healthier lifestyles, early illness detection, and health resources.
- Networks with appropriate resources in the community to secure educational program resources.
- Examples include: Nutrition / Exercise / Stress Management / CPR First Aid classes / Heart Health / Stroke Prevention / Diabetes prevention

#### **Facilitation**

- Provides training for those who are called to serve as health ministry needs are identified.
- Develops and/or facilitates support groups based on identified needs and resources.
- Identifies available support groups in the community that can be a resource to the congregation.
- Organizes noninvasive health care screenings: i.e.: blood pressure, paper / pencil risk assessments, health fairs.

#### Liaison/Referral Agent to Community Resources

- Develops community contacts in order to secure resources and services.
- Refers to physician or appropriate social service agency.
- Networks with other FCNs and professionals in the community.

## Maintains documentation as outlined in the ANA scope and standards of faith community nursing

- Utilizes the nursing process in patient / client documentation systems.
- Maintains patient/client records in a locked and secure cabinet.
- Maintains privacy and confidentiality as outlined in the confidentiality guidelines.
- Documents FCN activity.
