This is to give you notice that Intero Real Estate Services, Inc. (“Intero”), HomeServices Relocation, LLC, HomeServices Lending, LLC, Orange Coast Title Company of Northern California doing business as Orange Coast Title Company (“OCTNC”), Guarantee Appraisal Corporation doing business as both HomeServices Disclosure Reports and HomeServices NHD, and Vanderbilt Mortgage and Finance Inc. doing business as Silverton Mortgage (“Silverton Mortgage”) are part of a family of companies (the “Affiliated Companies”) owned by Berkshire Hathaway, Inc. (“Berkshire Hathaway”), and each may refer to you the services of another. Intero, HomeServices Relocation, LLC, HomeServices Lending, LLC, and Guarantee Appraisal Corporation are each wholly owned either directly or indirectly by HomeServices of America, Inc., a Berkshire Hathaway affiliate. OCTNC is owned 49% by OCTNC Partners I, LLC (of which Intero owns a 50% interest). Silverton Mortgage is a wholly-owned indirect subsidiary of Clayton Homes, a Berkshire Hathaway affiliate.
