
We must bewere last to the first this summons no directed solely to these outside the Church, however. It is directed to us, even to those of us who are proparing for or serving in the ministry. You may recall the words of the Master to Peter long after the apostile had made his solfssion at Caesares-Fhillipis: "I have prayed for you, that your faith will not fail; and when you have repented (KJ: when thou art converted), strengthen thy brethren." (Inke 22:32) Note, too, the opening words of the Assurance of Pardon in the Order of Worship for the Marning Service: "Hearken now unto the comforting assurance of the grace of God, promised in the gospel to all that repent and believe." provised in the gospel to all that repent and believe."

We are constantly in need of repentance -- of a return to that erientation toward God Touchsafed to us in Christ. Leut may come to some of us as a call to abandon that persocotive in which major decisions see made almost wholly on monetary bases. Or it may challenge us to a re-examination of the way in which we are using our time -- in study, in work, in play, in prayer. Some of us may be called to give up pride in our own achievements -- that well-right ourness which alienates us not only from our God, but also from our brothers.

Whatever the call, it is to be understood in terms of the Cross. To take up the Cross means to surrender those idols which we serve all two willingly, though never admitting that they dominate our lives. And the summons to believe is nothing other than the summons to share fully in that prepared which affirms that God in in Christ reconciling the world to himself.



On Thursday evening, Earch 10th, at 7:30 in the Lounge, the Vital Issues Commission will present for all Seminarians a meeting on the issue: "A CHRISTIAN LOOKS AT THE WORLD CRISIS." Speaking on this subject and answering questions which it raises will be CHARLES WALKER. Mr. Walker is quite a distinguished personage. We are fortunate to have him with us for this vital discussion. ALERICA'S STRENGTH -- PHYSICAL OR SPIRITUAL? -- as reported by Ed Shelly

(At least one Seminarian takes seriously the challenge to "write your congressman!" That Seminarian is Ed Shelly. Here, in edited form, is a report on some recent correspondence between Ed and the Honorable Paul B. Dague, representative to Congress from the Minth District, Ponnsylvania, Chester and Lancaster counties. The staff is publishing this report for the same reason that Ed sent it along to us: it presents a fairly good picture of a legislator's idea of "faith in action" on a national scale.)

WHAT ED WROTE:

In his letter to Congressman Dagne, Ed said "hats off" to President Eisenhower for expressing his personal, and the nation's, abiding faith in God. Ed cited passages from the Fresident's State of the Union message to the Sith Congress, in which Mr. Eisenhower said that the whole conception of the American government mests on a "deep faith" in the "divine endowment" of our people with "inalienable mights," that history's present crisis is concerned "with the worth of the individual," and that he had confidence that he was speaking for "a devout America, humble before God,"

Ed quickly points out to the Congressman from Pennsylvania, however, that President Eisenhower continues to endorse offorts to put into effect a program of Universal Military Training -- to strengthen our netion. Gaining support from quotes in the "Mandester Guardien," Ed angils U.M.T. as "futile, worthless, and a wretched replacement for active military forces." Likewise, Ed continues, such national defense moves are inconsistent with the laws of God -- the basis for the faith which President Eisenhover had hailed. Ed concludes his "study in parador" with the abstencet, "to bring more Americans to the Christian faith is the basic national defense, rather than U.M.T. Our country does not suffer from physical sickness, but from spiritual sickness. And a spiritual sickness demands a spiritual cure."

THE CONGRESSMAN'S REPLY:


The Honorable Mr. Dague expressed his personal thanks to Ed for his "forthright opinions," which he considered a privilege to receive. He expressed the hope that Ed. "will continue to acquaint(him) with his thinking on these important issues."

Moreover, in light of the cost of a program like U.M.T. and the present strength in volunteers for our graded forces, the Congressman agreed with Ed that U.M.T. "may well be worthless for all practical purposes."

Continuing his reply. Mr. Dague expressed his belief "that President Eisenhover is unquestionably sincere then he defines our government as resting on deep faith and Divine endowment." However, he reminds Ed that our nation has never built up or employed its armed strength, except in times of eggression by other nations.

At this point, the Congressmen expresses his own ideas on the Christian feith and its position and power in the U.S. He begins, "All of us, I am sure, are committed to the idea that Christianity is the only antidote to Communism. I would, however, submit that when Jesus Christ welked this earth He was given security to carry on His missionary endeavors by reason of the law and order maintained by force of arms throughout the Roman Empire. Our situation is identical in that so long as God-less Communism is dedicated to a program of controling the world by force, even so must be guard the respects of freedom and make secure the right of all Christians to enlarge and promote their philosophy."

Mr. Dague concludes. "We are not going to use armed might for the promotion of Christian ideals. Rather we are going to maintain our military strength so that Christianity may enjoy the freedom necessary to its advancement."

Here is the official record of individual scoring by members of the Seminary #1 Team -- over a seven-pame range:


