Christian faith begins in a personal experience with Jesus Christ. It is our response to what God has done for us through his son.

Not all such experiences are of the cataclysmic variety. Some are quiet and gentle, but at some time we have said "Yes" to Christ if faith is real. There must be a first step somewhere, sometime, before any life will become Christ-centered or Christ-controlled.

This is the important step, this act of surrender. This is the first and basic decision upon which all future decisions are made. There is a sense in which the Christian life is not one conversion, but a series of conversions or surrenders. Every time we make a step forward it means that something must be left behind, something is given up and some new area of life claimed for Chirst Thus it is that we are never at the place where we can say, "I am fully and completely Christian!" But, like Paul, we would have to confess, "I do not consider myself to have 'arrived,' spiritually....But I keep going on, grasping ever more firmly that purpose for which Christ Jesus grasped me."

The place of the decision is not important. What must be sought is the initial turning from self to God. This first decision makes all future decisions so much easier. Once we have opened life's door that the spirit of Christ may enter, we look upon the world and its crises and problems from a different perspective. Faith then becomes not a safe retreat in which one may hide from life, but the power and stability with which to face whatever life presents.

A FARLE FOR OUR TIMES

Once upon a time there reigned over a fair land a king whose chief worry was that his subjects would find out how unworthy he was to rule. So he assembled a group of courtiers to whom he spake thus, "Do all in your power to keep me in charge here. There are enemies of mine - you know who they are - who must be ferreted out. But, above all, don't let me know what you're doing."

So the courtiers hied them selves forth into the land, far and wide, ferreting out the king's enemies. And since their jobs depended on finding enemies to fierret out. When they didn't find any, they invented some.

One group, they discovered, was made up of college-age young people, of whom there was a goodly number in the land. They were concerned about the king's continuation of a war in a faroff corner of the globe which the king's predecessors had begun, but which he had promised to end, if made king.

The war had started in this tiny land, divided East and West by differing ideologies. The East was being egged on and supported by the Giant Bear, once an ally, but now an enemy of the king's land. So, to protect the American Way of Life, some 50,000 of the finest young men, chosen because there was no blemish mental or physical in them, had died. Naturally, the young men in the Groves of Academe wondered who would be the next to die and the fair maidens who loved the young men also worried about them.

One particular incident angered the young people more than anything else: on the highest holy day of the year, when people of the tiny country heard sounds from heaven and ran out of their huts to hear the Hearld Angels sing, the king's minions rained death and destruction on them. His justification was, "They'd better come to the Peace Table or I'll kill them getting them there," or, in other words, "I'd rather see them dead than Red." So the courtiers discovered many enemies of the king among the young

people.

Other enemies of the king, they discovered, were the town criers.

Now in normal times, all these good people did was report that there was a fire in Peasant Smith's house because he was smoking in bed or that Peasant Miller's cart met with Peasant Jones' cart at a crossroads with some damage to both carts and some injury to both citizens.

But lately the town criers were beginning to discover that the king's courtiers had broken the Law of the Land and they wanted to include this news in the town crier's messages, along with the news of other peccadilloes committed by the citizenry. This enraged the king and he solemnly announced that this calling out of such trivial matters breached a king's confidentiality.

At this juncture a select group of Wise Old Elders, who met regularly to deeply ponder and at times to stand up and orate, decided to investigate the truth of these charges that the king's courtiers had broken the Laws of the Land.

So what followed was a curious phenomenon: every so often the king asked the town criers to announce that he would appear on the castle walls and address the citizenry of the land. So, no matter whether or not his subjects would rather have watched the National Voice Box to see 11 warriors in red fight with 11 warriors in white, all they could do was go to the Castle to hear the king. Time after time he defended his courtiers, ending each solemn pronouncement by saying, "I am not a thief."

I wish I could end this tale on a happy note, but the last I heard from this land was that the Crown Prince was removed from office but not severely punished for his crimes because he was a C.P. Now a search is on for a new C.P., who can be shown to all as being above suspicion, if not very bright.

Such a state of affairs can be understood only when we perceive the truth of the little dictum, 'Power corrupts.

I usually miss the boat! I think of ideas which I fail to write down, then someone else comes along and does what I was thinking and gets the credit. One example of this began with our neighbors across the street around yesterday. Its called "streaking" and several of the students have assured me it's the coming thing. After my "experience" this September in Bergen, North Holland, I concluded that they may well be right so I said to myself that, as a moralist of stature and as a member of Dr. Ringer's ethics class that I ought to write a few guidelines for the clergy on the correct approach to "streaking," as some of my fellow seminarians have been suggesting "Streaking for Christ." The nudity one comes across in other situations must be met on an ad hoc basis. For that you had better prepare yourselves. I can only be of help in more ceremonious situations.

While my guidelines are coming a little late, they may be of use in Pennsylvania! My latest reports show little streaking here, or any other kind of nudity for that matter. Who knows, however, what is happening down in Daytona Beach?

To get back to my "guidelines" in light of this "wave of the future" and in terms of the loosening of other inhibitions I am sure that you will agree that any kind of participation is something in which we as clergy ought to take a concerned interest.

We used to think, in calmer days behind us, that nudity and certain other acts would never be present in the open - at least male nudity was taboo. After all, men have little to hide and women were more concerned about the kind of job a man had. But, my main source of information, a college chaplain in North Carolina, tells me that all kinds of mudity are on the increase. He says that while women have been the great supporters of the arts and other worthwhile causes in the U.S.A., they are not rushing in to support nudity. Walter Kerr even says that directors even find it difficult to get female actors to accept nude roles. It looks, according to my source, as if nudity will be the one form of art which men will have to support if it is to continue. This may be a real breakthrough in the American male's relationship to art.

But there is a more difficult problem ahead for us than the mere taking off of clothes because it is not only clothes which are being thrown away. All inhibitions are going! Nodesty prevents me from saying what some of them, after all, someone may want to send a copy of these guidelines to a friend through the mail. But I can say that the situation is serious. These people mean business if they are already doing it!

We can discuss one of the problems -- "streaking." At some point the on-lookers may be invited to join in. This could mean a general entangling of bodies regardless of sex. Or you may be supposed to stroke the body next to you as a kind of neighborly gesture. In this kind of thing there may be a number of problems for many church members. The chief problem of course is that many clergy and a few laymen are going to be against this general entangling of bodies let alone stroking the body next door. If people did not take well to the kiss of peace, I do not see how they are going to like "streaking." Now, it is perfectly all right for people to be against something. We could not survive in this modern world without some resentment. It's what keeps us going. My concern here is with the way the clergy, particularly fundamentalists, will go about being against "streaking." You have only to remember the prohibition of alcohol and the disaster that was to see what these enthusiastic Christians could do with nudity. I remember when Baptists were against mixed bathing (that means men and women swimming in the same pool). But the Baptists lost that one and now we have the bikini and "streaking." It is perfectly easy to see that if the clergy go after "streaking" with the same fervor as in the earlier fights, we are likely to end up with out even our underwere. The thought of that is something I deplore; I catch cold rather easily!

Since we must do something about "streaking," I propose that we organize to make our assault on these displays indicating loss of inhibitions. I think we in the U.C.C. had better alert our Baptist and Methodist friends, et al, for our coming crusade, so that we shall not have simply a frontal assault on nudity. As members of the U.C.C. we may want something a little more subtle. If you carefully explain to them that, of course you are against nudity, but that, as Dr. Vieth would say, "the approach to a problem is, as always, very important."

On March 6, 1974 Professor Gable informed me that he wishes to retire from the faculty at the end of the current academic year. I announced this to the faculty at its meeting on that same day. I will present this request to the Executive Committee of the Board of Trustees at their meeting on March 26.

My sentiments are expressed in the following statement, released to the press on March 7th: "Of course, I regret the retirement of Dr. Gable at this time. He has been a major factor on our faculty for more than 20 years. But I rejoice in the new adventure that has opened up for him and Mrs. Gable. Although they are retiring from the Seminary, they are not retiring from ministry, from teaching, or from an active life of service.

"Dr. Gable has begun the development of a new program of continuing education for pastors, he was instrumental in the initiation of our Parish Training Program for seminarians, and he has guided the design of our 'collegia' which bring pastors, students, and professors together in a common educational venture. We will miss his leadership in these, and other programs.

"We will take time toward the end of the year to celebrate Dr. Gable's service to the church and the Seminary. We will begin, as soon as possible, to seek a successor to carry on the work he has done so well for so long.

"But for now we record our gratitude for his life and service and wish him well as he and Mrs. Gable plan for their ministry next year in Hawaii."

We will not spend the rest of the semester saying goodbye to Lee and Ann Gable, but we will have several significant occasions to recognize their contribution and to celebrate their new adventure.
