#### A REPLY

Normally, I do not write letters or commentaries on occurrances within the Seminary community. I usually reserve my writings to the academic requirements, feeling ample release of my creative urge there. The response to the Chanel service on Thursday, October 30, 1975 has prompted this change in policy.

I do not challenge the appropriateness of the service. That is a matter for individual judgement. What is or is not meaningful for me may be precisely the opposite for another. I no more desire that he or she adopt my opinions verbatum then I will adopt

theirs uncritically.

What has disturbed me is the evident curtailment of freedom of speech on the part of some members of the Seminary community with regard to reception of the message presented. True, the message must have been exceedingly offensive to make them walk out in the middle of the service. True, that action is their righr not to hear that with which they violently disagree.

My points are this: 1/ this action violates the basic understanding of academic freedom, which is supposed to stand for the free and open hearings of all sides of a question without which academia can never truly be free; 2/ the individuals who do this are often the first to state their horror at the declining membership in their churches because of disagree—(continued on p.2)

#### CLARIFICATION ON CHAPEL

Last Thursday's chapel got a lot of people upset. I feel these people misinterpreted my reason for having this service. The main idea read into my service was that it advocated Civil Religion and that I was worshiping the flag instead of God. I did not intend to profess Civil Religion or worship the flag. The reason I presented this service was to share in the bicentennial celebration of America. The U.C.C. and other churches are cooperating with the Bicentennial Committee this year by having special services which lean toward this celebration. If churches throughout this land will be having services geared to this historic event, why shouldn't we here at L.T.S. service was condensed from an earlier service held in my home church the preceding Sunday.

I would like to comment on some of the feedback I have received. It was brought to my attention that there was no Call to Worship. Since this was a special service for the purpose stated above, I felt there was no need for one. I believe that a service does not always need a Call to Worship

to open the service.

In reference to the prayer I used, this was not my own prayer but one of Peter Marshall. In his prayer for America he states, "For the advancement of the Christian faith, did the Founding Fathers give their life's heritage, passed down to us." This land, which is your land, was made by God, and our founding fathers built a nation on the foundations of Bible (continued on p.2)

ment with the message proclaimed from

their respective pulpits.

Academic freedon is based upon the premise of free exchange of <u>all</u> ideas in a search for truth. Yet can academic freedom be said to exist when the only position I am confronted with is the one with which I already agree? I am not making up my mind in such a case, it has already been made up for me. By excluding opposing viewpoints I am not free to choose which seems most right, I am only free to pick within the range presented.

As regards those who are so downtrodden about the declining membership of their churches and the defection to the conservative churches I only request that, if you are one of the ones who walked out on Dale's service, please do not cry around me. That which you are unwilling to do for your fellow seminarian, you have no right to expect fron your parishioners. The message I received loud and clear was: if the message from the pulpit contradicts your concept of what a church should be doing, then we are bound to abandon that service. Can we not expect the same from the members of our congregations as they are asked week after week to tolerate that which is contrary to their belief? Is this not why conservative churches are growing?

For those who will reply, "We are only human:" I suggest that so is the person in the pew. Perhaps we should not expect less of them than we are prepared to give, but can we realistically expect more?

For those whose answer is "What you say has truth, but our situation is different, for we are right!" I suggest that only God is the final repository of truth. If you make this claim I wonder whether you are Jesus or Charles Manson. Both claimed to be the repository of all truth. I also offer you my heartfelt pity and love because divinity must be the loneliest of states as no one fully understands you.

In conclusion, it is my opinion that Dale had every right to present his service Thursday. I have every right to agree or disagree with it. Of such is the fabric of the society in which we live. I do feel, however, a certain responsibility to hear all of his message before I pass judgment

on its appropriateness. I have enough confidence in my own position to accept a challenge to it and stand ready to change my position should that challenge prove my conceptions wrong. Perhaps the time has come for us to realize that true dialog requires opposing viewpoints, not two people of the same viewpoint.

PARKING GRIPE-

somewhat unhappy about the parking situation on campus. Although I have accepted the fact that the number of parking spaces on campus per se is of parking on the lot behind the Pine Street houses leaves much to be desired. Firstly, the entry to the lot is quite narrow so that in winter one runs the risk of sliding into the President's shrubbery or down onto Bob Heyman"s walk; this narrowness also causes problems leaving the lot, for, often times, another car enters the lot as I am leaving and one or the othe of us has to back up to allow the othe car to maneuver. 1,7 Mary Lou Finlayson  One of the most common forms of humility to be found at LTS is the disavowal of trust in one's own capabilities, especially in the area of judgement. The usual line goes something like this: "Of course I might be wrong about this but..." A variation on this approach is, "Maybe I'm misunderstanding you but..." And then there is the old, "Who are we to say..." and the familiar, "This is just my opinion--stop me if I'm wrong--but..."

Such modesty speaks highly of the truly Christian character of our institution. Self-abasement has a long history within Christianity, going all the way back to the desert saints and the ascetics of the early church. Mistrust of one's own motives, judgement, and abilities has a great tradition in our faith, indeed.

But I wonder if there is a bulk of histo rical data to support a challenge to one's sincerity as normative within Christian self-examination? Of course I might be wrong about this, but I doubt that even the desert saints ever questioned their own sincerity--just their morality or judgement. Maybe I'm misunderstanding the nature of Christian modesty, but it seems to me that our modesty is never allowed to question the sincerity of our self-doubts. Who are we to say that we cannot trust ourselves, our opinions, our judgements? This is just my opinion -- write a reply if you think I'm wrong--but it seems to me that our own judgement is all we have to work with. It seems to me--and I might be wrong, of course, because we humans are sinful and prone to error--that when we try to lay the burden of decision on God we are doing nothing of kind; we are, in fact, making our own decisions and not taking the credit for it. Of course, we can do nothing of ourselves -- only God can do good. But couldn't we--just maybe--do a little bit of good on our own?

Of course we are sinful men, and so all our desires are against God. But isn't there just once and a while a desire that comes from inside of you--and it is a good desire? Yet, we cannot trust our own understandings. We cannot trust our own judgement. Of course, and you may disagree with me on this and please correct me if I'm wrong, we have no other basis for movement but that which starts from within ourselves. So why do we play the humility games rather than simply saying: "Here's the way I see it,"? Is it the long tradition of Christian humility in which we take pride? Hear ye the words of Ralph Waldo Emerson: "Yourself a new-born

#### FROM THE EXECUTIVE CABINET

At its meeting on November 6 the Executive Cabinet received a request from Margaret Clark that she be granted an exception to the no pet regulation and be allowed to keep her cat in her apartment. A strong recommendation from a consulting psychologist accompanied her request. After considerable discussion and with some reluctance the Cabinet took the following action:

In light of the seriousness of the professional advice we have received, permission is hereby granted for Ms. Margaret Clark to retain her pet cat on campus until May 31, 1976. At that time she will be asked to give up her cat or her oncampus residence.

The Executive Cabinet restates its commitment to the no pet regulation. Exceptions will be granted only upon request in writing and only where clear and convincing professional judgment justifies exceptions. All exceptions are for definite periods of time. Ordinarily no exceptions will be granted for more than an academic year. The objective of the policy is to remove pets from campus, and nothing in these temporary emergency exceptions should be construed to indicate any change of policy or the Cabinet's resolve to maintain it.
