GERMAN REFORMED CHURCH. History, Doctrine, &c.

The last of the symbolical books of the Reformed churches that claims our attention is the Rieidelberg Catechism, which was first pub-ilished at Heidelberg in the Palatinate, under the auspices of the Elector Frederick III, and subsequently often reprinted, translated into many languages, and introduced into almost all the countries in which the Reformed religion was profes-

The Heidelberg Catechism, however, is far from being the only one, nor was it the first, that was adopted for the purpose of public instruction in the Reformed church.

The origin of catechisms in the Reformed Church is somewhat later than in the Latheran. The first work of this kind was a catechism in the German language, composed and published by Occolampadius of Basel, which was translated into Latin, some years afterwards, by Oswald Myconius, and published at Basel in 1545.

In 1533 the Synod of the Canton of Zurich appointed Leo Juda, the bosom-friend of Zuingli, and the first Reformed pastor of the church of St. Peter in Zurich, to compile a catechism, which, being submitted to that body in the following year, was approved and appointed to be used as a guide in the instruction of youth in the churches and schools. This entechism being adapted only to the more advanced youth, another suitable for children was written, at the instance of the Synod by the same author, in 15. il; and this latter is the work which is usually referred to as Leo Juda's catechism. About two years later, this excellent divine also compiled a Latin catechism for the use of students in the higher schools, particularly for those who had the study of theology in view. It was ultimately supplanted by another composed by Bullinger in 1559, which at first was used only for the highest classes in the schools.

In 1583 Burkard Leeman, a learned and pious divine, who some years afterward succeeded chism designed for the higher classes in the German schools, while that of Leo Juda continued in use for the lower. Besides these, other catechisms were in use, which were either borrowed from foreign countries or were the productions of individual preachers. The diversity which conequently prevailed in the form of instruction, by the Senate of Zurich in 159s prescribing the mode of catechetical instruction, and establishing the smaller catechism of Leo Juda as the formuwas without the desired effect. Each of the other Reformed Cantons had also its own catechism. In 1536 Caspar Grossman, professor of theology at Bern, (who agreeably to the custom of that age, to render German names into Latin or Greek, assumed the name of Megander.) published a catechism for the use of the Reformed in Bern, which was immediately adopted in the churches and schools throughout the Canton. Two years later Martin Bucer and D. Capito of Strasburg, in their zeal to bring about a peace and re-union with Luther, had the address to prevail with the magistracy of Bern to have this catechism so altered, in its explanation of the Lord's supper, as to adapt its language to Luther's doctrine on that subject. Grossman, being dissatisfied with this alteration, was removed from his office, and retired to Zurich where he died in 1545. The churches of Bern howerer did not submit to this change. Few of them, adopted the altered catechism; and ultimately the magistrates themselves disregarded it. A smaller one for the use of children was published by authority in 1581.

In Schaffhausen the catechism of Leo Juda was used exclusively until 1569. In that year John Conrad Ulmer published a new one. act created much dissention; and to heal the disorder which it produced, the Synod of Schaffhausen appointed a committee of five divines, who compiled a new entechism which was taken from those of Leo and of Ulmer. The Heidelberg catechism was not introduced into Schaffhausen before the year 1643; and then it did not supercede the other. The compend for small children which is used in this canton is an abridgement of the catechism of Heidelberg. It is not the same which was ordered by the Synod of Dort, and, which has been in common use in the Reformed Dutch church.

In the Canton of Basel, as we have already observed, a catechism for the use of its churches and schools was published before any work of this kind appeared elsewhere in the Reformed church, but we have not at present ac-; cess to sources of information respecting it-

The French Reformed catechism was the production of Calvin. It was first published at Geneva in French and Latin in 1536, and afterwards passed through many editions. Translations of it were made into German, English, Scotch, Belgie, Spanish, Hebrew, and Greek. It was designed chiefly for the church of Geneva; but such was the authority which it obtained that it was introduced into many of the Reformed churches and schools in other countries. In Prance it was expounded in the religious assemblies of the Reformed, on the afternoon of every Lord's day, until the revocation of the Edict of Nantes. It was received by many in Switzerland, the Netherlands, Poland, Hungary, &c.

Other catechisms of more or less note were published in Switzerland, France, the Netherlands, and other countries. Among the more recent works of this kind is that of J. F. Osterwald, which appeared first at Geneva in French, in 17. 02. Many other editions were subsequently printed. It was also translated and printed in English, Belgie and German; in the last of which translation it had frequent editions.

Among all the productions of this kind the first rank has been conceded to the Hadelberg Catechism, which has obtained more general reception than any other as a compend and guide in carechetical instruction. It has its name from the place where it was composed, viz. Heidelberg, the capital of the Electoral Palatinate. Its authors were Caspar Olevian and Zacharins Ursinus. The latter, a native of Breslan in Selesia, was a disciple of Melanethon, under whose direction he prosecuted his studies at Wittenberg from 1550 to 1557. At the close of this period he accompanied his preceptor to the colloquy at Worms: after which he visited Geneva, where he made the acquintance of Crivin. He spent some time in Paris to learn the French language, and to improve his knowledge of Hebrew under the guidance of Mercerus. On his return he made some stay in Zurich. In 1555 he was called to the rectorship of a gymnusium in his native city Breslau, which office he filled with ability and faithfulness; but, on account of the disturbance which he saw that his opinion concorning the real presence would produce, he resigned this situation in 1560 and went to Wittenberg, from whence, in consequence of Melanethou's death, he departed and took up his abode in Zurich. In 1561 he was called to the Collegium Supientia in Heidelberg; and in the following year he, together with Olevian, was appointed by the Elector to compose a catechism for the churches in the Palatinate. On the death of Frederick and the accession of his son, Lewis VI, who was zealously attached to the doctrine of Luther and abolished the profession of the Reformed religion in the Electorate, he was compelled, as well as the students of the Collegium Sapientia, and many of his brethren, to quit Heidelberg and the dominions of the Elector. He retired to Neustadt an der Haardt, in a small territory under the government of the Count Palatine, John Casimir, a brother of Lewis, who was of the Reformed persuasion. Concerning the intricate points of human inability, election, and reprobation, he deviated from the system of Augustin, Luther and Calvin, and held the theory to which the name of synergism was given. He did not oppose the doctrine of those distinguished men while he propounded his own; and in a letter addressed to Caivin, with whom he maintained the most friendly relations, he declared his conviction that, however they differed in words, they taught substantially the same doctrine."

Such being the sentiments or the Elector, of Ursings, and of a majority of the clergy and people in the Plegtorate, it was to be expected that they would appear in the catechism: and accordurgly we find them fully exhibted there. vm's idea of a real participation of the body and blood of Christ is contained in Quest. 75 and 76, and more fully in Quest. 79.7 This theory, though nearer than that of Zuingli to the Lutheran, differed from the latter in three particulars, viz: 1, the body and blood of Christ were not in the bread and wine, as Luther taught, though they were communicated at the same time with them; 2, they were not received with the mouth, as he maintained, but by faith; 3, they were not received by the ungoally communicant, as he contended, but by the faithful only. On the subject of human inability and divine agency, the language of the catechism in Quest. 8, admits of Melanethon's interpretation as well as of Calvin's. Respecting election and the perseverance of the saints, its doctrine is expressed in terms which the highest Calvinist and the lowest synergist might adopt in Quest. 1, and 54.

This catechism was evidently designed as a bond of union to all the parts of the Reformed church. For this purpose it did not aim to establish uniformity of doctrine upon those points about which different portions of the church dissented from one another. Where there was no disagreement, its language is precise; where disagreement existed, it decides nothing. In the true spirit of the Gospel, it indulges liberty of conscience in those cases wherein believers in Jesus Christ may entertain different opinions. Its general reception among the Reformed was an

The Elector immediately directed a Latin translation of it to be made: and both the original and the translation were first published at Heidelberg in 1563. Many eelsewhere. Some of these comprised both the Latin and the German catechism; others were editions of one of them only; many were enriched with additions consisting of prayers, liturgies, expositions, proof-texts, &c.

A translation in ancient Greek was composed by Frederick Sylburg, of which eight editions are noticed by Walch; the first of them printed at Hedelberg in 1597. To two of these a version of the Belgic confession, in the same language by Jacob Revius, was added. They were printed at Leyden in 1622 and 1635. There is also a version in modern Greek, composed by order of the States General of the United Provinces, and printed in 1648. A Belgie or Low Dutch translation, by Caspar Van der Heyden, appeared first at Antwerp in 1580; a French one, the author of which is not named, at Amsterdam in 1540. There is a Cingalese version, printed at Columbo in the island of Ceylon in 1741, the auther of which was William Konyn. Other versions have also been published in the Saxon dialect, in English, Italian, Bohemian, Polish, Hungarian, and Hebrew.

An epitome of this catechism was composed by a committee of six divines, appointed by the Synod of Dort, with Francis Comar, the celebrated antagonist of Arminius, at their head. But before this time an epitome had appeared under the title of Fragstucke aus dem Heidelbergischen Catechiamus gerogen, which was published in German at Heidelberg in 1584, and in Latin at Neustadt in the following year. Other summaries were published, in the form of analyses of the Heidelberg catechism, at Bern in 1564, and in Bremen 1614. After the Synod of Dort, works of the same description in Latin, German, Belgie and Freuch continued to be written and published. Among these productions were those of Felix Wyss at Hanau 1653; Anth. Brunsen 1691: Arnold Montanus in Belgie 16-59, and German 1707; Samuel Maresius in French 1641; Joh. Martin, Sim. Moolmar, Anth. Van Oustrum, Simonis, and others.

The authors who have written commentaries on the Catechism are very numerous; and among them are many who are honourably distinguished in the literary world, as J. P. Parens, H. Altingius, J. Piscator, J. Coccejus, Everard Van Der Hooght, &c. Others have published sermons on the catechism, comprising the whole in lifty-two sermons, so as to complete the series by one sermon for every Sunday in the year-Among these productions are the sermons of B. Coppius 1585; P. Lansberg, 1594; G. Schindler, 1597; H. E. Sextran 1612; B. Moyer, 1684; Peter Von Der Hagen, 1693; L. G. Mieg, 1746; R. Schaeld, 1764; and, more recent-

ly, George Gottfried Otterbein, of Duisburg on the Rhine, whose sermons, in 2 volumes, were published in 1799. They were adapted to the exigency of that time, amidst the misrule of infidelity and the corruption of morals which characterized it. The author was a brother of the learned, pious and venerable divine of our church of the same name, who died in Baltimore some ago: and he was worthy of such a relation.

The catechism had its enemies as well as its friends, between whom a warm and long continued controversy arose. It was attacked with great violence, soon after its publication, by Mathias Flacius, Pilem. Heshusius, John Bren z and Jacob Andrew, who were among the most eminent of the Lutheran elergy, and were distinguished for their zealous attachment to the opintions of Luther. They were answered by Ursinus in several tracts which appeared in 1564. 1584, 1595. Among the Roman Catholics Angelus de Monte Bello, Martin Duncan, Engelbert Kenniphov, and C. Rittmever attacked it in their writings, but were met and refuted by many on the Reformed side. The principal offence was given to the Roman Catholics by the 80th Question, "What difference is there between the Lord's supper and the Popish mass?" This question was not in the first edition of the catechism, but was added in the second, and was subsequently retained.

Walch, in his Bibliotheca Theologica Selecta, speaking of this catechism, pronounces the fol-lowing judgement upon it: "Setting aside the Reformed dogmas, it must undoubtedly be acknowledged to be worthy of commendation for its good qualities, especially its neat manner of treating its subjects, its elegant arrangement. Its perspicuity, and the choice of its proof-texts."

The example of the Palatinate in adopting the Hadelberg catechism was followed by the Reforand churches in most other countries. Those churches however did not set uside their own catechisms, I they had any, when they received this one; neither were they prevented from introducing others that were afterwards compiled, if they seemed well adapted to the object of pullie instruction: but whatever catechisms or summaries of doctrine they might have, the Heid dberg catechism was placed beside them as the sum nary which was generally received in the Reformed church: and among the Reformed in tiermany, who were for the most part of the Melanethonian school, it was the received symbolical book. The popularity of this catechism was founded chiefly in the compromise which it offered and the common ground of union which it presented to all the members of the Reformed family. If Melanethon's sentiments had been suffered to prevail in the Lutheran church, it would probably have effected a union of the whole Protestant family.

From the Presbyterian. DREAD OF CALVINISM.

Mr. Editor,-In casting my eye over the columus of the "Christian Advocate and Journal for the in a week, I was amused with an artein which the writer sounds an alarm about his vinism discovered in Sunday school books, which by some means had crept into some of the libraries of the Union of the Methodist Episcopai church. The particular volume is which this deadly poison was detected, was "Scott's Force of Truth," in which this distinguished and popular author gives a narrative of his conversion from Socimanism to Calvinism. The writer of the article, however, seems to be very unwilling that his readers should be exposed to the danger of reading or even looking into this little volume for themselves. To preserve them from the temptation, he cites a passage from which it is evident, beyond doubt that Dr. Scott did believe in the horrible doctrine of election; and it'so, ha must have believed in the more horrible doctrine of reprobation, for they must go together.

Now, Mr. Editor, the thought occurred to me. that if every book is proscribed to the members of the Methodist Episcopal church which has a little spice of Calvinism in it, I think that a loss of no inconsiderable value will be sustained. For consider, in the first place, that every book or scrap from the pens of the Reformers of glorious memory falls into the proscribed list. In the next place, all the pious and practical works of the English church in her purest and best days must be placed in the expurgatory index. ali the casusacal and fruly spiritual works of the Paratans must be added to the list, for every one of these is more or less tinetured with Calvinism. Such men as Hall, and Davenant, and Andrews, and Reynolds-such pangent spiritual writers as Goodwin, and Baxter, and Owen, and Howe, and Flavel, and Cates, and Heyward; for although the writings of all these and a hundred others are not written in defence of Calvinism, yet they are deeply tinctured with this leaven. Now to ment would be considered a grievous loss to be ent off from all opportunity of looking into such works because they recognize the doctrines of election and perseverance. I should like to know whether the aforesaid writer, and those who agree with him, would permit, "Banvan's Pilgrin's Progress" or "Holy War" to stand on the shelves of one of their Sunday school libraries: ' or do not they know that thesamusing allegories of an untaught genius are repleto with Calvinism? And what will they say to such works as the biographics of Bramerd, o Martyn, of Newton, o Cecil, of Halyburton! Must not Methodists ever look into these treasures of spiritual knowledge? The truth is, Mr. Editor, if all books should be destroyed which have as much Calvinism as Scott's Force of Truth, our stock of works on experimental and practical religion would be extremely meager. it would take our Methodist bretheen some time to fill up the chasm which would be made by such a destruction. But what shall be done with the Calvinism of St. Paul, the most bold and inflexible of all Calvinists ? For my own part, Calvin-

the subline doctrines of this inspired man. want no higher Calvinism than what I can find in the sixth and ninth chapters of the Epistle to the Romans, and in the first chapter of the epistle the Ephesians. If this is not Calvinism, then um I no Calvinist; and the fact is, I got my opinions from Paul, and from my own experience, long before I ever read a word of Calvin.

Every elergyman of the Reformed Church is requested to act as agent for the Messenger within his pastoral care, and to increase the patronage and circulation of the paper by new subscriptions.

Letters addressed to the Editor, which do not contain money or new subscriptions, must be post-paid.

As the proposed change from a monthly to a semi-monthly paper will almost double the expense of publication, while only one half is added to the price, it is manifest that a considerable addiion to the subscription-list will be required in order to sustain it, and still more to realize profit from it for the missionary funds. Ti Editor has no private interest in urging upor his brethren the duty of new and vigorous extion; but he is persuaded that, in giving extensive circulation to the Messenger, they will promote the best interests of the church, and serve that cause to which they are consecrated by the solemn vows of their ordination. We do not see why our subscription list may not be at least doubled. One paper of the Methodist denomination, the Advocate and Journal published in New York, has 25,000 subscribers; and they have two other weekly religious papers besides. Why have we less than 1000 for the only paper of our church; and that a monthly one! It is because many, very many members of our church do not take a religious paper, who could abundantly afford to pay for it, and would derive more solid benefit from it than they do from a pretty long list of other things for which they pay their money freely. we must augur ill of the state of things in any portion of our church if its own paper receives little or no support from it.

Ministers of religion are very much mistaken I they imagine, that by taxing their people with religious publications they will diminish their own support; which, it must be confessed, is often low enough. The smallness of the contributions to their support is usually not owing to the want or ability on the part of their people, but to the more serious want of a disposition to uset-to the want of intelligence on the subject of religion, and of that preparation of the heart which religious knowledge must produce. An enlightened people will do with pleasure what an ignorant one cannot be induced to do all-

The Messenger ought to be introduced into every family within our, church, where it can be read, and the expense afforded; and we are sure that, if there were as much taste for religion amongst us as there is for earthly things, very tew families would think themselves too poor to pay for it.

We shall endeavour to give to this publication all the interest we can impart to it. We hope too that our brethren, both of the clergy and laity, to whom God has given talents to be useful in this way, will aid us with their communications. We reserve to ourselves the right to judge of the propriety of publishing what is offered. At the same time we claim no right to exclude from our columns the opinions of others, only because they are opposed to ours. Every member of the church who has her interests at heart, has a right to be heard in the Messenger, provided he loes not offend against propriety. In giving sublicity to his opinions we do not make them er own. Correspondents alone are responsible r what they write; and we shall therefore always expect that they entrust to us the secret or heir names.

SYNOD OF OHIO.

In the abstract of the proceedings of this Synod which we gave in our October number, the following minute occurs. "Rev. Thomas Winters, Jacob Descombes and David Winters were appointed a committee to correspond with the Synod of the German Reference church of North America."

In pursuance of this appointment a letter, in the German language, was addressed to our Synod at Easton of which the following is a translation.

Letter from the Committee of the Synod of Ohio. Germantown, Ohio, June 1833.

We the undersigned committee of the Reformed Synod of Ohio, who were appointed to confor with your reverend body, hereby perform the duty assigned to us.

The great distance, which separates us from your reverend body, caused your former Classis of Ohio, about eight years ago, to constitute itself a Synod. Whatever objections may have been urged against this measure, its elevated obpeet could not be mistaken. The reasons of it were in the newness of the State, the feebleness of the congregations which had to contend with so many adversities, especially with the invading spirit of sectaries, and the little help that could be expected from the Synod for the purpose of supplying and edifying the congregations.

The newly formed Synod, which now acquired strength by an increase of numbers, saw its expeciations crowned with the happiest effects; both in the general confidence that was infused by supplying with pastors the destitute congregations in this state, which with the divine blessing, were brought into a growing and flourishing con-

ble to meet the applications and requests that are addressed to us. Indiana, Illinois, Misssouri, Mississippi, yea, even Louisiana, invite us into their territories; but, on account of the want of suitable missionaries, their petitions cannot be granted, since we are unable even to supply the congregations in Ohio.

It would deserve to be called pride and obstinacy, if, after opening the way for the entrance of the Word in so many places, the Synod, conscious of its own weakness, should promise relief which it cannot afford, and thereby retard so holy a cause, instead of resorting to measures by

which the object may be attained.

The Synod feels the importance of its vocation. and though it has never ceased to invoke its divine Lord Jesus Christ, for the prosperity of his church, yet it has never expected miraculous aid. On the contrary it has looked to a union with the Mother-Synod as the measure by which the work it has begun may obtain the desired success. On which account, and especially since the separation into two bodies has created some coolness, both on the part of ministers and of the congregations, like that of two opposing parties, by which the church has sustained serious injury, it is come to the following conclusion: That the situation of the Synod demands a re-union with the Mother-Synod, in order that missionary operations may be more beneficially prosecuted, and the want of labourers more easily overcome by means of the Seminary in York, and that by unity of spirit a more effectual resistance may be made to difficulties and invading

In order to effect this object with greater certainty, the Synad requests your reverend body to devise a plan of re-union, and entertains the hope that such terms can be adopted as shall provide for its remoteness and authorize it, in cases of necessity, to perform all the actus ministerii.

It is the most fervent wish of the Synod that all the bodies which have separated from the general Synod should be again united with it that they may operate more beneficially and effeetually. But this union must be so directed by love and wisdom that we may not be in danger of perhaps seeing four Synds arise instead of three. The Synod flatters itself with the hope that, as a consequence of such beneficient union, the time may not be very distant when we shall see a second Seminary arise in the West.

While the Synod submits this matter by its committee to the wise disposition of your reverend body, the committee request that as soon as you shall have come to a decision, you communicate the same to them, that they may report to the Synod at its next annual meeting; in expectation of which they respectfully subscribe them-

This letter being read, it was referred to a committee consisting of Rev. Theedore Heffeditz,

ick Humerichouse and George Hess, Jun. whose report, after recapitulating the particulars contained in the letter, concludes thus:

The Committee to whom this subject was referred rejoice in the proposition of a fraternal union by which the providence of God is about to impart new strength to his church; they rejoice especially in the success which has attended the Classis of Ohio since its existence as an independent Synod; and under the influence of these feelings they recommend to Synod the following propositions:

1. That the Classis of Ohio be re-instated as a Classis in connexion with this Synod.

2. That, in considertion of its remoteness, the Classis of Ohio be authorized, agreeably to its request, to perform all the actua ministerii.

3. This act shall not take effect unless, agreeably to the constitution of the church, it be approved by two thirds of the Synod and a majority of two thirds of the Classes.

4. That the Corresponding Secretary of Synod be directed to communicate a copy of this report with its propositions and of the Synod's decision respecting it to the Committee of the Synod of Ohio.

ROMAN CATHOLIC COUNCIL IN BALTIMORE.

The following account of a Roman Catholic souncil, taken from the Baltimore Gazette, will give our readers an idea of the extent of that church in the United States, of the spirit that pervades it, and of the imposing pomp of the Papal hierarchy, even in this land of equality. This council, which to us seems general enough. is called a provincial council, whence it appears that the whole United States constitute but one of the provinces in the spiritual dominions of the Roman Pontiff. The decrees of this council will have no validity until they obtain the sanction of the Pope, who on the principles of the Jesuites is the supreme infallible judge in all cases.

CATHOLIC PROVINCIAL COUNCIL.

This Assembly is now in session in this city -it was opened formally yesterday in the Cathedral. The Most Rev. Doctor Whitfield, of course, presided, as Archbishop of Baltimore, and celebrated the Mass of the Holy Ghost on the occasion.

The other Bishops present were the Right Rev. Doctor David, from Bardstown-the Right Rev. Doctor England, of Charleston-Right Rev. Doctor Rosati, of St. Louis-Right Rev. Doctor Fenwick, of Boston-Right Rev. Doctor Dubois, of New York-Right Rev. Doctor Kenrick, from Philadelphia-Right Rev. Doctor Rese, of Detroit, and the Right Rev. Doctor Murcell, of Cincinnati. The only Bishops entitled to sents who were not present, are the Right | Deloui.

L. Mayer, F. A. Rauch, and the elders Freder- Rev. Doctor Portier, of Mobile, (who arrived this day.) and the venerable Doctor Flaget of Bardstown, the Schor Suffragan, whose delieate state of health did not permit his travelling lather. A large body of priests, selected by the prelates as advising Theologians, tilled the Chanc.d. The appearance of the Sanctuary was execedingly striking: the bishops were copes and mitres, and were seated at each side of the altar : the priests in their sacred vestments occupied the front before the platform. After Mass, the Bishop of Charleston delivered a discourse on the nature of church government, the object and utility of councils, and the peculiar benefits likely to arise from their celebration in this country.

The Prelates hold their legislative sessions daily every morning at nine o'clock; the consultations of the Prelates and Theologians take place in the afternoon at four o'clock.

ROMAN CATHOLIC COUNCIL.

This assembly terminated its session vesterday. the prelates having, after a High Mass celebra-Boston, and a sermon by the Right Rev. Doctor England, Dishop of Charleston, solemnly affixed their signatures to the acts. The appearance of the sanctuary was the same as on the preceding Sunday; but a peculiar solemnity was added by two circumstances on this day. The clergy and prelates came in procession from the Archbishop's residence, and entered at the front of the church, proceeding through the centre aisle to the principal altar, where they took their seats. This produced a very imposing effect; it was the first time that ten mitres were worn by one assembly in the United States. The second circumstance with which we were struck was the mode of subscribing the acts. Each prelate, in the proper order or his place. went alone to the altar and subscribed the record which had been laid upon it by the Secretary. after he had read the titles of the acts, and the fathers had given their verbal assent by the expression, placet, upon the question having been put by the Archbishop.

The Council adjourned to the third Sunday atter Easter, in the year 1837. Conformably to the discipline of the Catholic church, the acts of the Synod will not be published until after they shall have been submitted to the examination of the supreme head of the church, that their conformity with the doctrine and the general discipline of the whole body of the other Churches of the by the Right Rev. > Conversion of the Prince of Lucca.-This potentate has become a Protestant. Charles-Louis de Bourbon, Infant of Spain, was born at Madrid in 1799, His father was by Napoleon made King of Etruria, after the treaty of Luneville; he died 1803. His mother, sister of the King of Spain, became Regent of the kingdom. but was obliged to abdicate in favour of her son, then a minor, in 1807. The young prince received in 1815 the duchy of Lucca, and arriving at majority in 1819 he assumed the government. The year after he married the Princess Theresa. daughter of Victor Emanuel, king of Sardinia. They had a son in 1823. For some years the duke of Lucca has been travelling in Germany. and has made little stay in his own dominions. Though his renunciation of Romanism has Leen denied, yet resterated testimony confirms the statement that he has received the communion. according to the Protestant rites, at the hards of the Rev. DEPENCE OF MONAMMEDANISM BY ONE OF ITS MINISTERS.

"Among the contents of the late East-India papers," says the National Gazette, "there are several replies received uy the Rev. Jos. Wolff. who has journeyed in Hindoostan as a Christian Missionary. The following, from the Grand Mullah of Delhi, is a remarkable exposition of the Mohammedan faith."

The good Mullah has taken the miracles of Mohammed, as well as some other things, on trust. The prophet himself made no pretension to them : so far indeed was he from claiming a

power of working miracles, that he apologized [repeatedly for the want of it, alledging "that God giveth the power of working miracles to whom he pleaseth,"-"that if he should work miracles they would not believe,"-that they had before rejected Moses. Jesus and the prophets, who wrought miracles,"-that the Koran itself was a miracle." Notwithstanding this unambiguous disclaimer, his followers have ascribed to han both miracles and prophecies. His miraeles have been said to amount to 3000; and the story is now so firmly established in the Musselman's religious feelings, that the learned Grand Mullah does not hesitate to say that the existence of such a place as Constantinople or London is not more certain.

We give the Mullah's defence of his faith as a curiosity, and as a specimen of one sort of difficulties that encounter the Christian missionary among the fellowers of the Arabian imposter.—Ed. Mess.

"Translation of Mulvee Muhommed Ishah's Letter to the Reverend Joseph Wolff.

"I answer this to the Rev. Joseph Wolff-In all religions there are some points of radical, and others of but collateral importance. Of the revealed religion of Moses, Christ, and Muhammed. the root consists of two parts-viz: the unity of God, a state of retribution, and the mission of Prophets. But though some admit, others deny the divine mission of our Prophet. The Jews acknowledge the prophetic characters of Jesus and Muhammed, but the Christians (Nazareens) deny the latter.—The Mussulmans establish the divine mission of our prophet by numerous proofs, three of which I will recite.- Ist. That Muhammed, son of Abdollah Hushmee, of the Kareist tribes of Mecca and Medina, was a Prophet sent by God, is attested by his miracles; for whoevor achieves such is unquestionably a Prophet. From these we deduce the unavoidable conclusion, therefore, that Muhammed is the Prophet of God. Himself claimed the recognition of this, and no one denied it or the reality of his miracles, which succeeded each other in regular series. Their reality was no more doubted than that or Constantinople, London, and Abyssinia, or that of Hatim, Roostum, and islandiar. The proois by which their existence becomes established, are essentially the same as those on which the miracies and prophetic character of Muhammed rest. -- 2dly. That the Koran is from the mouth of God, is as little to be doubted as that the Old and New Testaments and the Prophecies proceed from him; for no one can deny that the composition of the Koran is without a parrallel, and the past and future unfolded in it could only be to its divine origin, though skilled in its lan- Why then deny that his mission was divine.

guage, were unable to produce even one solitary verse similarly pefect. Indeed, up to this date, A. H. 1248, no Arabian, Persan, no inhabitant of Christendom, of India, or Seind, no human or super-human being has produced a composition so perfect and surpassing .- And, 2div. The divine mission is proved in numerous chapters and verses of this work, which I am ready to adduce. Moreover, many attributes belonged to the Prophet which none cise produced. This bodily strength was superior to that of other men; so were his forbearance, liberatity, wisdom, and trust in God; his truth, honesty, the tulfilment of promises, and beneficence; his comprehension, capacity, justice, and compassion; his comeliness of feature and complexion, fragrance of person, and devotion to God, austeraty and strict observance to religious rites, with divers other surpassing qualities. He, too, proclaimed God's unity, and that he had neither partner nor equal; that man should first pray and give alms in his name—he said to the poor, to relatives, to the distressed, and to the holy devotces, observe justice one towards another; abstain from murder, fornication, swearing and theft, chicanery and decest, from talschood, breach of promise, and the love of this world. It exposed to tyranny, he commanded us to forgive the tyrant, to propitiate God by the sacrifice of animals, and to observe hospitality. Whosoever exhibits these and such like attributes must be indeed a Prophet. For instance, a certain person arriving in a city says, "I am a l'hysician." "H so," reply the inhabitants, "write us a book for the sick, and point out their remedies." He does all this. His book resembles those of anteedent physicians; thousands are cured by its means and by its study. Many physicians are produced, all successful in curing. Should any of the citizens say, "This is no physician," the world would pronounce them to be ignorant hols; for were any one to deny that Thenocrates, Galen, Socrates, and Avicenna, were physicians, he would be looked upon as contemptible and mad. The proofs of their truth are not stronger than those regarding the Prothet. Again, were any one to deny that the East India Company ruled in Hindeostan, would he not be considered as ignorant and insane ! Even so must be considered that person who denies Muhammed to have been a Prophet. Our well established religion prevails in many countries and cities, and is protessed by Mantus, Mulvees, learned and holy men in Aratia, Toorun, Persia, Turkey, Khoorasan, India, Scind, Bhookara, Abyssinia, and the Mugrab, and many souls have, through its means, been blessed and received forgiveness of their sins. So many learned and transcendent men appear not in support of any other creed; nor do so many valuable books, traditions, commentaries and proofs, concur in establishing any other religion whatsoever. Should a few blind men assert that the sun has not risen, because they have not seen him, would any one place reliance on their word? No; let their blindness be cured and the sun becomes visible. Our religion is no less clear than his light. The words of our Prophet are acknowledged as true-why then doubt of his ascent to and return from Heaven? Antecefrom God. The Jews and Christians opposed dent prophets ferctold his coming upon earth.

Cholera Morbus .- The Iollowing phenomenon, related by M. Pousson, of the Lazarist mission at Damaseus, in describing the effects of the cholera on its appearance in that city in 1831, cems to sanction the hypothesis which attribotes this disease to atmospheric causes, although the writer states that it was brought by the caravan of piterims from Mecca: "A fact which has not a little contributed to afarm people here is a species of phenomenon which is very extraordinary under the sky where we live. At this place, from the end of the rains till their return, the beginning of May till October, a cloud is never seen, the sky is always pure, the atmosphere free from vapour, the sun rises and sets amid a torrent of light. This year, on the contrary, from about two months since (that is from the beginning of July,) the atmosphere has been very thick and the sun pale. In the morning, more than an hour before sunrise, the sky in the east is inflamed, and as red as blood, white the earth and hills are illummated, or rather tinged, with a dull, lurid, and learning light, similar to that which is east upon near objects by a great fire in the night. As the sun approaches the horizon the redness deminishes; but after it has risen it is more than a quarter of an hour before it can disengage itself from the vapour, through which it appears as it seen behind a piece of gause. At night the same spectacle appears in the west. Scarcely has the sun disappeared before the sky to an immense height above the horizon, is covered with a reddish tint, which continues to increase for more than hour and a half. It then diminishes, but does not wholly disappear till upwards of an hour and a currier after sunset. All the city is terrified at a circumstance which has nover been seen before within the memory of man." - Asiatic Journal.

But I was truly sorry to find that the pecuniary income of the Society had fullen far short of some of the former subscriptions and donations during a year. Nevertheless, I hope and trust the Lord will open the hearts of the christian community, so that all subsequent subscriptions and donations may be more abundantly liberal, and greatly enlarged, so as to meet the increasing demands for "the bread of life," not only in our own country, but also more particularly in foreign lands, among the perishing millions of the heathen.

As I find by the public prints, Rev. A. Judson, Missionary in Burmah, is expected shortly to complete the translation of the whole Bible into that language; it therefore will become necessary for the American Christians to extend to them the arm of benevolence, in order that, as quick as the sacred volume is completed in its translation, it may be printed and immediately circulated among them.

I therefore propose to be one of twenty to raise twenty thousand dollars, to be appropriated to the printing of Burmese Bibles. I will hold myself responsible to pay my part (\$1,000) at any time the money is wanted, provided the subscription should be completed at or before the first of October, 1834.

KENYON COLLEGE.—Bishop M'Ilvaine, in his address to the Diocese of Ohio, says:

Under authority from the Board of Trustees of the College, I undertook to raise, as the least sum that would answer the purpose, \$30,000 in two annual payments. Beginning among my own affectionate people in Brooklyn, I proceeded to New York, Boston, Providence, Norwich, Conn. and New-London; then to Philadelphia, and Baltimore; in all which places the object was entertained with the greatest kindness and interest, by various religious denominations, as one in which all that desire the advancement of useful learning and pure and undefiled religion in the west, should feel themselves concerned. It was delightful to see how sectarian views were kept out of sight, by Christians of different names, and nothing regarded in the application but in connection with the glory of God and the promotion of his kingdom. The whole amount of actual subscriptions from the above cities, aided by a few names from other places, irrespective of promises and expectations, and inclusive of \$1,000 from P. G. Stuyvesant, Esq. of New-York for the library (the same gentleman having previously subscribed \$400 to the buildings) is \$28,520. And it is due to the great kindness and confidence of my friends in Broaklyn and the city of New-York, to say that in the former, \$5547, and the latter \$18,906, of the whole amount were subscribed. The whole expense incurred by the college in my agency in this work, exclusive of a bill for the printing of an address to the public, which has not been received, will not exceed \$70. As soon as the collection shall have been sufficiently received, a minute statement of all the subscriptions and receipts will be printed and a copy forwarded to every subscriber.-N. Y. Obs.

The Theatre.—An English paper states that Mr. C. Kemble and Miss Kemble realized upwards of £11,000 (nearly \$50,000) the first season of their theatrical exertions in the United States. They have now commenced a second season, and are not expected in England until next year.
