Art II, Sec. 1 Nominations

2. The nominating committee, after arriving at a slate of nominees (at least 2 for each office), shall submit this list to the Seminary Community Council for further suggestions.

- 1- due to withdrawn names from the original slate the slate submitted to the SCC did not have at least (2) two for each office which had been accepted. (i.e. at the time SCC approved the slate neither Russ Yoder or Jeff Diller had been contacted.)
- 2; The list which was submitted was given to a group of members representing the SCC. There was not a quorum present at the time to accept the slate. Therefore the slate was never officially accepted by that body.
3. SCC (or the group representing the SCC) made several 'suggestions' to the nominations committee at that time. This involved the moving of two names on the slate as well as the addition of two new names. Only one of the people involved was aware that their name was being considered for an office other than that for which they were originally contacted.

Art II, Sec. 3 Nominations

4. "One week after the posting of the slate, the nominating committee shall call a meeting of the seminarians to secure nominations from the floor. Each nominee thus presented must have six(6) seconds to his nomination.

1. The nominating committee, due to negligence, never called such a meeting. The only opportunity for additional nominations "from the floor" was in the form of written statements to the President of the SCC.
2. After one withdrawal was accepted and two names added- a new slate was never posted. The provision in the Constitution for an open meeting would cover this problem, but since one was not held the revised list should have been posted.

Art. II, Sec C, Elections

1. "A simple majority of all votes cast shall be considered sufficient for election.

A total of 42 votes were cast. This means that in order for a simple majority to be achieved, and a winner announced, 22 votes must be won by each candidate. This is not the case. There **must be a run off election** (conducted by the nominating committee) held within the next seven (7) days to determine the Presidency of the SCC.

After hearing the original statement that there was a student wishing to contest the election, I have gone through the constitution and have found the above faults concerning this election. I talked to Thom about the problem. We agreed to remove the posted announcement of winners and to contact all the nominees to inform them that the election was being contested. I have contacted all the nominees with the exception of Andy and Russ (who have not been home up to and including my writing.)

I hereby withdraw my name from the nomination slate (if there is to be another election).
